#### **INVOCATION AND FLAG SALUTE**

Deputy Mayor Gareis spoke about the recent Rev. Dr. Martin Luther King, Jr. Commemorative Service held at the First Baptist Church of Cranford. He congratulated this year's recipient of the Rev. Dr. Martin Luther King, Jr. award: Ms. Phyllis Dunlop.

The invocation was led by Deputy Mayor Jason Gareis, followed by the flag salute.

#### MAYORAL ANNOUNCEMENTS

Mayor Andrews stated that he echoed Deputy Mayor Gareis' remarks and spoke about the recent Rev. Dr. Martin Luther King, Jr. Commemorative Service. He complimented/thanked the following individuals and groups: the First Baptist Church of Cranford, Phyllis Dunlop, the Cranford Clergy Council, the Interfaith Human Relations Committee and Reverend Brown.

Mayor Andrews read the Mayor's Proclamations:

### Commemoration of Martin Luther King, Jr. Day - January 16, 2023

WHEREAS, Dr. Martin Luther King, Jr., who was born on January 15, 1929, devoted his life to justice and equality for people of all races and socio-economic standings through non-violent means; WHEREAS, Dr. King and the Civil Rights Movement helped change public opinion and public policy from segregation to integration, resulting in the repeal of laws mandating racial segregation known as the "Jim Crow Laws;"

**WHEREAS,** Dr. King sought to fulfill the intent and promise of ratification of the 13<sup>th</sup>, 14<sup>th</sup> and 15<sup>th</sup> Amendments to the United States Constitution through new legislative action, thereby leading to the passage of the Civil Rights Act of 1964, the Voting Rights Act of 1965, and other anti-discrimination laws aimed at ending economic, legal, and social segregation in America;

**WHEREAS**, Dr. King believed that service to others was "the soul's highest purpose," and was the path to happiness and greatness, once saying, "Life's most persistent and urgent question is: 'What are you doing for others?'" which led communities across the country to answer that question by coming together to honor Dr. King by helping their neighbors and communities through service projects spread across all fifty (50) states; and

**WHEREAS**, millions of people in the United States and around the world mourned when learning of Dr. King's assassination on April 4, 1968.

**NOW, THEREFORE,** I, Brian Andrews, Mayor of the Cranford Township Committee, proclaim January 16, 2023, as a day to recognize and remember the Rev. Dr. Martin Luther King, Jr. and the dreams and ideals for which he stood.

Mayor Andrews invited Ms. Barbara Bilger to the podium and spoke about former Mayor Bilger's service and character. He read the Mayor's proclamation:

### <u>Barbara Bilger – Outstanding accomplishment and dedication to the Township and residents of</u> <u>Cranford</u>

WHEREAS, Barbara Bilger has contributed to the Cranford community with her many years of service with various organizations including the Swim Pool Utility Advisory Board, the Memorial Day Committee, the Downtown District Management Corporation (DMC) Board, the Senior Housing Advisory Board, the Recreation and Parks Advisory Committee, and the Cranford World Trade Center Memorial Committee; and

**WHEREAS**, Ms. Bilger served on the Cranford Township Committee for over six (6) years; such service included two (2) terms as Mayor during 2002 and 2004; and the filling of an unexpired term in 2015; and

WHEREAS, Ms. Bilger's presence in the Cranford community included work with many types of organizations and events including her work as a trustee for St. Michael Church, her membership in the Veterans of Foreign Wars (VFW) Post 335 Auxiliary, her participation in numerous Chamber of Commerce events such as the Holiday Tree lighting and street fairs and her recurring role as the emcee for the annual Memorial Day ceremony; and

**WHEREAS**, Ms. Bilger has been a willing and generous volunteer since moving to Cranford over fifty-three (53) years ago; and

WHEREAS, Ms. Bilger's spirit and dedication to the Township will be greatly missed; NOW, THEREFORE, BE IT RESOLVED, that the Township Committee of the Township of Cranford thank Barbara Bilger for her years of service to Cranford and wish her well in her new Florida community and all of her future endeavors.

Mayor Andrews presented Barbara Bilger with the proclamation. Ms. Bilger spoke about her volunteer experience with the Township. She spoke about her appreciation for the Township's volunteers, the Cranford Police Department and the Cranford Fire Department. Ms. Bilger stated that she appreciated this recognition and stated that she would miss everyone.

Mayor Andrews also thanked Commissioner Miller Prunty who was the "driving force" behind the proclamation recognizing Ms. Bilger.

### MAYORAL REMARKS

Mayor Andrews spoke about four (4) areas of focus which were outlined at the recent Reorganization Meeting: 1) improving our quality of life; 2) investing in our infrastructure; 3) improving our Township government and 4) living our values.

Mayor Andrews stated that he wanted to discuss three (3) items during this Meeting: 1) the change in the Township Committee Official Meeting structure. Mayor Andrews elaborated about the new Official Meeting Agenda format. Referencing the focus of 2) "improving the quality of life", Mayor Andrews spoke about improving the Cranford Public Library, specifically through maintenance issue improvements and working to expand the Children's Room. Referencing the 3) "living our values" focus, Mayor Andrews spoke about gun safety work and activity in Cranford including work by the Cranford Police Department and Moms Demand Action organization.

### **COMMISSIONER REPORTS**

### Commissioner Curran – Finance

- Reported that the Township had recouped the entire surplus that was budgeted for the previous year;
- Stated that year 2023 would see challenges including the increase in State Health Benefits costs of approximately twenty-two (22) per cent (%) as well as expected increases in sewer rates;
- Stated that the Township Budget Meeting would be held on February 11<sup>th</sup> and the Capital Budget Meeting would be held on February 23<sup>rd</sup>; Encouraged members of the public to attend these meetings.

### Commissioner Miller Prunty – Engineering & Public Works

- Discussed an award of contract to conduct a Comprehensive Parking Study (Resolution No. 2023-98); explained that the funding for this study had been approved in the 2020 Capital Budget;
- Stated the Township would be considering a recycling contract renewal with Giordano Company;
- Stated that the Department of Public Works would begin filling potholes; requested that residents email <u>publicworks@cranfordnj.org</u> with repair requests;
- Announced that Friday, January 20<sup>th</sup> would be the last day for Christmas tree pick up;
- Stated that the Conservation Center would be closed on Sundays in January and February;
- Provided an overview of Township Road paving and drainage projects; stated that she would be working with the Administration Department to update the website with current road project information;
- Discussed large drainage projects on Cranford Terrace, Cranford Avenue and Arlington Road and stated that residents in those areas would be notified and informed throughout the duration of the projects;
- Stated that State Road, North Avenue, would be paved from "end to end" including the section between Lincoln Avenue and Orchard Street, in the Spring;
- Stated that there were flood mitigation projects "in the works" and elaborated;
- Spoke about a significant project at Kensington Avenue and Edgar Avenue which would help with drainage and flow in the area;
- Spoke about an upcoming Casino Brook study.

### **Deputy Mayor Gareis – Public Safety**

- Reported that Police Officer Rameil King and Police Officer Travis Freeman completed their field training and had been assigned to patrol;
- Announced that Sergeant D'Ambola, Patrol Officer Gamba and Patrol Office Meyer had been recognized by Mothers Against Drunk Driving (MADD);
- Spoke about the recent road project on Walnut Avenue and stated that the light-up crosswalk would be repaired/installed in the near future;
- Provided an explanation regarding Resolution No. 2023-100 pertaining to the Cranford Police Department's participation in the Defense Logistics Agency Law Enforcement Support Office 1033 Program;
- Spoke about three (3) resolutions pertaining to Fire Department promotions which would be considered that evening, specifically for Arthur Anderson, Doug Petschow and Andrew DiFrancesco; stated that the formal promotion ceremony would be held on the following day;
- Spoke about a resolution (Resolution No. 2023-99) pertaining to the purchase of Mobile Data Terminals (MDT's) for the Cranford Fire Department;
- Stated that the Stormwater Infrastructure Flood Committee had recently met; noted that the consulting engineering firm, Mott MacDonald, had briefed the Committee on Riverside Drive Dike repairs;
- Requested residents place their Christmas Trees at the curb;
- Noted that the Home Elevation Group met bi-weekly and would be meeting on the following day; stated that the first home should be started in the near future.

### Commissioner Black – Public Affairs

• Announced that the Recreation Facility at 375 Centennial Avenue officially opened for adult sport rentals that evening; stated her appreciation for the Cranford Soccer Club and the Cranford Lacrosse Club for their volunteerism and their funding of temporary netting for the Recreational Facility; stated that a grand opening would be planned.

### **PROFESSIONAL COMMENTS**

### Township Clerk Patricia Donahue

- Congratulated Barbara Bilger and wished her 'good luck' in her future endeavors;
- Congratulated Arthur Anderson and Doug Petschow on their promotions and congratulated Andrew DiFrancesco on his appointment within the Cranford Fire Department.

### Interim Township Administrator Ryan Greco

• Recognized and thanked Barbara Bilger for her tremendous amount of support to the Township and stated that she would be forever missed.

### **Township Attorney Ryan Cooper**

- Congratulated Mayor Barbara Bilger and stated that she would be missed;
- Congratulated the Firefighters on their expected advancements.

### **PUBLIC COMMENTS**

Mayor Andrews opened the informal portion of the meeting and asked if there were any questions or comments.

<u>Don Smith, 21 Oneida Place</u> – Mr. Smith stated that he was in disagreement about the new Agenda format and asked that the Township Committee reconsider the changes, specifically regarding the public comments section. A brief discussion ensued with Mayor Andrews and Commissioner Curran.

<u>Kurt Krause</u> – spoke about 1) an ongoing erosion issue at his parents' property located at 20 Pittsfield Street 2) the Memorial Day Ceremony and the Honor Guard position for shooting their rifles. He recommended that the shooting take place away from the members of the public.

Commissioner Miller Prunty stated that she would bring the erosion issue to the weekly Engineering Meeting. Ms. Bilger stated that she would reach out to the Honor Guard Commander on the following day and convey Dr. Krause's concerns about the Honor Guard.

<u>Christine Esposito, 11 Behnert Place</u> – Ms. Esposito stated that she was present to speak about the 750 Walnut Avenue site and the pending application before the Planning Board. Ms. Esposito stated that members of the community were misled by the Planning Board process as it related to the Redevelopment Agreement and the Redevelopment Plan. She stated that the Township Attorney and members of the Township Committee told residents to voice their concerns with the Planning Board. Ms. Esposito stated

that many aspects of the Plan and Agreement were "set in stone" and elaborated. Ms. Esposito stated that it was her expectation that the Township Committee would be proactive with Hartz and hold such developer accountable and elaborated.

<u>Jim Carvalho, 9 Orange Avenue</u> – Mr. Carvalho spoke about the departure of former Township Administrator Jamie Cryan, the subsequent appointment of Police Chief Ryan Greco as Interim Township Administrator and Mr. Cryan's appointment as Township Administrator in another municipality. Mr. Carvalho stated that he wished Mr. Cryan "well".

Mr. Carvalho spoke about a recent Township labor attorney award (to Rainone, Coughlin, Minchello, LLC) and Assembly Speaker Coughlin's attendance in Cranford last year for a State budget signing. Mr. Carvalho spoke about legislation in Trenton pertaining to elected officials' property records and pay-to-play practices on a state-wide level.

Mr. Carvalho commended Ms. Black's votes 1) against the change in the Township's Bylaws, specifically pertaining to the Official Meeting Agenda format and 2) against the appointment of Township Attorney Ryan Cooper.

Mr. Carvalho spoke about retroactively-amended Agendas and asserted that the Township had amended the December 22, 2022 Agenda after the Meeting occurred on two (2) occasions.

<u>Don Smith, 21 Oneida Place</u> – Referencing Commissioner Curran's suggestion to members of the public to attend Workshop Meeting to provide input to the Township Committee, Mr. Smith stated that Workshop Meetings were not recorded. He suggested the Township Committee reconsider the Official Meeting format so that public input could occur at the beginning of the Official Meeting and at the end of the Official Meeting.

<u>William Thilly, 22 Bloomingdale Avenue</u> – Mr. Thilly approached the podium and stated that he wanted to relax again. He thanked the members of the Township Committee for their time.

Hearing no further comments, Mayor Andrews closed the informal portion of the meeting.

**WHEREAS**, the Unites States Congress authorized the Defense Logistics Agency (DLA) Law Enforcement Support Office (LESO) 1033 Program to make use of excess Department of Defense

personal property by making that personal property available to municipal, county and State Law Enforcement Agencies (LEAs); and

WHEREAS, DLA rules mandate that all equipment acquired through the 1033 Program remain under the control of the requesting LEA; and

**WHEREAS**, participation in the 1033 Program allows municipal and county LEAs to obtain property they might not otherwise be able to afford in order to enhance community preparedness, response, and resiliency; and

WHEREAS, although property is provided through the 1033 Program at no cost to municipal and county LEAs, these entities are responsible for the costs associated with delivery, maintenance, fueling, and upkeep of the property, and for specialized training on the operation of any acquired property; and WHEREAS, N.J.S.A. 40A:5-30.2 requires that the Governing Body of the municipality or county approve, by a majority of the full membership, both enrollment in, and the acquisition of any property through, the 1033 Program.

**NOW THEREFOR BE IT RESOLVED**, by the Township Committee of the Township of Cranford that the Cranford Police Department is hereby authorized to enroll in the 1033 Program for no more than a one (1)-year period, with authorization to participate terminating in December 31<sup>st</sup> of the current calendar year.

**BE IT FURTHER RESOLVED**, that the Cranford Police Department shall develop and implement a full training plan and policy for the maintenance and use of the acquired property.
