MAYORAL REMARKS

Mayor Andrews discussed an upcoming ribbon cutting ceremony for the Cranford Recreation Center at 375 Centennial Avenue. He stated that the new facility represented a generational investment in the community and elaborated. Mayor Andrews stated that the process which "got" us here exhibited the best of local government and elaborated. Mayor Andrews stated that the ribbon cutting ceremony would be held on the upcoming Saturday. He encouraged members of the community to attend.

Mayor Andrews spoke about a recent Mayors Council for Rahway River Watershed Flood meeting he attended with Commissioner Miller Prunty. He provided an overview of the Council. Mayor Andrews thanked the Township's federal partners for working to get the Army Corps of Engineers back "to the table" to talk about Rahway River flooding (and specifically thanked Senator Cory Booker, Senator Bob Menendez, Congressman Donald Payne, Jr., and Congressman Tom Malinowski). Mayor Andrews then spoke about engaging with local partners and working in Cranford on flood mitigation strategies.

COMMISSIONER REPORTS

Commissioner Curran – Finance

- Spoke about the recent annual Budget meeting and announced that the Township Budget would be introduced at the Township Committee's March 21st Official Meeting;
- Discussed challenges faced by the Township including increased costs in pension payments, increased healthcare benefits costs and increased Rahway Valley Sewerage Authority (RVSA) fees; stated that the Township was in good position to handle these challenges;
- Announced that the Capital Budget meeting would be held on the upcoming Thursday;
- Stated that the Centennial Village Group would conduct a "Pot of Gold Raffle";
- Discussed recent work of the Environmental Commission; encouraged interested residents to reach out to the Environment Commission;
- Stated that a Frequently Asked Question flyer had been circulated pertaining to Pool matters; stated that the Township Committee was interested in communicating the correct information and briefly elaborated.

- Announced that Conservation Center stickers would be available for sale, both online at www.cranfordnj.org and at the Conservation Center, beginning March 4, 2023;
- Spoke about the Downtown Management Corporation's upcoming Fire & Ice event to be held on February 25, 2023;

WHEREAS, the Contractor, CCM Contracting Inc., 336 Route 22, Green Brook, New Jersey, 08812 has submitted a Maintenance Bond No. 0239852(M) in the amount of \$1,217,265.92 to the Township in connection with aforementioned project; and

WHEREAS, the Township's Engineering Department has indicated that CCM Contracting Inc. has completed the project and has met all requirements for final payment and is recommending the return of the Performance Bond No. 0239852 in the amount of \$1,345,680.96 currently on file with the Township Clerk of the Township of Cranford; and

WHEREAS, the Chief Financial Officer and the Director of Finance has certified to the availability of funds upon adoption of the 2023 municipal budget which will be on file in the office of the Township Clerk.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Cranford, New Jersey, as follows:
