INVOCATION AND FLAG SALUTE

The invocation was led by Deputy Mayor Jason Gareis, followed by the flag salute.

MAYORAL ANNOUNCEMENTS

Mayor Andrews recognized Girl Scout Week. He then discussed the Swim Pool Utility, the Township's proposed partnership with the Westfield YMCA and what could be expected when construction began at the Cranford Indoor Pool and Fitness Center.

MAYORAL REMARKS

Mayor Andrews provided an update on the Township's Affordable Housing obligations.

COMMISSIONER REPORTS

Commissioner Curran – Finance

- Spoke about the introduction of the Township Budget;
- Discussed inflation, the rising cost of living, and the importance of maintaining a healthy reserve;
- Stated that the Fire Department needs a new Fire Truck;
- Encouraged residents to review the Township Budget and provided them with information on where to find the budget documents.

<u>Commissioner Miller Prunty – Engineering & Public Works</u>

- Informed members of the public that the lights at Post Office Plaza were in the process of being repaired and a new flag had been ordered;
- Reminded residents that Conservation Center stickers are for sale and available at the Conservation Center;
- Announced that the 2022 Conservation Center stickers expire on April 3rd;
- Discussed a recent ruling by the Massachusetts Supreme Court pertaining to public meetings.

Deputy Mayor Gareis – Public Safety

• Announced that the Cranford Community Connection would be holding their third Annual Truck Parade on March 26th; elaborated about the upcoming event; thanked the Cranford Police Department and Cranford Fire Department for their contributions to the Parade; thanked various groups and individuals who helped plan and organize the Parade.

Commissioner Black - Public Affairs

- Announced that the Spring registration for Recreation Department programs was scheduled to "open up" on the upcoming Friday;
- Provided an update on the Cranford Recreation Center at 375 Centennial Avenue; requested that residents provide feedback on what could be improved;
- Addressed the issue of parking at the Cranford Recreation Center at 375 Centennial Avenue

PUBLIC COMMENTS

Mayor Andrews opened the public comments portion of the meeting and asked if there were any questions or comments.

<u>Tom O'Brien, 30E Springfield Avenue</u> – commended Commissioner Prunty; thanked members of the public for supporting the comments that he made at the March 7th Township Committee Official meeting. Mr. O'Brien spoke about the importance of mutual respect; expressed his dissatisfaction with Commissioner Curran's response regarding the Township's finances. Mr. O'Brien then asked questions pertaining to the Township Budget; provided comments about the North Avenue Gateway Redevelopment Area Project, specifically pertaining to parking.

<u>Jim Carvalho, 9 Orange Avenue</u> – spoke about the change in the format of Official Meetings. Mr. Carvalho spoke about Commissioner Curran's comments which he stated were delivered at the March 7th Township Committee Official meeting.

<u>Peter Taylor, 8 Claremont Place</u> – stated that he had served on the Planning Board for twelve (12) years; discussed the North Avenue Gateway Redevelopment Area Project. He spoke about the Request for Proposal (RFP), plan goals, renderings, parking and design standards associated with the Project.

<u>William Thilly, 22 Bloomingdale Avenue</u> – discussed the topic of Affordable Housing and expressed his dissatisfaction with the Township's process for meeting their Affordable Housing obligation.

<u>Deborah Brooks, 1 Buchanan Street</u> – thanked the members of the Township Committee for accommodating members of the Cranford Indoor Pool & Fitness Center and spoke about the facility's hours of operation.

<u>Leon Sevigny, 452 Orchard Street</u> – discussed the issue of flooding and asked that the Township Committee focus on its citizens.

<u>Elizabeth Allcock, 5 Cayuga Road</u> –thanked the members of the Township Committee for working with members of the Cranford Indoor Pool & Fitness Center to come to an agreement regarding the hours of operation for the facility. She asked for clarification regarding the hours and provided further feedback.

<u>Sally Kleeman, 130 North Lehigh Avenue</u> - thanked the members of the Township Committee for reconsidering the hours of operation for the Cranford Pool & Fitness Center (Pool); inquired about weekend hours for the Pool. Ms. Kleeman spoke about the importance of the facility within Union County.

<u>Samantha Ulan, 18 Crescent Place</u> - spoke about the North Avenue Gateway Redevelopment Area Project and offered feedback about the proposed renderings.

<u>Don Smith, 21 Oneida Place</u> – thanked Mayor Andrews for his briefing regarding the Council on Affordable Housing (COAH)

<u>Rita LaBrutto, 104 Arlington Road</u> – thanked the Township Committee for the previous evening's discussion at the Workshop Meeting and spoke about the proposed plans for the North Avenue Gateway Redevelopment Area Project. She suggested that the Request for Proposal (RFP) be "scrubbed" and expressed concern over the height of the buildings.

<u>John Kasperan, 4 Van Buren Avenue</u> – stated that he was looking for feedback on the Cranford Indoor Pool & Fitness Center and spoke about the importance of accommodating Senior Citizens.

<u>David Solomon, 317 High Street</u> – asked the Township Committee to reconsider the hours of operation for the Cranford Indoor Pool & Fitness Center to better accommodate Senior Citizens and members with disabilities.

<u>John Mallon, 100 Belmont Avenue</u> – discussed the proposed North Avenue Gateway Redevelopment Area Project and asked that the Township Committee be "deliberate" in the process. He also requested that the Township Committee seek further public input on the project.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and the Township Committee be and hereby authorized to enter into a Cooperative Pricing Agreement with the Lead Agency.

WHEREAS, the Township Committee of the Township of Cranford recognizes that Casino Avenue, Pacific Avenue and Linden Place were recently paved as part of the 2021 Township Paving Program. These sections of roadway are currently under moratorium until the end of November 2026;

WHEREAS, pursuant to the Township of Cranford Municipal Code Chapter 367 Streets and Sidewalks, Article VIII Excavations and Openings, §367-44(D) Limitations on permit; opening streets less than five years old, "the Township Engineer, or his designee, shall be required to secure approval therefor from the governing body by resolution before any permit can be approved hereunder" and

WHEREAS, the Township Committee acknowledges the need to upgrade the New Jersey American Water infrastructure; and

WHEREAS, the Township Committee hereby grants the Township Engineer, or his/her designee, authority to approve the necessary permit(s) for the Applicant to effectuate this project; and

WHEREAS, the Township Committee hereby approves lifting the moratorium placed on these sections of roadway to enable the installation of proposed improvements.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Cranford, New Jersey, as follows:

- 1. Grants the Township Engineer, or his/her designee, authority to approve the necessary permit(s) for the Applicant stated herein at the location described above.

SUPPORTING A TOWNWIDE STUDY TO EVALUATE ACTIVE TRANSPORTATION SAFETY AND THE SEEKING OF ASSISTANCE FROM THE NEW JERSEY DEPARTMENT OF TRANSPORTATION (NJDOT) BUREAU OF SAFETY, OFFICE OF BICYCLE AND PEDESTRIAN PROGRAMS

WHEREAS, it is a priority for the Township of Cranford (Cranford) to ensure that equitable access to safe, convenient, healthy, environmentally, and economically beneficial transportation options are available for vulnerable road users of all ages and abilities. "Vulnerable users" includes pedestrians, cyclists, young children, senior citizens, persons with disabilities, and public transportation users; and WHEREAS, Cranford has made active transportation safety a priority, including conducting a downtown walk audit in 2016, receiving a North Jersey Transportation Planning Authority (NJTPA) grant to undertake a Complete Streets Technical Assistance Conceptualization Study for the Post Office Plaza in 2019 and completing a pedestrian and cyclist safety public survey in 2020; and

WHEREAS, Cranford has concurrent and complementary efforts related to walking and cycling including a Complete Streets Policy update (first adopted in 2013), a downtown streetscape study (anticipated completion: Spring 2023), a parking study (anticipated completion: date 2023) and several major development projects including one (1) designated Area in Need of Redevelopment in downtown Cranford; and

WHEREAS, Cranford is designated as a Transit Village through a Smart Growth partnership spearheaded by the New Jersey Department of Transportation (NJDOT) and New Jersey Transit, recognizing Cranford's commitment to creating attractive, vibrant, pedestrian-friendly neighborhoods where people can live, shop, work and play without relying on automobiles; and

WHEREAS, Cranford was recognized as the Best Downtown in New Jersey for two (2) consecutive years in 2018 and 2019 by NJ.com, due in part to its vibrant, pedestrian-friendly downtown, commercial offerings and numerous programs and events held in the downtown Special Improvement District; and WHEREAS, Cranford's downtown and business community have continued to exhibit dynamism, despite the impacts and challenges associated with COVID-19, with new business openings and Township policies to create more outdoor spaces to pedestrians, cyclists, and recreation; and WHEREAS, North Avenue, also referred to as State Route 28 (NJ 28), is a major thoroughfare which, along with South Avenue (Union County Route 610) and the New Jersey Transit Raritan Valley Line, bisects Cranford's downtown, creating unique challenges related to safety, access, cross-town mobility, traffic flow, and walkability; and

WHEREAS, Cranford has dedicated walking and cycling trails, paths, and routes but does not currently have any dedicated on-street facilities for cyclists; and

WHEREAS, Cranford does not provide busing to school children due to the presence of neighborhood schools located within walking distance of most residential areas;

NOW THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Cranford, that the Township supports a townwide study to evaluate active transportation safety, compliance with the Americans with Disabilities Act (ADA) and overall conditions for walking and cycling. The study should be data-driven and informed by robust outreach to the community.

BE IT FURTHER RESOLVED, that the Township of Cranford will seek support from the New Jersey Department of Transportation (NJDOT) Bureau of Safety, Office of Bicycle and Pedestrian Programs, recognizing that NJDOT has conducted similar efforts to promote safe and complete streets and improve safety and mobility of pedestrians and cyclists within New Jersey.
