Township Attorney Ryan Cooper, Administrator Jamie Cryan, Police Chief Ryan Greco, Chief Financial Officer (CFO) Lavona Patterson and Township Clerk Patricia Donahue were present.

Commissioner Andrews arrived to the Meeting at 6:35 p.m.

# **Public Comments**

Mayor Miller Prunty opened the public comments portion of the meeting and asked if there were any questions or comments. Hearing no comments, Mayor Miller Prunty closed the public comments portion of the meeting.

# Lead Pipe Update

Mr. Michael Bange, Mr. William Lewis, Mr. Matthew Csik and Ms. Cassandra Malone of New Jersey American Water\_were present.

Mr. Bange spoke about New Jersey American Water's (American Water) replacement of lead pipes and galvanized steel initiative. He stated that the program sought to replace lead and galvanized steel service lines over the next ten years. Mr. Bange stated that 989 certified program notification letters were mailed to Cranford property owners and only eight (8) property owners had responded to the mailing. Discussion ensued on ways to contact American Water, further American Water outreach efforts, American Water permitting needs (i.e., blanket open permits), and the extent of the service line initiative, specifically from the water main to the curb versus from the water main to the curb to a property.

# Draft North Avenue Redevelopment Plan

Township Attorney Ryan Cooper stated that the North Avenue Redevelopment Plan (Plan) was included in the Commissioners' Meeting packets. He stated that the Downtown Management Corporation had formed a subcommittee regarding the proposed North Avenue Redevelopment. Mr. Cooper requested that the Commissioners provide Plan feedback. He recommended that the North Avenue Redevelopment Plan be introduced for Township Committee consideration at the April 12<sup>th</sup> Township Committee Official Meeting. Commissioner Black stated that she would like to have highlighted what was unique to the Plan as it seemed there was a lot of "cut and paste" narrative included in the Plan and that the narrative was repetitive. Commissioner Black inquired about the intersections of North Avenue and Centennial Avenue and North Avenue and Springfield Avenue.

Mr. Cooper noted that a proposed North Avenue Redevelopment Agreement would provide specifications as well as address the Township's Affordable Housing obligations. Mayor Miller Prunty requested that the Commissioners forward all questions regarding the proposed North Avenue Redevelopment Plan to Administrator Cryan and Township Attorney Ryan Cooper.

# **Hours of Operation**

Commissioner O'Connor elaborated briefly about the hard-working Township employees. Commissioner O'Connor noted that the current work hours made the Township less competitive for prospective new hire employees. She stated that by changing the work hours, the Township could be more competitive with neighboring communities (the Workshop Meeting packet contained the work day hours for Union County municipalities). She then spoke about the propose salary ordinance and summer hours and stated that she was a big proponent of employee morale.

Administrator Cryan inquired if Commissioner O'Connor was advocating for a thirty-two and half (32.5) or thirty-five (35) hour work week. Commissioner O'Connor stated that she was advocating for a thirty-five (35) hour work week. Mayor Miller Prunty stated that she was happy to see this matter "back on the table". Discussion ensued.

Mayor Miller Prunty opened the public comments portion of the meeting and asked if there were any questions or comments. Hearing no comments, Mayor Miller Prunty closed the public comments portion of the meeting.

Discussion ensued including discussion about the removal of the resolution from the Official Meeting Agenda.

Township Clerk Patricia Donahue stated that the Budget would be introduced for consideration at the Official Meeting and reviewed the administrative details associated with the Budget introduction.

The Township Committee moved to Council Chambers at 7:34 p.m. to conduct the Official Meeting.

On motion of Commissioner Andrews, seconded by Commissioner O'Connor and passed, the Township Committee returned to open session at approximately 9:05 p.m.

### **Draft North Avenue Redevelopment Plan (continued)**

Commissioner Black inquired about the role of the Downtown Management Committee (DMC) as it pertained to the proposed North Avenue Redevelopment Plan. Discussion ensued including discussion regarding the attendance of Township Committee members at DMC subcommittee meetings. Committee consensus was reached that only the Township Committee's DMC liaison (Commissioner Andrews) would attend the DMC North Avenue Redevelopment Plan subcommittee meetings.

On motion of Commissioner Andrews, seconded by Commissioner O'Connor and passed, the Township Committee adjourned at approximately 9:20 p.m.
