INVOCATION AND FLAG SALUTE

The invocation was led by Deputy Mayor Gareis, who recited words from Rabbi Kerbel of Temple Beth-El Mekor Chayim, followed by the flag salute.

MAYORAL ANNOUNCEMENTS/

ANNOUNCEMENTS

Mayor Andrews spoke about the upcoming twelfth (12th) Annual Cranford Community Holocaust Day of Remembrance on April 26, 2023 at Orange Avenue School and elaborated about remembering the Holocaust.

Mayor Andrews read the Mayor's Proclamations:

Holocaust Remembrance

WHEREAS, the Holocaust was the systematic persecution and annihilation of six million Jews, and millions of others including Roma, Poles, people with physical disabilities, homosexuals, communists, socialists and dissenting clergy by the Nazi regime and its collaborators between 1933 and 1945; and WHEREAS, our global family, regardless of race, religion, political affiliation, or identity should actively rededicate ourselves to the principles of individual freedom and moral responsibility in a just society; and

WHEREAS, we the people of the Township of Cranford should always remember the terrible events of the Holocaust and remain vigilant against hatred, persecution, and tyranny; and

WHEREAS, the Cranford Clergy Council, Cranford Interfaith Human Relations Committee, Cranford Public Schools, & Saint Michaels School will host the 12th Annual Cranford Community Holocaust Day of Remembrance on Wednesday, April 26, at Orange Avenue School; and

WHEREAS, as a community, we have a responsibility to directly challenge and combat acts of injustice, bias, inequity, and hate; and

NOW, THEREFORE, I, Brian Andrews, Mayor of the Township of Cranford, pursuant to an Act of Congress (Public Law 96-388, October 7, 1980), do hereby honor the victims of the Holocaust and the survivors as well as the rescuers and liberators, and further proclaim that we, as a community, should strive to overcome hate, intolerance and indifference through education, remembrance, and action.

Mayor Andrews invited members of the Cranford Library Board of Trustees to the podium.

<u>Cranford Public Library Recognition – National Library Week</u>

Whereas, today's libraries are more about what they can do with and for their communities, and not just about what they have on the shelves; and

Whereas, libraries have long served as trusted institutions, often the heart of their cities, towns, schools, and academic campuses; and

Whereas, libraries serve people of all ages, interests and backgrounds providing the resources and space to engage in life-long learning; and

Whereas, libraries offer equipment and professional staff support to utilize technology, programs and services; and;

Whereas, libraries are a resource for all - regardless of race, ethnicity, creed, ability, sexual orientation, gender identity or socio-economic status; and

Whereas, we recognize librarians as information professionals who provide expertise, services and guidance for patrons to access credible sources and material, making their own informed decisions about the world today; and

Whereas, libraries provide access to and display a wide range of information not just a majority opinion or single perspective; and

Whereas, America is celebrating National Library Week including April 25th as National Library Workers' Day, recognizing the immeasurable contributions made by library workers; April 26th as National Outreach Day showing library services are not limited to their physical location; and April 27th as Take Action for Libraries Day encouraging community support for libraries;

Now, Therefore, I, Brian Andrews, Mayor of the Township of Cranford, proclaim National Library Week, April 23-29, 2023. During this week, we encourage all residents to visit our library, and explore all that it offers.

The President of the Cranford Library Board of Trustees, Patricia Pavlak, provided comments on the important roles that libraries have in local communities and the nation as a whole. She thanked Mayor Andrews and the members of the Township Committee for their support of the Cranford Public Library.

MAYORAL REMARKS

Mayor Andrews discussed the adoption of the Municipal Budget (Budget) and the Introduction of the Capital Budget Ordinance. He highlighted some key Budget points including the allocation of funds for pedestrian improvements and Cranford Public Library maintenance. He announced that Kathryn Cannarozzi would be the new Director of the Cranford Public Library and thanked Assistant Library Director Judy Klimowicz for serving as Interim Library Director.

COMMISSIONER REPORTS

Commissioner Curran – Finance

- Discussed the adoption of the Municipal Budget and the expected 2023 increase in the Township's property taxes;
- Congratulated Chief Financial Officer (CFO) Lavona Patterson and Interim Township Administrator Ryan Greco for their hard work with the Budget;
- Spoke about the introduction of the Capital Budget Ordinance;
- Spoke about the Swim Pool Utility Budget; stated that there was a lifeguard shortage and encouraged members of the public to apply for the Township's lifeguard positions.

Commissioner Miller Prunty – Engineering & Public Works

- Spoke about meeting which was held on the previous day with residents in the area of Kensington Avenue and Edgar Avenue to discuss upcoming project work; spoke about drainage and road pavement work;
- Provided an update on the upcoming Dike Repair Project along Riverside Drive;
- Directed members of the public to visit cranfordnj.org/engineering to view the scheduled road projects;
- Stated that Mott MacDonald had provided preliminary information about Orchard Brook;
- Stated that Mott MacDonald was scheduled to provide a preliminary report regarding the North East Quadrant within the next few weeks;
- Discussed the Capital Budget as it pertained to Department of Public Works and Engineering matters;
- Stated that the Township had been contacted by the New Jersey Department of Transpiration (NJDOT) regarding the paving of North Avenue;
- Spoke about the various events that would be taking place throughout the Township over the upcoming weekend including the Jaycee's Annual Rahway River Cleanup, the Second (2nd) Annual Downtown Cranford Arts Day and the Townwide Garage Sale.

Deputy Mayor Gareis – Public Safety

• Discussed the potential acquisition of a new Rescue Truck for the Fire Department;

Commissioner Black - Public Affairs

- Stated that the Recreation and Parks Department was beginning to "gear up" for the Summer season:
- Informed members of the public that clean-up had begun at the Cranford Canoe Club and Memorial Park;
- Announced that the Recreation and Parks Advisory Committee had started planning for the July Fourth (4th) Celebration;

PUBLIC COMMENTS

Mayor Andrews opened the public comments portion of the meeting and asked if there were any questions or comments.

<u>Tom O'Brien, 30 Springfield Avenue</u> – stated that air traffic in the area had increased. He spoke about the Township's Request for Proposals (RFP's) pertaining to a Comprehensive Parking Study which occurred

in September 2022 and in November 2022 and his dissatisfaction with the process and selected vendor. Mr. O'Brien expressed his dissatisfaction about parking throughout the Township and traffic.

<u>Don Smith, 21 Oneida Place</u> – spoke about a lawsuit being brought by various municipalities against Governor Murphy pertaining to the New Jersey's Council on Affordable Housing (COAH). Mr. Smith spoke about existing housing developments in Cranford and expressed concerns over the rising cost of rent. Township Attorney Ryan Cooper provided clarification pertaining to the pending litigation regarding the New Jersey's Council on Affordable Housing (COAH).

<u>Loretta Smith, 21 Oneida Place</u> – requested an explanation of the 375 Centennial Avenue Recreation Facility budget. She inquired 1) about an opening date for the outdoor pools and 2) whether the Township would be hosting a Memorial Day Parade.

<u>Deirdre Koczur, 207 Edgar Avenue</u> – spoke about the Township's various road paving and drainage projects. Ms. Koczur discussed a recent meeting with residents in the area of Kensington Avenue and Edgar Avenue as well as an upcoming meeting with the Army Corp of Engineers and suggested that the timing of the meetings be changed so that they were not occurring while most residents were at work.

<u>Jim Carvalho, 9 Orange Avenue</u> – spoke about his dissatisfaction with the Official Meeting Agenda format and elaborated. He then expressed his frustration with reports given by the Township Committee at a previous meeting and elaborated.

<u>Rita LaBrutto, 104 Arlington Road</u> - thanked Commissioner Curran for his work on the Municipal Budget and provided suggestions on how the Township could save money. She also expressed her discontent with Payment in Lieu of Taxes (PILOT) programs and tax abatements for developers.

<u>William Thilly, 22 Bloomingdale Avenue</u> – provided suggestions on how to make Township Committee meetings more enjoyable and less serious.

Tom Hannen, 94 Belmont Avenue —discussed the Repair and Restoration of the Nomahegan Dike along Riverside Drive Project; inquired if there was any thought given to using a stronger material than soil and fill for the proposed elevation. Mr. Hannen inquired about the connection and size of the storm sewer for the Kensington Avenue and Edgar Avenue Drainage Improvements Project. Mr. Hannen inquired how the meeting time was chosen for these project meetings.

<u>Greg Carey, 25 Locust Drive</u> – provided a summary of his concerns regarding 5G Cell Towers and asked the Township Committee to address them.

<u>Tom O'Brien, 30 Springfield Avenue</u> – spoke about redevelopment and how it relates to the Township's Master Plan.

Hearing no further comments, Mayor Andrews closed the public comments portion of the meeting.

AUTHORIZING AN INTER-LOCAL AGREEMENT WITH THE COUNTY OF UNION FOR DRUG RECOGNITION EXPERT CALLOUT PROGRAM

WHEREAS the County of Union through the Union County Police Department is responsible for administering the New Jersey Division of Highway Traffic Safety Drug Recognition Expert Callout Grant Program on behalf of local and county agencies; and

WHEREAS, pursuant to Resolution No. 2022-727, the Union County Board of Chosen Freeholders authorized the County Manager to apply for, accept, and expend the New Jersey Division of Highway Traffic Safety (hereinafter referred to as the "NJDHTS") Drug Recognition Expert Callout Grant Program to assist law enforcement agencies in reducing drug-related crashes, injuries, and fatalities in an amount of \$73,950.00 for the grant period of October 1, 2022 through September 30, 2023 (hereinafter referred to as the "Program"); and

WHEREAS this Agreement shall memorial the expression of intent among the County and the Township of Cranford to cooperate with each other in implementing and operating a callout procedure for certified Drug Recognition Experts to respond to and conduct evaluations when drug use is suspected during a motor vehicle stop. The participants recognize that such cooperation assists in enabling communities to reduce the number of injuries and fatalities associated with drugged driving on County roadways; and

WHEREAS, the NJDHTS has issued a grant to the County of Union to administrate and provide call out through the Union County Police Department's Dispatch Center for participating municipal police departments' Drug Recognition Experts (hereinafter referred to as "DRE"). Pursuant to the grant, the County of Union will receive funds for administration costs. The grant provides overtime costs for DRE's callouts, as well as court appearances related to expert testimony. Funding is also provided for equipment purchases and training related to the DRE program; and

WHEREAS, the County and the Township of Cranford have determined it to be in their mutual interest for the Cranford Police Department to designate certain DREs to be assigned to the Program; and

WHEREAS, the Township of Cranford wishes to enter into this Agreement with the County of Union for the purpose of setting forth the terms and conditions regarding the assignment of DREs employed by the Municipality to the Program; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Cranford, in the County of Union, New Jersey, that the Township Administrator and the Township Clerk are hereby authorized to enter into a Drug Recognition Expert Callout Program Agreement with the County of Union, Union County Administration Building, 10 Elizabethtown Plaza, Elizabeth, New Jersey 07207, for the purpose of providing the Township with access to and funding for Drug Recognition Experts in order to reduce drug-related crashes, injuries, and fatalities.
