INVOCATION AND FLAG SALUTE

The invocation was led by Deputy Mayor Giblin, followed by the flag salute.

FIRE DEPARTMENT ANNOUNCEMENTS

Recognition Awards

INFORMAL MEETING

Mayor Hannen opened the informal meeting and asked if there were any questions or comments. Hearing no comments, Mayor Hannen closed the informal meeting.

ORDINANCES - Final Reading

Ordinance No. 2017-11:

The Township Clerk read by title only Ordinance No. 2017-11 entitled, "AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF CRANFORD, CHAPTER 98 DOGS AND OTHER ANIMALS".

Said ordinance having been advertised and posted in accordance with law, Commissioner O'Connor opened the public hearing.

Jeffrey Morton, Shake-A-Paw Pet Stores, Union/Green Brook New Jersey, stated that the ordinance proposed by the Township Committee was written by an animal rights group. Discussed other initiatives supported by animal rights groups and feels their agenda is political. Informed the Township Committee that it is illegal in New Jersey to buy a puppy from a puppy mill. Thanked Commissioner O'Connor for the motion to amend the ordinance to remove certain preamble statements, but feels the remainder of the ordinance is not truthful and requested that the Township Committee table the ordinance. Referred to data and specifics provided by animal rights activists and stated that these statistics are inaccurate and a "blatant lie". Feels the Township Committee should learn more before considering adoption of this ordinance. Also feels the ordinance is predicated on untruths and lies and reiterated his request that the Township Committee table the ordinance.

Mayor Hannen discussed data presented by Mr. Morton and requested clarification as to Mr. Morton's statement concerning the number of dogs euthanized per year.

Mr. Morton explained that there were thirty-four (34) dogs euthanized but the reasons why were not documented. Stated that some were due to health issues and some were due to behavioral issues.

Commissioner Dooley requested clarification of a 2015 statute cited by Mr. Morton.

Mr. Morton discussed the requirements of the Health Protection Act which prohibits pet stores from purchasing animals from puppy mills and stated that New Jersey pet stores must purchase animals from licensed breeders. Also mentioned that there has been a decrease in the number of pet stores in New Jersey.

Commissioner Dooley asked Mr. Morton how many years his business has been in operation.

Mr. Morton stated that he has been in business for twenty-six (26) years.

Larry Cohen, 24 Mac Lennan Place, Fanwood, New Jersey, Humane Society Volunteer, referred to Mr. Morton's statements and feels if they are true, they are unrelated to the Township Committee's consideration to prohibit the sale of animals in Cranford. Discussed the fact that one pet store exists in Cranford, Just for Pooches, and it does not sell animals. Also discussed violations against Shake-a-Paw and other pet stores, and mentioned that the owners of these stores are also in attendance tonight. Feels this ordinance would protect citizens and defenseless animals. Discussed comments included in a breeder's report regarding ways it controls the animal population. Feels the objective of this ordinance is to do the right thing for animals and citizens.

Commissioner Dooley requested clarification as to the contradiction in statistics provided by Mr. Morton vs. the Humane Society.

Mr. Cohen stated that eighty-four (84) dogs in Union County were euthanized in 2015.

<u>Delia Collins, 72 Georgia Street, Clark</u>, discussed the statistics concerning the number of animals euthanized and explained that many animals in Union county are euthanized in Essex County and would not be included in these statistics. Discussed a report by New Jersey Humane Health Services which listed how many animals have been euthanized in Newark.

<u>Denise Archer, Hunterdon County</u>, discussed animals she purchased at pet boutiques and animals she has rescued. Also stated that she is in the veterinary business and spoke in support of a pet store owner in attendance this evening. Feels many of the animals that are euthanized are in shelters. Also feels the Township Committee should not take rights from citizens as to where an animal may be purchased. Stated that if a pet store is in violation, an inspection of the premises should be conducted.

Mayor Hannen asked Ms, Archer if she is a veterinarian. Also requested clarification as to the animals left in shelters and if the reason was behavioral.

Ms. Archer stated that she is not a veterinarian and believes the majority of the animals left in shelters are due to the fact that their owners cannot take care of them.

Cindy Knowles, Owner of Furrylicious, discussed regulations implemented in 2015. Also stated that the prohibition of puppy mills could not be passed at the State level, and feels this is why animal rights groups are requesting prohibition at the municipal level. Stated that she has no violations issued against her store, which is contrary to statements made this evening. Discussed regulations she is required to follow and questioned why data from 2015 is being referred to when it is almost 2018. Explained that shelters are not regulated. Also discussed two (2) towns in New Jersey that are facing legal action for adopting similar ordinances. Read correspondence from various elected officials regarding her store. Also feels the animal rights group's agenda is political.

<u>Janis Fisher, Manasquan, New Jersey</u>, feels the court issues raised by Ms. Knowles pertains to constitutional issues and believes there is no issue with a challenge in Cranford because there is currently no pet store existing in Cranford. Also addressed conflicting statements concerning violations and referred to statements concerning the health of dogs adopted through recues as well as pet stores. Discussed the reason why data presented by the Humane Society dates back to 2015. Encouraged the Township Committee to move forward with the ordinance.

Alan Braslow, Cherry Hill, New Jersey, discussed an issue that occurred with a pet store in Cherry Hill and tax dollars spent to close that store down. Discussed regulations concerning health requirements and behavioral issues associated with certain dog breeds. Discussed screening conducted during a rescue adoption. Also referred to comments concerning the limitation of a citizen's choice of where animals may be purchased. Discussed 2016 data concerning euthanization in Union County and Camden County.

Mayor Hannen requested clarification as to the requirements concerning rescue shelters. Also requested clarification as to background checks conducted in connection with rescue adoption. Discussed background checks conducted when he rescued a dog and feels it is very involved, which might be why people chose to purchase from pet stores.

Mr. Braslow explained that there is no interpretation of rescue retail at the moment. Also discussed background checks that are conducted and inspection of the owner's home.

<u>Stephanie Earl, Furrylicious,</u> discussed issues with reports cited by animal rights activists. Discussed the demand for pets and stated that there are very few breeders in New Jersey. Also discussed the rescue process and feels

requirements to adopt a pet are unreasonable. Addressed comments that puppies from pet stores have inherent behavioral issues. Also discussed the Humane Society of the United States (HSUS) and the United States Department of Agriculture (USDA) and other regulations regarding pet stores.

Ellen Coyote, Hamilton, New Jersey, New Jersey State Certified Animal Cruelty Investigator, feels the entire pet store industry is unscrupulous. Discussed issues with USDA regulations and inspections. Encouraged the Township Committee to adopt the ordinance for the best interest of the public. Also stated that she would like to see regulations and license requirements implemented for rescue groups.

Hearing no further comments, Commissioner O'Connor closed the public hearing.

COMMISSIONER COMMENTS

Commissioner O'Connor discussed research she conducted concerning this ordinance. Does not feel this ordinance would limit citizens' rights. Also stated that the only pet store in Cranford sells pet supplies only, and that this store owner is supportive of this ordinance.

Commissioner Dooley explained that she would be abstaining because she is unsure as to which data is correct. Feels the State statute enacted in 2016 would adequately protect the citizens and residents of Cranford. Stated that she appreciates the passion that has been exhibited concerning this ordinance, but she needs further data in order to make an informed decision.

Deputy Mayor Giblin stated that he would also be abstaining from voting. Feels additional data is needed.

Mayor Hannen discussed the 2016 Animal Intake and Disposition Survey that was distributed this evening, and calculations he was able to derive from this report and from statistics available online. Feels it indicates that adoption is successful, but expressed concern with organizations that have made pet adoption almost impossible. Stated that he would reluctantly support adoption of this ordinance, but the adoption process needs to improve.

Hekemian, Richard Hekemian, Mark Hekemian and Cranford Development Associates, LLC ("CDA") (collectively, "Seller") dated January 5, 2017 ("Sale Agreement") to acquire certain properties known as Block 291, Lot 15.01 and Block 292, Lot 2 a/k/a 215 and 235 Birchwood Avenue in the Township of Cranford, Union County, New Jersey (the "Property"); and

WHEREAS, Pursuant to Resolution No. 2017-111 dated January 24, 2017, the Township entered into an amendment to the Sale Agreement with the Seller through a First Amendment to Agreement for Sale of Real Estate dated January 24, 2017 ("First Amendment"); and

WHEREAS, Pursuant to the First Amendment, Seller established an Environmental Escrow Holdback in the amount of \$250,000 for a period of nine (9) months from the February 7, 2017 Closing Date (*i.e.*, until November 7, 2017) that provided the Township with a mechanism to withdraw funds to pay for certain Remediation Costs in accordance with the conditions and procedures set forth in the First Amendment;

NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Cranford, in the County of Union, New Jersey:

- 1. The Township has completed its Remediation of the Property and has withdrawn the necessary funds from the Environmental Escrow Holdback to pay its Remediation costs (including \$10,891.25 paid to Maser Consulting and a \$20,000 lump sum settlement for remaining Remediation costs as agreed to by Seller); and
- 2. The remaining funds in the Environmental Escrow Holdback are \$219,108.75 ("Final Balance"); and
- 3. The Township is hereby authorized to direct the Escrow Agent to return the Final Balance to Seller.

PUBLIC COMMENTS

Mayor Hannen opened the public comments portion of the meeting and asked if there were any questions or comments.

<u>Kathy Allegro, 17 Shetland Drive</u>, referred to a comment on Facebook concerning the adjournment of Hartz Mountain's application and requested clarification.

Commissioner Dooley confirmed that the Planning Board hearing scheduled for October 18, 2017 concerning the Hartz Mountain application has been adjourned.

<u>Gerald Caperio</u>, 17 ½ <u>Eastman Street</u>, discussed public safety issues and requested that certain vacant properties be inspected and addressed accordingly.

Commissioner Dooley thanked Mr. Caperio for his comments and explained that earlier this year an ordinance regarding vacant properties was adopted and letters would be mailed to all vacant property owners regarding the condition of properties.

Mr. Caperio discussed multi-tenant properties, specifically office parks, and stated that they usually have long-term vacancies. Feels the Township should be aware of certain records and documents that should be on file with the Fire Department concerning these properties.

Michael Gedonius, 704 Springfield Avenue, discussed the 750 Walnut Avenue property. Explained that while he lives on the north side of Cranford, he feels this matter is a quality of life issue and supports residents who would be directly impacted by this development. Discussed mass transit which is consistently crowded and feels this will worsen if the development at 750 Walnut Avenue moves forward. Also feels the Township Committee should contact NJ Transit and state legislators concerning the impact the increase in population would have to mass transit. Also discussed Hartz Mountain's statements concerning the annual net benefit of the project and requested clarification as to the occupancy rate this net benefit was based upon. Also asked if Hartz Mountain believes in the numbers it provided, and if Hartz Mountain would be willing to "float a bond" to make up for any differences or shortfalls in its projected revenue. Encouraged the Township Committee to continue to ask questions and to listen to the residents of Cranford.

Wendy Menneg, 21 Sutton Place, discussed existing apartment complexes in Cranford and those being constructed in neighboring municipalities. Also discussed vacancies within those developments and requested clarification as to whether Hartz Mountain should be obligated to explain how it intends to fill vacant units. Also stated that vacant apartments within existing developments are being converted to Section 8 housing because of the difficulty encountered with filling vacancies. Stated that she does not understand how this development would be beneficial to Cranford.

Mayor Hannen referred to Ms. Menneg's statement regarding Section 8 housing and requested clarification as to how she obtained this data.

Ms. Menneg stated that residents residing in these developments have stated that vacant apartments are being converted to Section 8 housing.

Hearing no further comments, Mayor Hannen closed the public comment portion of the meeting.
