#### **MAYORAL ANNOUNCEMENTS**

Mayor Miller Prunty read the Mayor's Proclamation:

#### Metastatic Breast Cancer Awareness

WHEREAS, October is Breast Cancer Awareness Month, let it be known that the township of Cranford is pleased to recognize and observe October 13, 2022 as Metastatic Breast Cancer Awareness Day and hereby recognizes METAvivors of NJ as the first state chapter of METAvivor Research and Support, Inc; and WHEREAS, breast cancer is the most common type of cancer among women in the United States, and second leading cause of cancer death, more than one in eight women and one in 833 men will be diagnosed with breast cancer in their lifetimes. In 2022, an estimated 271,270 Americans will be diagnosed with breast cancer including over 8,340 women in New Jersey; and

WHEREAS, Metastatic breast cancer occurs when breast cancer spreads to other parts of the body - including the bones, lungs, liver and brain - and has an average life expectancy of 26 months. Regardless of early detection, approximately 30% of stage 0 to III breast cancers will return as stage IV. Approximately 42,260 Americans will die from breast cancer in 2022, with 98% being from metastatic breast cancer. This is equivalent to 115 deaths per day; and

WHEREAS, METAvivor educates the public about metastatic breast cancer research, they prioritize converting the disease from terminal to chronic by hiking the current 5 percent of U.S. metastatic breast cancer research dollars for stage IV treatment to 30 percent. This mission is captured in the #DontIgnoreStageIV national social media campaign. Extensive research efforts are underway to save lives, including the ClinicalTrials.gov database and Storm Riders Network which both provide critical information about ongoing clinical research studies and metastatic breast cancer-specific trials; and

WHEREAS, the METAvivors of NJ Facebook group was founded by Tami Bowling and Lauren O'Brien of Scotch Plains in April 2019 as an active response to stage IV metastatic breast cancer patients and their communities in and around New Jersey. It is a central network to access current metastatic breast cancer information, calls to action, and opportunities for community engagement. It also serves as a source of hope for patients, family and friends impacted by the disease; and

WHEREAS, the pink ribbon is well-known for representing the fight against breast cancer, the **metastatic breast cancer awareness ribbon colors** only include pink as a thin overlay to signify that the cancer originates in the breast. The addition of green and teal represents the triumph of spring over winter, life over death, renewal, hope, immortality, healing and spirituality.

NOW, THEREFORE BE IT RESOLVED that the Township Committee of the Township of Cranford hereby joins the nation to recognize October 13, 2022 as Metastatic Breast Cancer Awareness Day and encourages citizens to join the effort towards awareness of metastatic breast cancer in October.

BE IT FURTHER RESOLVED that a copy of this Resolution be presented as a sincere token of this Board's best wishes to our METAvivors of NJ representatives.

Mayor Miller Prunty thanked the Fire Department and the FMBA (Firefighters Mutual Benevolent Association) for their breast cancer awareness efforts and elaborated.

# RESOLUTION OPPOSING THE PROPOSED INCREASES TO THE STATE HEALTH BENEFITS PROGRAM

**WHEREAS**, the State Health Benefits Program (SHBP), governed by N.J.S.A. 52:14-17.25 et seq., offers medical, prescription drug, and dental coverage to qualified State and participating local government public employees, retirees, and eligible dependents; and

WHEREAS, all SHBP plans are self-funded meaning that the money paid out for benefits comes directly from a SHBP fund supplied by the State, participating local employers, and member premiums; and WHEREAS, the Division of Pensions and Benefits is responsible for the daily administrative activities of the SHPB, the State Health Benefits Commission is the executive organization responsible for overseeing the SHBP; and

WHEREAS, the State Health Benefits Commission, comprised of state officials and union representatives, annually consider the calendar year premium levels for the Local Government Employer Group of the SHBP based on recommendations found in the Rate Setting Recommendation Analysis of the Local Government Employee Group; and

**WHEREAS**, the preliminary rate increase for the 2023 Local Government Employer Group is 22.8%, which includes a 21.6% increase for Active, a 13% increase in Early Retiree, and a 0.7% increase for Medicare Retiree; and

WHEREAS, subsequent news accounts report the Department of Treasury noting "rates for active members and early retirees would likely be increased between 12 to 20 % across the various plans for the upcoming year"; and

WHEREAS, such proposed exorbitant rate increases will fall upon the local property taxpayer along with the local public employees at a time where there is record inflation, and

WHEREAS, the proposed premium increase for most active employees will take thousands more out of their paychecks annually and lead to huge costs for local governments that will translate into higher property tax bills for struggling families; and

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Cranford in the County of Union that it does contact the State Health Benefit Commission to reconsider the rate increase and strike a rate increase that is appropriate in the current economic conditions; and

**BE IT FURTHER RESOVLED**, that the governing body of the Township of Cranford in the County of Union does hereby urge the legislature to adopt legislation expanding the composition of the State Health Benefits Commission to include representatives from both municipal and county government management; and

**NOW THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Cranford that November 4<sup>th</sup> through November 6, 2022 be designated as Rake Days in collection zones two (2) and three (3); and

# **PUBLIC COMMENTS**

Mayor Miller Prunty opened the public comments portion of the meeting and asked if there were any questions or comments.

Jason Stevens, 9 Richmond Avenue – Mr. Stevens discussed the public hearings that had occurred during the past eight (8) months regarding development at Williams Nursery in Westfield. He thanked Mayor Miller Prunty for her effort on this matter. Mr. Stevens stated that no one had more to lose regarding the proposed development than the residents in the Northeast quadrant in Cranford (as it pertained to flooding). Mr. Stevens encouraged members of the public to attend the Union County Planning Board Zoom meeting regarding this development which was scheduled for the following evening. He provided the Union County Department of Land Use phone number (908-527-4268) to gain Zoom meeting access. Mayor Miller Prunty requested that the letter she had written to the Union County Planning Board regarding this matter be posted to the website if it had not been already posted. Mr. Stevens stated that their outreach had already positively affected the development plans.

<u>William Thilly, 22 Bloomingdale Avenue</u> – Mr. Thilly stated that he was an independent candidate for the Township Committee. He inquired 1) if anyone had been in contact with the owners of the Williams Nursery, 2) asked about whether progress had been made regarding interested developers paying for their own taxes, and 3) if the Township could require developers to pay for their own flood mitigation efforts.

Mayor Miller Prunty responded. Mr. Thilly stated that he had lost confidence in developers to "do" proper flood mitigation and elaborated.

Mr. Thilly spoke about the Birchwood Park units, specifically regarding the number of Birchwood Park students that entered the Cranford school system. Mr. Thilly spoke about the 750 Walnut Avenue and Chestnut Street developments and his desire that the developers pay a lot of money. Mayor Miller Prunty provided information about the number of school children at the Birchwood Park development, specifically that there were thirty-three (33) children in the school system as opposed to the projected ninety (90) students.

<u>Jim Carvalho, 9 Orange Avenue</u> – Mr. Carvalho spoke about a "machine matinee". He stated that the "machine matinee" consisted of two (2) partisan campaign events on taxpayer property at taxpayer expense: 1) a Community Center April 26<sup>th</sup> event with Congressman Donald Payne Jr. and 2) a June 30<sup>th</sup> (State) Budget signing at Cranford High School Library with Governor Phil Murphy. Mr. Carvahlo named and described individuals who attended both events.

<u>William Thilly, 22 Bloomingdale Avenue</u> – Mr. Thilly asked the Township Committee to remind members of the public about the Anchor Program tax rebate.

Hearing no further comments, Mayor Miller Prunty closed the public comments portion of the meeting.

#### **Commissioner Gina Black**

- Expressed her condolences to Building Department Head Frank Genova on the passing of his father;
