#### MAYORAL ANNOUNCEMENTS

Mayor Miller Prunty read the Proclamation:

<u>Former Police Chief Harry W. Wilde Recognition – Outstanding accomplishment and dedication to</u> <u>the Township and residents of Cranford</u>

WHEREAS, Harry Wilde, dedicated his career, time and talents to family, friends, his beloved Cranford community and the Cranford Police Department; and

WHEREAS, Harry Wilde, served in the United States Coast Guard from 1959-1963 and achieved the rank of Boatswain Mate. He served in Greenland and later commanded vessels patrolling the New York harbor; and

WHEREAS, Harry Wilde joined the Cranford Police Department in 1963 and moved quickly through the ranks, before being promoted to Chief in 1991; and

WHEREAS, Harry Wilde' commitment and history with the Cranford Police Department holds many accomplishments throughout his forty-year career, before retiring in 2003; and

WHEREAS, Harry Wilde served as an adjunct faculty member at Union College, served on the Union College Board of Governors, served as Executive Officer of the Union County Narcotics Strike Force and is a past recipient of the Martin Luther King Award; and

WHEREAS, Harry Wilde was directly responsible for developing the West Point Command and Leadership Program in 1993. To this day the academic award bears his name; and

WHEREAS, Harry Wilde was appointed by the NJ State Chiefs of Police Association to serve on the Attorney Generals task force on police reform and recognized by the NJ State Chiefs of Police Association as a resident expert\* in the field of Federal Tort Claims; and

WHEREAS, Chief Wilde' love for his family, the community and his country, has inspired his tremendous efforts as a leader to contribute to his lifelong dedication and service; and

NOW, THEREFORE, BE IT RESOLVED, that the Township Committee of the Township of Cranford

thank and commend Chief Harry Wilde for his dedication to our community for all his work as a true leader and wish him good health and happiness.

Mayor Miller Prunty invited members of Trinity Episcopal Church to the podium and read the Mayor's Proclamation:

#### 150<sup>th</sup> Anniversary of Trinity Episcopal Church

WHEREAS, in 1872 a small group met in private homes in Cranford to worship "according to the customs and usages of the Protestant Episcopal Church. The group incorporated a religious society under the name The Rectors and Trustees of Trinity Mission Episcopal Church"; and

WHEREAS, in 1873, as the parish out-grew worshiping in members' homes, "the old public-school house" was rented to hold services, which were presided over by priests from neighboring parishes. In addition, funds were raised from members and via small denomination bonds, purchased by Cranford citizens, to begin construction of a church building at its present location on land donated by members. In 1875, the first service was celebrated in the new church building and Trinity called the Rev. E.M. Reilly as its first Rector; and

WHEREAS, Trinity has a strong tradition of service to others. During the Great Depression Trinity, led by Father Frank Sherlock, co-founded the Cranford Welfare Association which has become Cranford Family Care today. Since 1956 Trinity has been providing space for weekly Alcoholics Anonymous meetings. Today, Trinity's Outreach Ministry projects serve the local and international community, and WHEREAS, Today, Trinity is dedicated to living out its mission 'to know Christ and make the Lord known with Joy, Faith, and Service' in all that we do; and

NOW, THEREFORE IT BE RESOLVED that the Township Committee of the Township of Cranford congratulates Trinity Episcopal Church on the occasion of its 150th Anniversary and commends the many people who, through many generations, have built and sustained this loving and generous congregation in Cranford.

Father Andy Kruger of Trinity Episcopal Church thanked Mayor Miller Prunty for reading the proclamation and spoke briefly about the planning that went into Trinity Episcopal Church's 150<sup>th</sup> Anniversary celebration, noting that the celebration was delayed due to the pandemic. He also spoke about the support and commitment of the Township to its residents and serving in a church which is committed to its parishioners\* and the surrounding community.

#### **INFORMAL MEETING**

Mayor Miller Prunty opened the informal meeting portion of the meeting and asked if there were any questions or comments.

<u>Jim Carvalho, 9 Orange Avenue</u> – Mr. Carvalho stated that he was dissatisfied with the slow pace at which it takes for Township Committee meeting minutes to be approved and made available to the public. He read an excerpt from State law which referred to the promptness at which meeting minutes should be made available to the public and asked the Township Committee what the reason was for the delay. A discussion ensued in which Township Clerk Donahue spoke about the status of Minutes processing.

<u>Greg Carey, 25 Locust Drive</u> – Mr. Carey said that he was in attendance to petition the Township Committee for relief against the proliferation of 5G antennas throughout Cranford. He expressed concerns about the potential exposure of radio frequency output that could be harmful to residents. He made a formal request that the Township Code be amended to restrict 5G infrastructure, specifically to the effect of the prompt removal of all 5G antennas from residential spaces and/or spaces that children frequent within the Township.

<u>Chrissa Stulpin, 356 Retford Avenue</u> – Ms. Stulpin inquired about Resolution No. 2022-367 pertaining to the award of contract to Arterial LLC for the Special Improvement District (SID) Streetscape Improvement Plan. Mayor Miller Prunty responded.

<u>SECTION 2</u>. It is hereby determined and stated that (1) said Note is not a "private activity bond" as defined in the Code and (2) the Township and its subordinate entities, if any, do not reasonably anticipate issuing in excess of \$10 million of new money tax-exempt obligations (other than private activity bonds) during the calendar year 2022.

<u>SECTION 3</u>. It is further determined and stated that the Township has, as of the date hereof, issued the following tax-exempt obligations (other than the Note) during the calendar year 2022, viz:

The issuing officers of the Township be and they hereby are authorized to deliver a certified copy of this resolution to the original purchaser of the Note and to further provide such original purchaser with a certificate of obligations issued during the calendar year 2022 dated as of the date of delivery of the Note.

<u>SECTION 6</u>. This resolution shall take effect immediately upon its adoption.

# RESOLUTION REQUESTING APPROVAL OF ITEMS OF REVENUE AND APPROPRIATION – N.J.S.A. 40A: 4-87

# (PERTAINING TO THE NATIONAL OPIOIDS SETTLEMENT)

**WHEREAS**, N.J.S.A. 40A: 4-87 provides that the Director of the New Jersey Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, the Director may also approve the insertion of an appropriation for the equal amount;

**NOW, THEREFORE, BE IT RESOLVED** that the Township Committee of the Township of Cranford in the County of Union, New Jersey hereby requests the Director of the New Jersey Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2022 in the sum of \$7,190.00 which is now available from the Settlement Agreements, more commonly referenced as the "National Opioids Settlement," between the three largest pharmaceutical distributors, Johnson & Johnson, McKesson, Cardinal Health and AmerisourceBergen, and the multiple States and Local Political Subdivisions affected by the opioid crisis, pursuant to the provision of the statute; and

**BE IT FURTHER RESOLVED** that the like sum of \$7,190.00 is hereby appropriated under the caption "National Opioids Settlement"; and

**BE IT FURTHER RESOLVED** that the above is a result of funds from the "National Opioids Settlement" agreement in the amount of \$7,190.00.

## Resolution No. 2022-381:

**WHEREAS**, Father Charles Watters, who was an Air National Guard Chaplain during two tours of duty during the Vietnam War, also served at St. Michael Church in Cranford from 1964 through 1965; and

**WHEREAS,** during his second tour, Father Watters was killed on November 17, 1967 during a twelve (12)-day battle in the vicinity of Dak To, Vietnam; and

**WHEREAS**, unarmed and completely exposed, Father Watters rushed forward in the line of contact with complete disregard for his own safety to provide aid to wounded soldiers, to assist with evacuation efforts and to assist with Last Rites to the dying soldiers; and

**WHEREAS**, Father Watters was mortally wounded while giving aid to his comrades and awarded our nation's highest honor, the Congressional Medal of Honor, posthumously. Only a handful of chaplains have received this honor. Father Watters was buried at Arlington National Cemetery with full honors; and **WHEREAS**, during Cranford Memorial Day Parades, the Cranford Knights of Columbus honored Father Charles Watters with a float depicting him ministering to a fellow soldier; and

**WHEREAS**, Father Charles Watters spent all of his life in Cranford, serving the people of his town, and then served his country and ultimately, gave his life; and

**WHEREAS**, as Father Watters served in Saint Michael Parish, it is fitting to memorialize him in the location near St. Michael Church; and

**WHEREAS**, Father Watters always put others needs before his own and was known for his willingness to help those in need and whose sacrifice and dedication to the community have been recognized by the Veterans of Foreign War (VFW), the Cranford 86, and Saint Michael Church; and

**WHEREAS**, Cranford residents Gracy Lyubarsky, Aashritha Jinaga, and Alexi Pryor of Girl Scout Troop No. 40222 focused their Silver Award Project on formally recognizing the Cranford 86 individuals with honorary street signs within the community, beginning with Father Charles Watters; and

**WHEREAS**, these Silver Award Candidates worked with the Cranford VFW, Saint Michael Church, the Cranford Historical Society, the Cranford 86 Project Committee, the Cranford Police Department and the Cranford Knights of Columbus to organize an effort to dedicate a Township Road to Father Watters; and

**NOW THEREFORE BE IT RESOLVED** that the Township Committee of the Township of Cranford, be and hereby authorizes, the dedication of street signs, and the honorary re-naming of Alden Street, from Miln Street to North Union Avenue, as "Father Charles Watters Plaza".

## Resolution No. 2022-382:
