INFORMAL MEETING

Mayor Miller Prunty opened the informal meeting portion of the meeting and asked if there were any questions or comments.

<u>Don Smith, 21 Oneida Place</u> – Mr. Smith inquired about Ordinance No. 2022-27 pertaining to a financial agreement for the redevelopment of land located at 750 Walnut Avenue. He inquired 1) why there was not a schedule of payments and 2) the duration of the long-term period associated with the Financial Agreement. Township Attorney Ryan Cooper responded. Discussion ensued.

William Thilly, 22 Bloomingdale Avenue – Mr. Thilly sought clarification regarding Ordinance No. 2022-27, including language in the Financial Agreement pertaining to annual revenue versus annual gross revenue. He inquired why a large tax exemption would be given to a large development company. Discussion ensued.

Mayor Miller Prunty asked Chief Financial Officer Lavona Patterson to address members of the public regarding the Payment in Lieu of Taxes (PILOT) for the 750 Walnut Avenue Redevelopment area.

<u>Chief Financial Officer Lavona Patterson</u> - Ms. Patterson spoke about the 750 Walnut Avenue Redevelopment area and taxes. She covered the areas of conventional taxes, taxes on the commercial portion of the area and taxes on the residential improvements portion of the project (there would be no taxation for the residential improvements portion). Ms. Patterson said that there would be an approximate four million dollar (\$4,000,000) increase on the assessment if the Township moved forward with the project. She then spoke about the Township's tax levy and net valuation.

Commissioner Andrews asked Ms. Patterson for clarification regarding the PILOT. Brief discussion ensued.

Hearing no further comments, Mayor Miller Prunty closed the informal meeting portion of the meeting.

$ORDINANCES-\underline{Introduction}$

Ordinance No. 2022-27:

The Township Clerk read by title only Ordinance No. 2022-27 entitled, "AN ORDINANCE ESTABLISHING A FINANCIAL AGREEMENT FOR THE BENEFIT OF THE REDEVELOPMENT OF APPROXIMATELY 15 ACRES LOCATED AT 750 WALNUT AVENUE, BLOCK 541, LOT 2"

Said ordinance was introduced and approved on first reading on motion of Deputy Mayor Gareis, seconded by Commissioner Andrews, and passed by the indicated vote of the Township Committee:

Commissioner Black

Stated that she greatly respected the Township professionals and respected that the PILOT (Payment in Lieu of Taxes) agreement for the 750 Walnut Avenue was better than most. She expressed concerns over what the Township would be getting in return from the developer. Commissioner Black stated that she spent a lot of time 1) reviewing the Phoenix Advisor figures and 2) reviewing these numbers with Chief Financial Officer Patterson. She stated that the developer would be getting a long-term forty-million-dollar (\$40,000,000) tax credit and elaborated. She inquired what the Township would be getting back and answered that she did not believe the Township was receiving much in return. Commissioner Black spoke about what the developer would be receiving including their desired building height and desired building configurations. She noted that the developer resisted residents' requests to keep the current driveway configurations. Commissioner Black spoke about previous developments which were built without PILOT agreements, specifically the Riverfront and Woodmont developments. Commissioner Black stated that she would be voting "no".

Commissioner O'Connor

Spoke about the Memorandum of Understanding (MOU) for the 750 Walnut Avenue redevelopment area and how it related to the PILOT. Commissioner O'Connor referenced a phrase in the MOU: "mutual good faith, cooperation and assistance" and stated that should be shown by both parties. Commissioner O'Connor spoke about the residents' concerns regarding the driveways and noted that nothing had been done in response to these concerns. She stated that the concerns about the Traffic Study fell on deaf ears. Commissioner O' Connor stated that the Township could get a better deal from Hartz Mountain Industries, Inc. (Hartz) and elaborated. She stated that the residents were her first concern and stated that

she did not think they had been treated with mutual good faith by Hartz. Commissioner O'Connor stated that she would be voting "no'.

<u>Commissioner Andrews</u>

Commissioner Andrews provided background on what had occurred during recent years between the Township and Hartz. Commissioner Andrews noted that the MOU had been approved unanimously. He also noted that the MOU had been approved before his time on the Township Committee. Commissioner Andrews stated that legal counsel had advised that Hartz could hold the Agreement to the Township. Commissioner Andrews stated that he had worked fairly aggressively to renegotiate. He stated that legal counsel had consistently advised that in order to comply with the law and Special Master, the terms of the MOU had to be honored. Commissioner Andrews stated that it was responsible to meet the Affordable Housing requirements. He noted this PILOT would result in a reduced tax burden on the residents and more money would go to the schools. Commissioner Andrews stated that he did not think the Agreement was perfect but it would be better than getting sued and it was better than getting a development with nine hundred (900) units. Commissioner Andrews stated that the responsible thing to do would be to approve the PILOT and stated that he would be voting "yes".

Deputy Mayor Gareis

Stated that the Agreement preceded his time on the Township Committee. Deputy Mayor Gareis spoke about the duty to continue the Agreement and elaborated. He stated that he could not comment on some of Commissioner O'Connor's points as the application was before the Planning Board and he sat on the Planning Board. He stated that he would vote 'yes'.

Mayor Miller Prunty

Stated that like Deputy Mayor Gareis, Mayor Miller Prunty sat on the Planning Board and the 750 Walnut Avenue application was an active application before the Planning Board. Mayor Miller Prunty stated that she could not comment because she sits on the Planning Board. Mayor Miller Prunty noted that this matter preceded her time on the Township Committee and elaborated. She stated that like her fellow Commissioners, Mayor Miller Prunty had worked hard to get the best for Cranford and that she would be voting "yes".

<u>Don Smith, 21 Oneida Place</u> – Mr. Smith asked for a status on Hartz Mountain's intention to file for a variance to remove the basketball courts. Mayor Miller Prunty responded.

Jim Carvalho, 9 Orange Avenue – Mr. Carvalho expressed his dissatisfaction with the party in power. He discussed the results of the recent general election. He spoke about two recent partisan affairs held at what he believed were on taxpayer expense, specifically Senator Donald Payne's visit to the Cranford Community Center and Governor Phil Murphy's visit to Cranford High School. Mr. Carvalho stated that he had not received support from the opposition party and elaborated. He spoke about recent ordinances pertaining to conflict-of-interest policies and the establishment of an anti-nepotism policy. Mr. Carvalho spoke about his dissatisfaction with the opposition party.

Mayor Miller Prunty suggested that if Mr. Carvalho truly believed his accusations that he contact the Union County Prosecutor's Office or the Attorney General's Office.

<u>William Thilly, 22 Bloomingdale Avenue</u> – Mr. Thilly spoke about tax exemptions, affordable housing obligations, matters not being clear to the members of the public, optics and a money loss for the Township. He suggested renegotiating. Mr. Thilly stated that he wanted to spend the rest of his time relaxing.

<u>Superintendent of Public Works Erik Hastrup, 364 North Avenue East</u> – Mr. Hastrup provided an update on leaf pickup.

Hearing no further comments, Mayor Miller Prunty closed the public comments portion of the meeting.
