INVOCATION AND FLAG SALUTE

The invocation was led by Deputy Mayor Curran. The flag salute was led by members of Cranford Girl Scout Troop 40079.

MAYORAL PROCLAMATIONS/

ANNOUNCEMENTS Mayor Andrews recognized

Mayor Andrews recognized March as Women's History Month; spoke about the Township's female Administrator, Business Administrator/CFO Lavona Patterson and complimented her work; spoke about the women in Cranford's Municipal Government who continuously overperform for members of the public. Mayor Andrews spoke about the mission of the Girl Scouts as well as their role in building future women leaders; thanked Girl Scout Troop 40079 for their recent work with the installation of planters at the entrance to the Riverwalk (at South Avenue and Centennial Avenue).

Mayor Andrews spoke about the recognition of March as Colorectal Cancer Awareness Month; noted that a member of the community had passed, Ms. Amy Saccone, from this disease last year. Mayor Andrews invited Richard Saccone and Dr. Christopher Lenza to the dais and read the Mayor's Proclamation:

Colorectal Cancer Awareness Month

WHEREAS, the second leading cause of cancer death among men and woman in the United States today is colorectal cancer; and

WHEREAS, every year over 150,000 people in our country are diagnosed with this disease, and sadly over 50,000 Americans die from it; and

WHEREAS, colorectal cancer is one of the most highly treatable forms of cancer because regular screening tests can detect cancer early, when treatment is most likely successful; and

WHEREAS, colorectal cancer rates have been increasing in people younger than 50 years of age; and WHEREAS, educational efforts can help provide information to the public of methods of prevention and screening for early detection; and

WHEREAS, during National Colorectal Cancer Awareness Month, we honor all Americans we have lost to this disease, those currently surviving it, and the loved ones who support them.

NOW, THEREFORE BE IT RESOLVED, that I, Brian Andrews, Mayor of the Township of Cranford, on behalf of the Township Committee of the Township of Cranford, Proclaim March as National Colorectal Cancer Awareness Month and encourage all citizens to increase awareness and prevention of this disease.

Dr. Christopher Lenza provided comments about colorectal cancer, the importance of screening for the disease and recommended that persons over the age of 45 (forty-five) years get screened for colorectal cancer. Mr. Saccone thanked the Mayor for the proclamation and thanked the members of Township Committee for the opportunity to speak. Mr. Saccone spoke about awareness, action and better outcomes for colorectal cancer; noted that younger Americans should be tested and elaborated; spoke about his wife's experience with colorectal cancer; spoke about his hope that his wife's struggle would not be "for naught".

Mayor Andrews stated that the Cranford Clergy Council, the Cranford Interfaith Human Relations Committee, Cranford Public Schools and Saint Michael School would be hosting the 13th Annual Cranford Community Holocaust Day of Remembrance on March 27th at Hillside Avenue School. He then read the Mayor's Proclamation:

Holocaust Remembrance

WHEREAS, the Holocaust was the systematic persecution and annihilation of six million Jews, and millions of others including Roma, Poles, people with physical disabilities, homosexuals, communists, socialists and dissenting clergy by the Nazi regime and its collaborators between 1933 and 1945; and WHEREAS, the attacks in Israel on October 7, 2023, represent the deadliest day for Jews since the Holocaust and Hamas continues to unjustly hold hostages who were abducted that day; and

WHEREAS, we the people of the Township of Cranford should always remember the terrible events of the Holocaust and remain vigilant against hatred, persecution, and tyranny; and

WHEREAS, the Cranford Clergy Council, Cranford Interfaith Human Relations Committee, Cranford Public Schools, & Saint Michael School will host the 13th Annual Cranford Community Holocaust Day of Remembrance on Wednesday, March 27, at Hillside Avenue School; and

WHEREAS, as a community, we have a responsibility through the power of education and our actions to directly challenge and combat acts of injustice, bias, inequity, and hate; and

NOW, THEREFORE, I, Brian Andrews, Mayor of the Township of Cranford, pursuant to an Act of Congress (Public Law 96-388, October 7, 1980), do hereby honor the victims of the Holocaust and the survivors, as well as the rescuers and liberators, and further proclaim that we, the Cranford community, should strive to overcome hate, intolerance and indifference through education, remembrance, and action.

MAYORAL REMARKS

Mayor Andrews stated that the Township's Operating Budget and Capital Budget would be considered for introduction that evening; stated that the Budget reflected the Township Committee's values and aspirations and elaborated about the Township's expected investments. Mayor Andrews stated that the New Jersey State Senate had approved a bill which would create a new regulatory framework for Affordable Housing commitments in New Jersey; stated that this bill was not the right solution for the State of New Jersey; stated that the Bill would dissolve the Council on Affordable Housing; spoke about Affordable Housing requirements and the lack of acknowledgement of building in flood areas. Mayor Andrews spoke about comments received from residents during the evening's Workshop Meeting pertaining to their concerns regarding 1) 750 Walnut Avenue and 2) flooding at Casino Avenue.

COMMISSIONER REPORTS

<u>Deputy Mayor Curran – Recreation & Parks</u>

- Encouraged residents to join the Outdoor Pools; provided a year-to-date Outdoor Pool membership sign-up update;
- Stated that the Cranford Recreation website was operational; noted that it was more user-friendly;
- Commended Richard Saccone and Dr. Christopher Lenza for their remarks about Colorectal Cancer screenings; recommended Colorectal Cancer screenings and elaborated about their importance;
- Spoke about the resident feedback received at the evening's Workshop Meeting regarding the 750 Walnut Avenue construction area; spoke about an upcoming planned on-site meeting with representatives from Hartz Mountain Industries (Hartz) and concerns pertaining to dust, mounds (of dirt), traffic mitigation and tree plantings.

<u>Commissioner Miller Prunty – Engineering & Public Works</u>

- Spoke about the introduction of the Municipal Budget and the Downtown District Management Corporation (DMC) Budget which would occur that evening; noted that the DMC assessment for the Downtown property owners would increase for the first time since 2013; spoke about the work of the Downtown Management Corporation (DMC);
- Provided an update on upcoming road repair work;
- Invited members of the public to attend the Clean & Green Cranford Committee's Annual River Cleanup on April 20th;
- Stated that she was pleased to announce that Construction Code Official Gary Junkroft and Technical Assistant Hillary Barboza had begun work in the Building Department and briefly elaborated.

<u>Commissioner Gallo – Public Safety</u>

- Noted that it was Women's History Month and recognized several members of the Cranford Police Department, Cranford Fire Department and Cranford First Aid Squad;
- Congratulated Christopher Polito on his promotion to the rank of Police Captain;
- Welcomed Probationary Patrol Officers Matthew Richel and Quinn Haddad to the Cranford Police Department;
- Congratulated Walter Berg on his re-appointment as a Special Law Enforcement Officer;
- Announced that the Cranford Fire Department had been awarded a \$40,000 (forty thousand dollars) American Rescue Plan Firefighter grant; thanked Fire Chief Dan Czeh and Battalion Chief Matt Lubin for their grant work;
- Reminded residents that the "burning of yard waste" and other materials is prohibited; provided Fire Department contact information.

Commissioner Black – Finance

- Spoke about the Municipal Budget process and described the challenges to the Township's finances (i.e., utility increases, insurance increases, terminal pay costs, pension costs and RVSA (Rahway Valley Sewerage Authority) increases); spoke about the Township Surplus and the Capital Budget; spoke about the expected Municipal portion of the Tax Levy; stated that the Budget would be published in the Westfield Leader; noted that the Budget would be considered for adoption at the end of April; encouraged residents to bring forth questions about the Budget.
- Described Ordinance No. 2024-09 (pertaining to the establishment of a CAP Bank).

Mayor Brian Andrews

 Complimented Business Administrator/CFO Lavona Patterson on her work with the 2024 Municipal Budget.

Township Attorney Ryan Cooper

Noted that he meets monthly with the Township's Affordable Housing Counsel and Affordable Housing Planner to discuss the changes in legislation as well as the Township's future obligations and plans; stated he expected that plans and concepts would be presented to the Township Committee and residents in the future months.

PUBLIC COMMENTS

Mayor Andrews opened the public comments portion of the meeting and asked if there were any questions or comments.

<u>Don Smith, 21 Oneida Place</u> – referenced pending Affordable Housing legislation and suggested that the Township Committee brief residents on the Township's current and future Affordable Housing obligations and elaborated.

<u>William Thilly, Cranford</u> – stated that he would be running as an independent candidate for Township Committee in the upcoming General Election and elaborated about 1) how he would conduct himself as a member of the Township Committee, 2) developers and 3) Robert F. Kennedy, Jr. statements.

<u>Sherry Lange, 222 Arbor Street</u> – spoke about a recent email she sent to the Township Committee which requested the display of the Christian Flag on the flagpole in front of the Municipal Building for the month of April; provided a Supreme Court ruling reference regarding this request.

George Collins, 5 Behnert Place – noted that he was a member of the Environmental Commission; spoke about the idling of trucks on Walnut Avenue and requested that Commissioner Gallo follow-up with the Cranford Police Department regarding carbon emission signage for Walnut Avenue. Mr. Collins then read a letter from the daughter (Carol Kennedy) of his elderly neighbors (Mary and Aldo Ramondelli of 729 Walnut Avenue) which described the negative impact of the construction activity at 750 Walnut Avenue (i.e., noise, traffic, debris and dust) and provided suggestions on how the Township Committee could assist (i.e., dust suppression techniques and noise reduction strategies). Mr. Collins spoke about the negative consequences associated with the construction activity at 750 Walnut Avenue (i.e., pervasive dust and associated cough); requested that the Township Committee continue to hold Hartz (Hartz

Mountain Industries) accountable; spoke about the hazardous effects of the increased traffic on Behnert Place; requested the conversion of Behnert Place to a dead-end street.

Angela Leary, 4 Behnert Place – thanked the Township Committee for 1) their work and 2) keeping the residents informed about the progress at 750 Walnut Avenue; requested that Commissioner Gallo work with traffic matters at 750 Walnut Avenue, specifically a speed sign on Walnut Avenue and the development of a traffic plan; spoke about truck traffic on Lexington Avenue and needed signage; inquired whether separate ordinances pertaining to the prohibition of truck traffic were needed for various streets around 750 Walnut Avenue; requested an update pertaining to a 25 (twenty-five) miles per hour speed limit on Walnut Avenue.

<u>Christine Esposito, 11 Behnert Place</u> – spoke about truck traffic on Walnut Avenue, specifically during the early morning hours; requested a greater Police presence during the morning hours.

<u>Delia Collins, 72 Georgia Street (Clark)</u> – discussed the need for additional pedestrian crossing signage at the intersection of Walnut Avenue and Chester Lang Place, specifically for drivers coming from Clark.

- 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate, and correctly stated
 - b. Items of appropriation are properly set forth
 - c. In itemization, form, arrangement, and content the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced, publicly advertised, and

adopted in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.

6. That all other applicable statutory requirements have been fulfilled.

RESOLUTION IN SUPPORT OF CONVERTING EXISTING BUT UNDERUTILIZED RAIL TRACK WITHIN THE CENTRAL RAILROAD (CRR)/NEW JERSEY TRANSIT (NJT) RIGHT OF WAY (ROW) INTO PEDESTRIAN/BICYCLE TRAILS AND CONNECTING ALL PEDESTRIAN/BICYCLE TRAILS IN UNION COUNTY

WHEREAS, the Township Committee of the Township of Cranford wishes to show continued support for the use and expansion of alternate modes of transportation in order to reduce vehicular traffic on our roads, provide safe means of off-road travel, increase usable greenways and open space and provide connectivity of communities of place via off-road trails throughout Union County; and

WHEREAS, on July 13, 2021, the Township Committee of the Township of Cranford adopted Resolution No. 2021-269 which expressed support for the 'Rails to Trails Union County' advocacy group in their pursuit of the transformation of unutilized railroad lines into walking and bicycle trails connecting the Township of Cranford and all other municipalities with unutilized railroad lines in the County of Union; and

WHEREAS, the 'Rails to Trails' group has transformed into 'Union County Connects', a group with the larger vision of creating and connecting all pedestrian and bicycle trails in Union County, and

WHEREAS, Union County Connects (UCC) has the support of the Union County Board of County Commissioners, and

WHEREAS, in February 2023, Union County was awarded a \$700,000 (seven hundred thousand dollars) in Federal Safe Streets and Roads funding for all grant portions of what will be used in association with Union County Connects, and

WHEREAS, in June 2023, Union County was awarded \$ 1,500,000 (one and half million dollars) in NJDOT (New Jersey Department of Transportation) funding for the conversion of the Rahway Valley Line from an abandoned railway line to a bicycle/pedestrian trail, and

WHEREAS, in September 2023, Union County received a \$1,000,000 (one million dollars) award for the design and construction of a new pedestrian/bicycle way through the Borough of Roselle, connecting with the East Coast Greenway in Cranford, which then connects with the Goethals Bridge, and the CRR/NJT line, and

WHEREAS, all Union County municipalities along the former CRR New Jersey ROW from Elizabeth, through Roselle/Roselle Park, Cranford, Garwood, Westfield, Fanwood, Scotch Plains and Plainfield are

experiencing exponential growth of mixed use residential/commercial development with the potential for increased vehicular traffic on North and South Avenues (also known as SR 28 and UC 610) which parallel the CRR line as main east-west routes of travel; and

WHEREAS, it is apparent that the joint conversion of the 3.8 (three and eight-tenths) mile defunct section of CRR ROW (Elizabeth-Cranford), and a shared usage of the 8 (eight) mile section of operating NJT ROW (Cranford- Plainfield) could be converted via Rail-to-Trails and Trails within Rails (Massachusetts Central Rail Trail) into a 12 (twelve) mile off-road bicycle/pedestrian trail that would provide a new travel way potentially reducing traffic on our roadways, changing modal travel to unite our municipalities for pleasure, social and business travel and potential economic benefits, with the provision of a new Union County destination connecting all municipalities via bicycle and pedestrian travel.

NOW THEREFORE BE IT RESOLVED that the Township Committee of the Township of Cranford, County of Union, State of New Jersey, hereby expresses support for "Union County Connects' in its pursuit of connecting all underutilized railroad ROWs, bicycle and walking trails and parks in the County of Union.

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to the Union County Board of County Commissioners and appropriate New Jersey Transit representatives.
