WHEREAS, the Township intends to use all those powers provided by the Legislature for use in a redevelopment area, including the power of eminent domain.

NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Cranford, in the County of Union, New Jersey does hereby, pursuant to N.J.S.A. 40A:12A-4, request and authorize the Planning Board of the Township of Cranford to undertake a preliminary investigation as to whether the land identified as Block 195, in its entirety, and Block 193, Lots 6.01, 10, 11, 12, 13, 14, 15 & 16 on the Township of Cranford Tax Map be classified as an area in need of redevelopment or an area of rehabilitation; and,

BE IT FURTHER RESOLVED that the Planning Board of the Township of Cranford shall conduct the aforesaid investigation in accordance with the requirements of N.J.S.A. 40A:12A-6; and,

BE IT FURTHER RESOLVED that the redevelopment area determination, if such a determination is made, shall authorize the municipality to use all those powers provided by the Legislature for use in a redevelopment area, including the power of eminent domain; and,

BE IT FURTHER RESOLVED that in making its preliminary investigation, the Planning Board shall make its recommendations based upon a finding that the conditions as set forth in N.J.S.A. 40A:12A-5 are found to be present.

RESOLUTION DESIGNATING THE "BIRCHWOOD AVENUE STUDY AREA," LOCATED AT BLOCK 291, LOT 15.01 AND BLOCK 292, LOT 2, AS A NON-CONDEMNATION AREA IN NEED OF REDEVELOPMENT

WHEREAS, by Resolution No. 2016-393, dated January 19, 2017, and pursuant to the Local Redevelopment and Housing Law, N.J.SA. 40A: 12A-l et seq. (the "Redevelopment Law"), the Township Committee of the Township of Cranford directed the Planning Board of the Township of Cranford to conduct a preliminary investigation and public hearing to determine whether all or part of the area known and designated on the Tax Map of the Township of Cranford as Block 291, Lot 15.01, and Block 292, Lot 2 (collectively the "Property") is an Area in Need of Redevelopment in accordance with N.J.S.A. 40A:12A-6; and

WHEREAS, the Planning Board, following an initial review of the proposed area for redevelopment, directed that a map be prepared depicting the boundaries of the Property, pursuant to N.J.S.A. 40A:12A-6(b)(l); and

WHEREAS, the firm of Maser Consulting submitted a report dated February 6, 2017 to the Planning Board entitled "Redevelopment/Rehabilitation Study Area Determination of Need, Birchwood Avenue Study Area" ("Preliminary Investigation"); and

WHEREAS, as required by N.J.S.A. 40A:12A-6, the Planning Board held a public hearing on April 20, 2017, to determine whether all of part of the Property is an area in need of redevelopment in accordance with the Redevelopment Law and thereupon, duly adopted a resolution recommending to the Township Committee of the Township of Cranford that the Property be designated as an area in need of redevelopment; and

WHEREAS, The Planning Board finds that conditions as set forth in N.J.S.A. 40A:12A-5 are found to be present at the Property; and

WHEREAS, following the public hearing of April 20, 2017, the Planning Board issued a Resolution dated April 20, 2017 recommending that the Township Committee of the Township of Cranford adopt a resolution designating the Property a Non-Condemnation Area in Need of Redevelopment; and

WHEREAS, the Township Committee has considered the recommendation of the Planning Board and the Preliminary Investigation; and

WHEREAS, the Preliminary Investigation and the recommendations of the Planning Board recommend the designation of the Property based on Criterion (c) N.J.S.A. 40A:12A-5; and

NOW, THEREFORE, BE IT RESOLVED, on this 25th day of April 2017:

- 1. The Township Committee evaluated the Preliminary Investigation of the Property and the testimony presented by Kristin J. Russell, the Planner from Maser Consulting, who prepared the Preliminary Investigation at its Official Meeting on April 25, 2017, in accordance with the requirements of N.J.S.A. 40A:12A-6.
- 2. The Township Committee considered the Planning Board's recommendation that the Property be designated a Non-Condemnation Area in Need of Redevelopment.
- 3. The Township Committee finds, consistent with the findings of the Planning Board, as follows:
 - a) The Property includes approximately 15.861 acres and consists of two (2) tax lots.
 - b) The Property is currently vacant.
 - c) Environmental studies indicate that portions of the Property contain marginally contaminated fill which would inhibit or increase the cost of redevelopment.
 - d) The Property condition meets Criterion "c" of N.J.S.A. 40A:12A-5 of the Redevelopment Law.
- 4. Accordingly based upon the property analysis in the Preliminary Investigation and the findings of the Planning Board, the entire Property meets the statutory criteria for redevelopment:

Block 291, Lot 15.01, and Block 292, Lot 2

- 5. Therefore, the Township Committee determines that the Property identified above, and highlighted on the map hereto affixed as Attachment A, should be and hereby are designated as a Non-Condemnation Area in Need of Redevelopment, as provided in N.J.S.A.40A:12A-5.
- 6. The Township Clerk shall forthwith transmit a copy of this resolution to the Commissioner of the Department of Community Affairs ("DCA"), in accordance with N.J.S.A. 40A:12A-6.
- 7. Within ten (10) days of the approval of this resolution by DCA, the Township Clerk shall further serve a notice of the determination of the Township Committee to designate the Birchwood Avenue Property as Non-Condemnation Area in Need of Redevelopment upon each person, if any, who filed a written objection thereto and supplied an address to which such notice can be sent.

<u>Kristen Russell, Planner with Maser Consulting</u>, presented information regarding the Birchwood Avenue property and the recommendation by the Planning Board that the property be designated as an area in need of redevelopment. Explained that the site is currently zoned for two-family dwellings which allows for multi-family housing and an affordable housing set aside, and discussed goals included in the Master Plan as respects residential uses. In addition, mentioned that development should be designed to minimize impacts on existing environmental features.

Ms. Russell also discussed environmental aspects of the property and explained that Maser Consulting used a Licensed Site Remediation Professional (LSRP) to determine the condition of the properties, in particular the soil. Discussed the 2015 study that was conducted which revealed there was fill-in debris present, which was most likely used to level the land at the original time of development. Discussed the Preliminary Assessment Report that was prepared by Maser's LSRP that qualified the site as an area in need of redevelopment. Explained that Maser's LSRP found it probable that the site was contaminated based on the prior use of fill. Discussed the site adjacent to the property that was also contaminated. In summary, Ms. Russell stated that it is her recommendation that the Township Committee qualify the Birchwood Avenue property as an area in need of redevelopment under criteria C.

Commissioner Comments:

<u>Commissioner Dooley</u> asked if the main location of the contamination is on the straddle line of the two properties, and requested clarification as to the impact of the contamination to the properties as a whole.

Ms. Monahan confirmed that Commissioner Dooley is correct as to the location of the contamination and explained that contamination of the property is not required for the entire site in order for the property to be declared as an area in need of redevelopment.

<u>Deputy Mayor Giblin</u> discussed the benefit of the designation of the property as an area in need of redevelopment because it would allow for the authorization of a Payment in Lieu of Taxes (PILOT) Program for the developer of the property.

Ms. Monahan confirmed that the developer would qualify for a PILOT Program if the Township Committee declares the property as an area in need of redevelopment. Explained that the designation does not impose an obligation of a PILOT Program on the Township, but it provides the Township with more options.

<u>Commissioner Kalnins</u> discussed the importance of designating the property as an area in need of redevelopment because of the additional options it provides to the Township. Asked Ms. Monahan to explain the process moving forward if the property is designated as an area in need of redevelopment.

Ms. Monahan explained that if the resolution designating the Birchwood Avenue property as an area in need of redevelopment is adopted tonight, it would be submitted to the Department of Community Affairs (DCA) in Trenton for review and approval. Once submitted to DCA, there is a thirty (30) day waiting period, and if there is no response after thirty (30) days, the designation is deemed to be acceptable. Also explained that there is a forty-five (45) day period for anyone objecting to the designation to submit a written objection. If no objections are received, the designation of the property would be non-appealable, and then the Planning Board would retain a planner to prepare a redevelopment plan, and a public hearing would be held. Also explained that redevelopment plans can be amended.

Ms. Monahan also discussed the Request for Proposals (RFP) the Township issued for a qualified developer to purchase and redevelop the property.

Mayor Hannen opened the public comments portion of the meeting and asked if there were any questions or comments.

<u>John Pritchard, 42-44 West Holly Street</u>, feels the Township needs to maintain its Police Department and Fire Department staffing levels. Also feels residents should always remember those who served our country and those who were lost during war. Sang a song in support of the military. Urged the Township Committee to request that legislators reactivate Muhlenberg Hospital and other hospitals in the area due to their proximity to Ground Zero.

Hearing no further comments, Mayor Hannen closed the public comment portion of the meeting.

PROFESSIONAL COMMENTS

Township Administrator Terence Wall

• Discussed the 2017 Municipal Budget and thanked Chief Financial Officer Patterson and all Department Managers for their efforts. Also expressed his appreciation for the Township Committee's support and assured residents that the budget would be tracked throughout the year to ensure that all funds are used wisely.

COMMISSIONER REPORTS/COMMENTS

Commissioner Mary O'Connor

- Thanked Brownie Troop No. 40772 for leading the flag salute;
- Thanked the Tree Advisory Board and the Environmental Commission for planning Arbor Day activities. Announced that the schedule was posted on her Facebook page and provided contact information for those interested volunteering;
- Announced that registration is open for the Velocity 5K race and provided information for those interested in registering. Also discussed events that would take place after the race, and that funds raised would be donated to community initiatives;
- Discussed the upcoming Cranford Family Weekend and the events to be held;
- Discussed her vote on the 2017 Municipal Budget. Feels redevelopment, a drug epidemic and pedestrian safety needs justify the maintenance of Police Department staffing levels. Discussed the Cranford Police Department's ranking of forty-nine (49) in public safety out of over five hundred and fifty (550) police departments in the State of New Jersey. Also stated that the Cranford Police Department was ranked in the top percent of New Jersey departments after last year's reaccreditation process. Also discussed the selection of Cranford as the best town in Union County to raise a family, and stated that public safety

was an important criterion in that selection. Stated that these rankings did not happen overnight or by accident, but are attributed to hard work by many people over the past three (3) years. Thanked Chief Financial Officer Patterson, Township Administrator Wall and all departments for their efforts with the budget, but urged the Township Committee to reconsider and provide funding for vacant positions within the Police Department. Discussed her appointment as Public Safety Commissioner from 2014 to 2016, and feels public safety personnel deserve all of the support that can be given to them;

- Discussed the Holocaust Day Remembrance service and provided information for those interested in attending. Stated that this event is sponsored by the Cranford Clergy Council, Cranford public schools, St. Michaels School and the Cranford Interfaith Relations Committee, and encouraged everyone to attend;
- Announced that she would be holding evening office hours on Tuesday, May 2, 2017 and welcomed the public to meet with her and to express any concerns they might have.

Commissioner Andis Kalnins

- Thanked Brownie Troop No. 40772 for leading the flag salute;
- Provided clarification of an article in the newspaper regarding tax refunds and explained that these refunds pertain to tax liens;
- Discussed the 2017 Municipal Budget and thanked Chief Financial Officer Patterson, Township Administrator Wall and all departments for their efforts. Extended a special thanks to Chief Financial Officer Patterson for her efforts in receiving State approval of the budget, and especially for the fact that no changes to the budget were required;
- Discussed the DMC's Strategic Plan which will be presented to the Township Committee during the May 8, 2017 Workshop Meeting. Suggested that residents attend the Workshop Meeting, but feels a presentation should also be scheduled for an Official Meeting.

Commissioner Ann Dooley

- Thanked Chief Financial Officer Patterson and Township Administrator Wall for their efforts with the 2017 Municipal Budget;
- Discussed the DMC Strategic Planning Subcommittee and explained that it is comprised of citizen professionals who have provided their expertise to the Township. Feels the strategic plan will benefit Cranford's downtown and contains excellent proposals that seem "eminently doable". Encouraged residents to attend the presentation scheduled for the May 8, 2017 Workshop Meeting;
- Discussed the User-Fee Based Residential Cleanup Program (bulky waste) and explained why it was necessary to reject the bid that was received. Informed residents that the Superintendent of Public Works is working with other municipalities in an effort to identify a potential shared services solution and the Township Committee would keep residents informed of any decisions that are made.

Deputy Mayor Patrick Giblin

- Discussed the Rahway River cleanup and thanked all volunteers. Also thanked the Chairman of the committee, Michael Scotti, and various captains for their efforts. Feels the event was a success;
- Thanked Chief Financial Officer Patterson for her efforts with the 2017 Municipal Budget;
- Thanked Tina Helmstetter for her efforts with the sapling planting program that was organized in conjunction with Arbor Day;
- Discussed the Street Smart Program, which focuses on pedestrian safety, and announced that it would begin on Monday, May 1, 2017. Also thanked Police Lieutenant Davenport for his efforts with this program;
- Announced that the Cranford Athletic Field is now operational, and stated that he had an opportunity to see his children play on the field. Feels it is commendable that half of the funds were raised through donations and thanked the Cranford Soccer Club, members of the Board of Education, and everyone else involved with the project. Feels it will be a tremendous asset to the community.

Mayor Thomas H. Hannen, Jr.

- Congratulated the Township Committee on the adoption of the 2017 Municipal Budget. Explained that the budget fell under the CAP which allows money to be reserved for future emergencies. Also discussed the issue of public safety and assured residents that all Township Committee members are concerned with public safety. Explained that no Police Department command units have been compromised in connection with the Township Committee's decision regarding staffing levels, and while it is unfortunate that a School Resource Officer was reassigned before the end of the school year, feels the overall staffing level provides the level of public safety necessary for the Township;
- Discussed Holocaust Remembrance Day and explained that the service is sponsored by the Cranford Clergy Council, Cranford Public Schools, Cranford Interfaith Human Relations Committee and St. Michaels School. Encouraged residents to attend the service;
- Announced that the Relay for Life event is scheduled for May 19, 2017 in conjunction with the American Cancer Society. Announced that a tribute would be made to individuals lost to cancer and encouraged residents to support the cause;

• Announced that May 1, 2017 is Melanoma Monday and encouraged residents to take proper precautions when exposed to the sun.
