MAYORAL REMARKS

Mayor Kathleen Miller Prunty thanked the residents and organizations for their assistance during and after the flood. She thanked the neighboring communities of Westfield and Roselle Park for sending volunteers. Mayor Miller Prunty also thanked the Cranford Police Department, Cranford Fire Department and the Cranford First Aid Squad for their extraordinary service to the community.

MAYORAL ANNOUNCEMENTS

Mayor Miller Prunty spoke about architectural services for the Home Elevation project. She stated that the Department of Public Works along with an outside contractor had started flood debris pick-up and would continue such debris pick-up until all of it had been collected. Mayor Miller Prunty stated Elizabethtown Gas had sent multiple crews to Cranford and were working on restoring hot water to residents. Mayor Miller Prunty stated that the FEMA had now designated Union County as a Disaster Area which would allow flood victims to be eligible for FEMA funding.

OFFICE OF EMERGENCY MANAGEMENT UPDATE

Emergency Management Coordinator Fire Lieutenant Matthew Lubin stated that the Township had reached out to the State Office of Emergency Management to offer the Cranford Community Center as a FEMA Disaster Recovery Center (DRC). He said FEMA would be setting up a Disaster Recovery Center (DRC) in Elizabeth which would be available to all Union County residents. He informed members of the public that the easiest way to apply for assistance through FEMA was via online at www.disasterassistance.gov. Fire Lieutenant Lubin then gave an update on the recent fire at the Conservation Center. He stated that Union County Hazardous Material (HAZMAT) personnel had conducted air quality monitoring.

CRANFORD POLICE DEPARTMENT UPDATE

Police Chief Ryan Greco began by recognizing the Department of Public Works for their hard work in the

aftermath of the storm. He stated that the decision was made to prioritize debris pick-up along school routes and units had been deployed to ensure that children safely navigate around the large garbage trucks. He also stated that there were fifty (50) to one hundred (100) abandoned vehicles on the street during and after Storm Ida. Chief Greco stated that the roads were now cleared of such cars.

INFORMAL MEETING

Mayor Miller Prunty opened the informal meeting portion of the meeting and asked if there were any questions or comments.

<u>Jim Carvalho, 9 Orange Avenue</u> – Mr. Carvalho stated that there were two (2) sets of Township Committee Meeting Minutes missing from the Township website. He stated that he believed the reason for the missing Minutes was due to deceptiveness and corruption on the part of Township Officials. A brief discussion ensued between Mr. Carvalho and Township Clerk Patricia Donahue.

Erik Hastrup, Superintendent, Cranford Department of Public Works (DPW) – Mr. Hastrup stated that DPW and an outside contractor, Messercola Excavating Inc. had been picking up flood debris since Friday, September 3, 2021. He provided descriptive maps that outlined each of the four (4) sections of the Township. Mr. Hastrup requested that residents refrain from putting out paint cans or tires. He stated that if residents have concerns about their street being missed by the debris pick-up vehicles, they should call DPW.

Hearing no further comments, Mayor Miller Prunty closed the informal meeting portion of the meeting.

WHEREAS, the Township of Cranford (the "Local Unit"), in the County of Union, New Jersey, has determined that there exists a need within the Local Unit to acquire, construct, renovate, install or refinance the Project which consists of Phase 2B of the storm drainage and flood management improvement projects (the "Project"), as further defined in each of that certain Loan Agreement (the "I-Bank Loan Agreement") to be entered into by and between the Local Unit and the New Jersey Infrastructure Bank (the "I-Bank") and that certain Loan Agreement (the "Fund Loan Agreement", and together with the I-Bank Loan Agreement, the "Loan Agreements") to be entered into by and between the Local Unit and the State of New Jersey, acting by and through the New Jersey Department of Environmental Protection (the "State"), all pursuant to the SFY 2022 New Jersey Water Bank Financing Program (the "Program"); and

WHEREAS, the Local Unit has determined to finance or refinance the acquisition, construction, renovation or installation of the Project with the proceeds of a loan to be made by each of the I-Bank (the "I-Bank Loan") and the State (the "Fund Loan", and together with the I-Bank Loan, the "Loans") pursuant to the I-Bank Loan Agreement and the Fund Loan Agreement, respectively; and

WHEREAS, to evidence the Loans, each of the I-Bank and the State require the Local Unit to authorize, execute, attest and deliver the Local Unit's I-Bank Loan General Improvement Bonds, Series 2021, to the I-Bank (the "I-Bank Loan Bond") and the Local Unit's Fund Loan General Improvement Bonds, Series 2021, to the State (the "Fund Loan Bond", and together with the I-Bank Loan Bond, the "Local Unit Bonds") in an aggregate principal amount not to exceed \$3,500,000, pursuant to the terms of the Local Bond Law of the State of New Jersey, constituting Chapter 2 of Title 40A of the New Jersey Statutes Annotated (the "Local Bond Law"), other applicable law and the Loan Agreements; and

PROJECTS IN, BY AND FOR THE TOWNSHIP OF CRANFORD, IN THE COUNTY OF UNION, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$3,500,000 TO PAY THE COST THEREOF, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS", which was finally adopted by the Township Committee at a meeting thereof duly called and held on July 12, 2016, at which time a quorum was present and acted throughout, all pursuant to the terms of the Local Bond Law and other applicable law.

Section 2. The Chief Financial Officer of the Local Unit (the "Chief Financial Officer") is hereby authorized to determine, in accordance with the Local Bond Law and pursuant to the terms and conditions established by the I-Bank and the State under the Loan Agreements and the terms and conditions hereof, the following items with respect to the I-Bank Loan Bond and the Fund Loan Bond:

- (a) The aggregate principal amount of the I-Bank Loan Bond and the Fund Loan Bond to be issued;
- (b) The maturity and annual principal installments of the Local Unit Bonds, which maturity shall not exceed thirty years;
- (c) The date of the Local Unit Bonds;
- (d) The interest rates of the Local Unit Bonds;
- (e) The purchase price for the Local Unit Bonds; and
- (f) The terms and conditions under which the Local Unit Bonds shall be subject to redemption prior to their stated maturities.

Section 3. Any determination made by the Chief Financial Officer pursuant to the terms hereof shall be conclusively evidenced by the execution and attestation of the Local Unit Bonds by the parties authorized under Section 4(c) hereof.

Section 4. The Township Committee hereby determines that certain terms of the Local Unit Bonds shall be as follows:

The law firm of Rogut McCarthy LLC (the "Local Unit's Bond Counsel") is hereby authorized to arrange for the printing of the Local Unit Bonds, which law firm may authorize McCarter & English, LLP, bond counsel to the I-Bank and the State for the Program, to arrange for same. The Township Auditor is hereby authorized to prepare the financial information necessary in connection with the issuance of the Local Unit Bonds. The Mayor, the Chief Financial Officer and the Township Clerk are hereby authorized to execute any certificates necessary or desirable in connection with the financial and other information.

Section 7. The Mayor and the Chief Financial Officer are severally authorized to execute any certificates or documents necessary or desirable in connection with the sale of the Local Unit Bonds and are further authorized to deliver same to the I-Bank and the State upon delivery of the Local Unit Bonds and the receipt of payment therefor in accordance with the Loan Agreements.

Section 8. This resolution shall take effect immediately.

Section 9. Upon the adoption hereof, the Township Clerk shall forward certified copies of this resolution to the Local Unit's Bond Counsel and to Richard T. Nolan, Esq., McCarter & English, LLP, bond counsel to the I-Bank.
