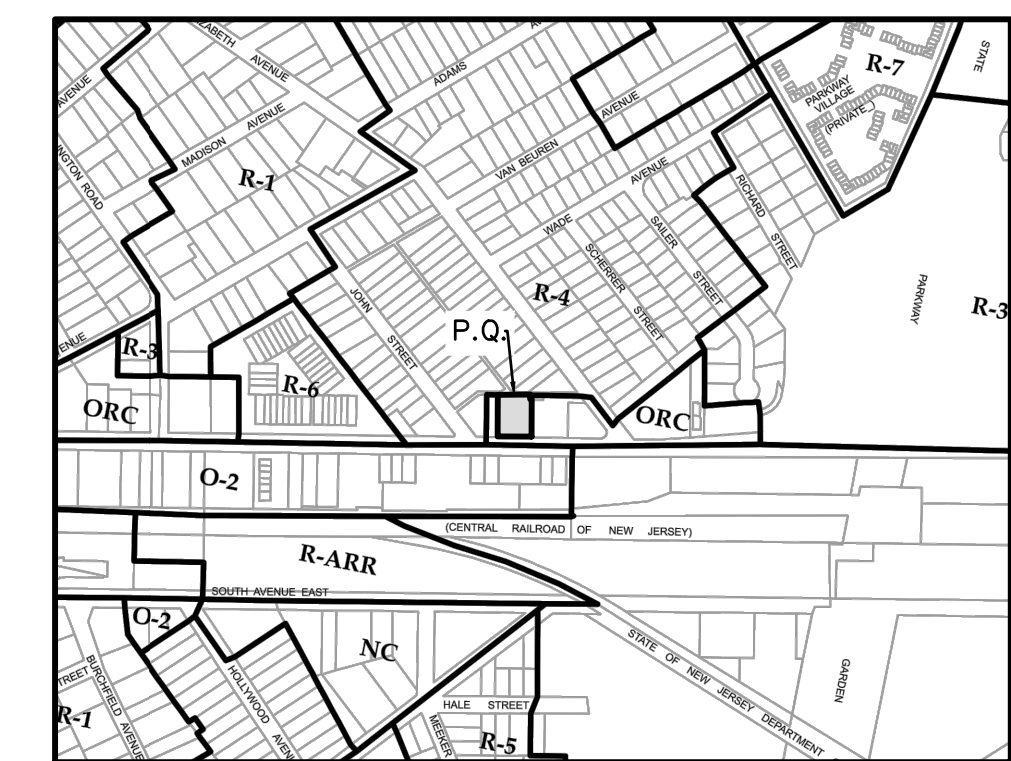

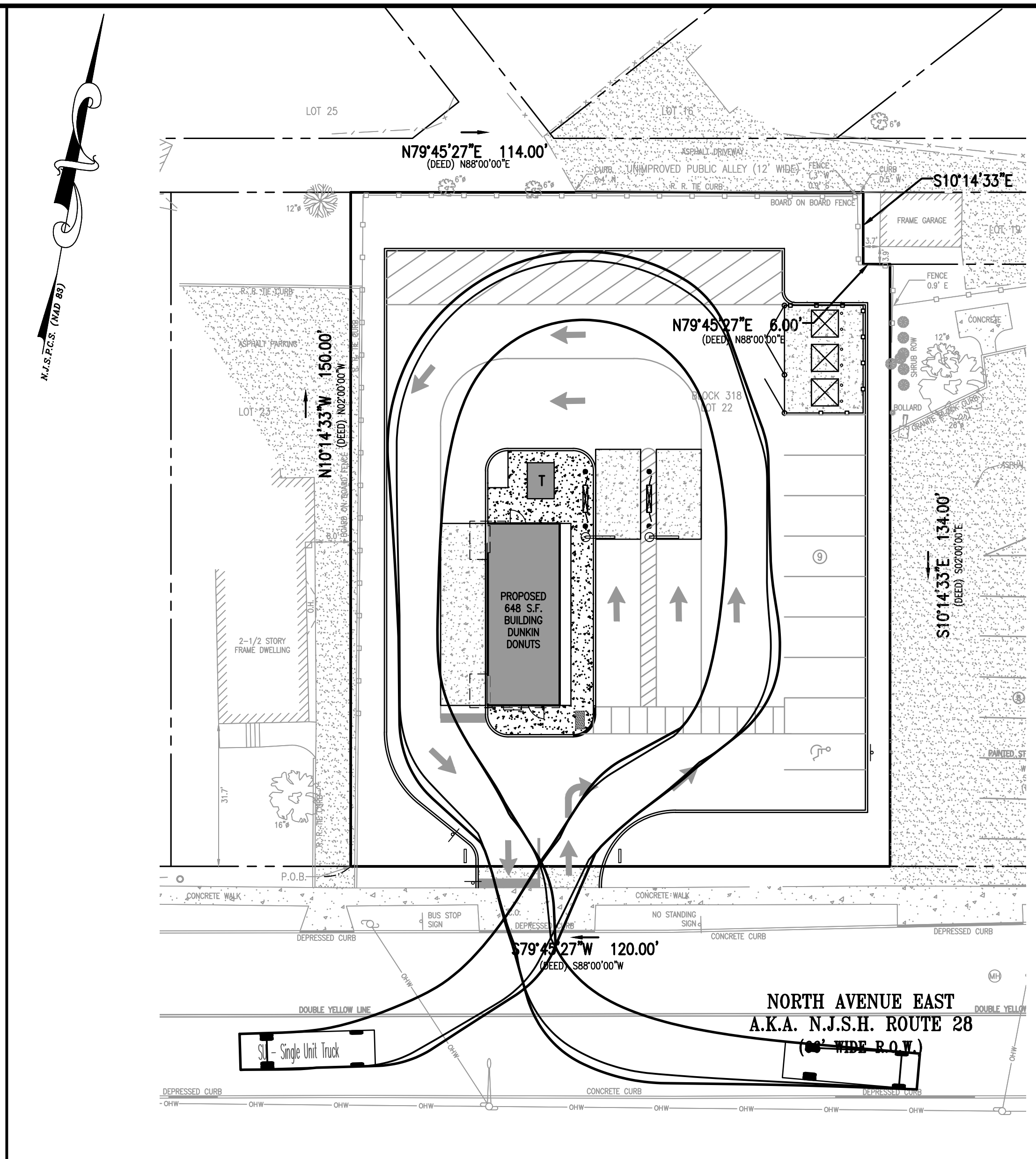

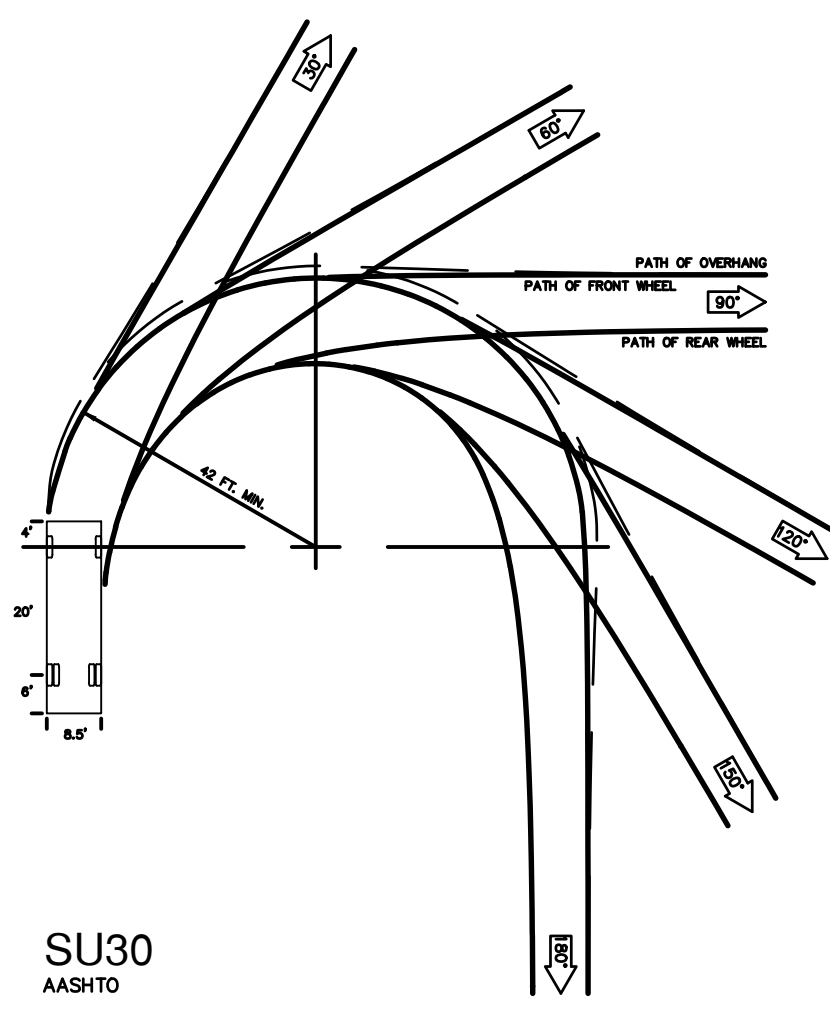
**EXISTING CONDITIONS & DEMOLITION PLAN**

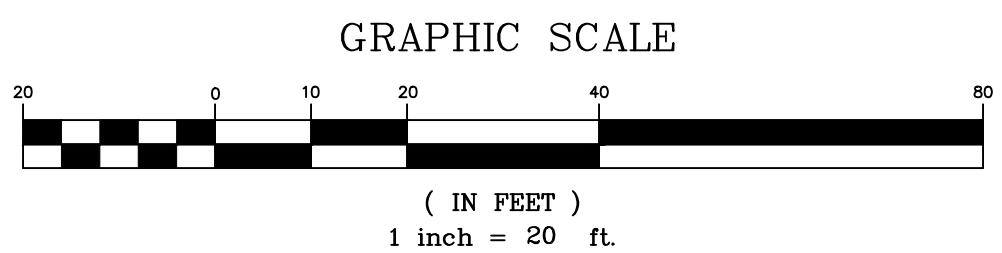
