**WHEREAS**, the annual municipal financial outlay to provide such health insurance coverage is very costly to the Township, with premiums becoming increasingly more expensive; and

**WHEREAS**, a Cranford Township employee may have other health insurance coverage through his/her spouse or civil union partner or otherwise; and

**WHEREAS**, pursuant to law, a local municipal employer is permitted to request a waiver by its employees of Township-provided health insurance coverage; and

**WHEREAS**, a municipality is permitted to allow its employees entitled to receive health insurance coverage to receive an incentive for waiving such coverage; and

WHEREAS, the Township of Cranford is desirous of authorizing such incentive;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Cranford, Union County, State of New Jersey, that for calendar year 2016 the Township will offer an incentive, in the prorated annual amount set forth below, to all employees who execute (or have executed) a form waiving all health insurance coverage for this year according to the following schedule:

Employee Coverage - 25 percent or \$5,000, whichever is less, of the amount saved by the Township, because of the employee's waiver of health insurance coverage. Employee and Child(ren) – 25 percent or \$5,000, whichever is less, of the amount saved by the Township, because of the employees waiver of health insurance coverage. Employee & Spouse/ Civil Union Partner - 25 percent or \$5,000, whichever is less, of the amount saved by the Township, because of the employee's waiver of health insurance coverage.

Family - 25 percent or \$5,000, whichever is less, of the amount saved by the Township, because of the employee's waiver of health insurance coverage.

Provided that the employee qualified for and was entitled to such coverage during the 2016 calendar year; and

**BE IT FURTHER RESOLVED** that the coverage waiver incentive amount shall be prorated based upon the date on which the waiver form is executed by each individual Township employee; and **BE IT FURTHER RESOLVED** that the dollar amount of the incentive to be paid to each such participating employee shall be distributed to the employee at the conclusion of calendar 2016; and **BE IT FURTHER RESOLVED** that any employee waiving health insurance coverage hereunder shall have the option to reinstate Township health insurance coverage in accordance with the requirements of the Township's Health Insurer and Plan(s) then in effect.

## Resolution No. 2015-08:

WHEREAS, alcohol and drug abuse effects many lives especially our youth; and

**WHEREAS**, the best way to combat the problem of alcohol and drug abuse is through prevention and educational programs; and

**WHEREAS**, the Cranford Municipal Alliance is dedicated to a comprehensive and coordinated effort to reduce and prevent alcohol and drug abuse in Cranford to make our town safe for all our citizens – especially our young people, and will include in its Safe Homes Project such dedicated efforts; and **WHEREAS**, the first prevention strategy involving the Safe Homes Project is "Zero Tolerance", meaning no alcohol use by underage youth will be tolerated; underage drinkers will be held accountable for their actions.

**WHEREAS**, the Township Committee of the Township of Cranford is aware that properties within the Township are delinquent on their property taxes; and

**WHEREAS**, the Township Committee of the Township of Cranford is further aware that properties within the Township are delinquent on their sewer charges; and

**WHEREAS**, N.J.S.A. 54:5-1 et seq., "The Tax Sale Law," permits a municipal official, pursuant to a resolution approved by the governing body, to hold a public auction for the sale of Tax Sale Certificates.

WHEREAS, N.J.S.A. 40A:26A-1 et seq., the "Municipal and County Sewerage Act," permits a municipal official, pursuant to a resolution approved by the governing body, to hold a public auction in the same manner as is provided for the sale of Tax Sale Certificates pursuant to N.J.S.A. 54:5-1 et seq. NOW, THEREFORE, BE IT RESOLVED, that the Township Committee of the Township of Cranford hereby authorizes the Township Tax Collector or her designee to hold a public auction for the sale of outstanding property debt and to convert all outstanding sewer charges into liens against properties with outstanding sewer charges and sell those liens at public auction prior to the end of Calendar Year 2016.

## Resolution No. 2015-16:

**WHEREAS**, the Township of Cranford has established a schedule of municipal charges for extraordinary services performed by the Township on private property; and

**WHEREAS**, the Township has billed the property owner in an attempt to collect these charges. **NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Cranford that the Tax Collector is hereby authorized to advertise these unpaid charges in the notice of tax sale, and as per state statute, convert the unpaid charges to municipal liens to be sold at the annual tax sale as a municipal lien against the property enforceable in accordance with NJSA 54:5 et. seq.

RESOLUTION INCREASING BID THRESHOLD AND APPOINTING A QUALIFIED PURCHASING AGENT, PURSUANT TO N.J.S.A. 40A:11-3a AND N.J.A.C. 5:34-5 ET. SEQ.

**WHEREAS**, the Local Public Contracts Law provides local contracting units with the ability to increase their bid threshold up to \$40,000.00; and

**WHEREAS**, N.J.S.A. 40A:11-3a, permits an increase in the bid threshold if a Qualified Purchasing Agent is appointed, as well as grants the authorization to negotiate and award such contracts below the bid threshold; and

**WHEREAS**, N.J.A.C. 5:34-5 et seq. establishes the criteria for qualifying as a Qualified Purchasing Agent; and

WHEREAS, Jennifer Burns possesses the designation of Qualified Purchasing Agent as issued by the Director of the Division of Local Government Services in accordance with N.J.A.C. 5:34-5 et. seq.; and WHEREAS, the Township of Cranford desires to take advantage of an increased bid threshold; NOW THEREFORE BE IT RESOLVED, that the Township Committee of the Township of Cranford, Union County, State of New Jersey hereby increases its bid threshold to \$40,000.00; and BE IT FURTHER RESOLVED, that the Township Committee of the Township of Cranford, Union County, State of New Jersey hereby appoints Jennifer Burns as the Qualified Purchasing Agent to exercise the duties of a purchasing agent pursuant to N.J.S.A. 40A:11-2(30) with specific relevance to the authority, responsibility, and accountability of the purchasing activity of the Township of Cranford.

# I. STATEMENT OF PURPOSE

This Cash Management Plan (the "Plan") is prepared pursuant to the provisions of N.J.S.A. 40A:5-14 in order to set forth the basis for the deposits ("Deposits") and investment ("Permitted Investments") of certain public funds of the Township of Cranford, pending the use of such funds for the intended purposes. The Plan is intended to assure that all public funds identified herein are deposited in interest bearing Deposits or otherwise invested in Permitted Investments hereinafter referred to. The intent of the Plan is to provide that the decisions made with regard to the Deposits and the Permitted Investments will be done to insure the safety, the liquidity (regarding its availability for the intended purposes), and the maximum investment return within such limits. The Plan is intended to insure that any Deposit or Permitted Investment matures within the time period that approximates the prospective need for the funds deposited or invested so that there is not a risk to the market value of such Deposits or Permitted Investments.

## II. IDENTIFICATION OF FUNDS AND ACCOUNTS TO BE COVERED BY THE PLAN

The Plan is intended to cover the deposit and/or investment of the following funds and accounts of the Township of Cranford.

1. Current Fund	6. General Capital Fund
2. Trust Assessment Fund	7. Swim Pool Operating Fund
3. Trust Fund	8. Swim Pool Capital Fund
4. SID/DMC Fund	9. COAH
5. Dog Trust Fund	10. CDBG Block Grant

# III. DESIGNATION OF OFFICIALS OF THE TOWNSHIP OF CRANFORD AUTHORIZED TO MAKE DEPOSITS AND INVESTMENTS UNDER THE PLAN

The Chief Financial Officer of the Township of Cranford [and the Treasurer] (the "Designated Official") is hereby authorized and directed to deposit and/or invest the funds referred to in the Plan.

#### IV. DESIGNATION OF DEPOSITORIES

The following banks and financial institutions are hereby designated as official depositories for the Deposit of all public funds referred to in the Plan, including any Certificates of Deposit which are not otherwise invested in Permitted Investments as provided for in this Plan:

All New Jersey Banks that provide a certificate of eligibility. Depositories for 2013 are Two River Community Bank, TD Bank and Sovereign Bank.

A "Certificate of Eligibility" is the certification issued by the New Jersey Department of Banking, Division of Banking, that a public depository if eligible to act as a depository for public funds and qualifies as a participant in the New Jersey Governmental Unit Depository Protection Act (GUPA). The Township of Cranford shall designate said depositories by resolution of the governing body each year in accordance with N.J.S.A. 40A:5-15.1.

# V. AUTHORIZED INVESTMENTS

- A. Except as otherwise specifically provided for herein, the Designated Official is hereby authorized to invest the public funds covered by this Plan, to the extent not otherwise held in Deposits, in the following Permitted Investments:
  - (1) Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America;
  - (2) Government money market mutual funds;
  - (3) Any obligation that a federal agency or a federal instrumentality has issued in accordance with an act of Congress, which security has a maturity date not greater than 397 days from the date of the purchase, provided that such obligation bears a fixed rate of interest not dependent on any index or other external factor;
  - (4) Bonds or other obligations of the Local Unit or bonds or other obligations of school districts of which the Local Unit is a part or within which the school district is located;
  - (5) Bonds or other obligations, having a maturity date not more than 397 days from the date of purchase, approved by the Division of Investment of the Department of the Treasury for investment by Local Units;
  - (6) Local government investment pools;
  - (7) Deposits with the State of New Jersey Cash Management Fund established pursuant to section I of P.L. 1977, c. 281 (C.52:18A-90.4); or
  - (8) Agreements for the repurchase of fully collateralized securities if:
    - (a) the underlying securities are permitted investments pursuant to paragraphs (1) and (3) of this subsection a;
    - (b) the custody of collateral is transferred to a third party;
    - (c) the maturity of the agreement is not more than 30 days;

(d) the underlying securities are purchased through a public depository as defined in section I of P.L. 1970, c.236 (C.17:9-41); and

(e) a master repurchase agreement providing for the custody and security of collateral is executed.

For purposes of the above language, the terms "government money market mutual fund" and "local government investment pool" shall have the following definitions:

## Government Money Market Mutual Fund. An investment company or investment trust:

- (a) which is registered with the Securities and Exchange Commission under the "Investment Company. Act of 1940," 15 U.S.C. sec. 80a-l et seq., and operated in accordance with 17 C.F.R. sec. 270.2a-7.
- (b) the portfolio of which is limited to U.S. Government securities that meet the definition of any eligible security pursuant to 17 C.F.R. sec. 270.2a-7 and repurchase agreements that are collateralized by such U.S. Government securities; and
- (c) which has:
  - (i) attained the highest ranking or the highest letter and numerical rating of a nationally recognized statistical rating organization; or
  - (ii) retained an investment advisor registered or exempt from registration with the Securities and Exchange Commission pursuant to the "Investment Advisors Act of 1940," 15 U.S.C. sec. 80b-1 et seq., with experience investing in U.S. Government securities for at least the most recent past 60 months and with assets under management in excess of \$500 million.

# <u>Local Government Investment Pool.</u> An investment pool:

- (a) which is managed in accordance with 17 C.F.R. sec. 270.2a-7;
- (b) which is rated in the highest category by a nationally recognized statistical rating organization;
- (c) which is limited to .U.S. Government securities that meet the definition of an eligible security pursuant to 17 C.F.R. sec. 270.2a-7 and repurchase agreements that are collateralized by such U.S. Government securities;
- (d) which is in compliance with rules adopted pursuant to the "Administrative Procedure Act," P.L. 1968, C.410 (c.52:14B-l et seq.) by the Local Finance Board of the Division of Local Government Services in the Department of Community Affairs, which rules shall provide for disclosure and reporting requirements, and other provisions deemed necessary by the board to provide for the safety, liquidity and yield of the investments;
- (e) which does not permit investments in instruments that: are subject to high price volatility with changing market conditions; cannot reasonably be expected, at the time of interest rate adjustment, to have a market value that approximates their par value; or utilize an index that does not support a stable net asset value; and
- which purchases and redeems investments directly from the issuer, government money market mutual fund, or the State of New Jersey Cash Management Fund, or through the use of a national or State bank located within this State, or through a broker-dealer which, at the time of purchase or redemption, has been registered continuously for a period of at least two years pursuant to section 9 of P.L. 1967 c.9 (C.49.3-56) and has at least \$25 million in capital stock (or equivalent capitalization if not a corporation), surplus reserves for contingencies and undivided profits, or through a securities dealer who makes primary markets in U.S. Government securities and reports daily to the Federal Reserve Bank of New York its position in and borrowing on such U.S. Government securities.

# VI. SAFEKEEPING CUSTODY PAYMENT AND ACKNOWLEDGMENT OF RECEIPT OF **PLAN**

To the extent that any Deposit or Permitted Investment involves a document or security which is not physically held by the Township of Cranford, then such instrument or security shall be covered by a custodial agreement--with an independent third party, which shall be a bank or financial institution in the State of New Jersey. Such institution shall provide for the designation of such investments in the name of the Township of Cranford to assure that there is no unauthorized use of the funds or the Permitted Investments or Deposits. Purchase of any Permitted Investments that involve securities shall be executed by a "delivery versus payment" method to insure that such Permitted Investments are either received by the Township of Cranford or by a third party custodian prior to or upon the release of the Township's funds.

To assure that all parties with whom the Township of Cranford deals either by way of Deposits or Permitted Investments are aware of the authority and the limits set forth in this Plan, all such parties shall be supplied with a copy of this Plan in writing and all such parties shall acknowledge the receipt of that Plan in writing, a copy of which shall be on file with the Designated Official(s).

# VII. REPORTING REQUIREMENTS

The Designated Official(s) referred to in Section III hereof shall submit to the governing body of the Township of Cranford a monthly written report of any Deposits or Permitted Investments made pursuant to this Plan, which shall include, at a minimum, the following information:

- A. The name of any institution holding funds of the Township of Cranford as a Deposit or a Permitted Investment.
- B. The amount of securities or Deposits purchased or sold during the immediately preceding month.
- C. The class or type of securities purchased or Deposits made.
- D. The book value of such Deposits or Permitted Investments.
- E. The earned income on such Deposits or Permitted Investments. To the extent that such amounts are actually earned at maturity, this report shall provide an accrual of such earnings during the immediately preceding month.
- F. The fees incurred to undertake such Deposits or Permitted Investments.
- G. The market value of all Deposits or Permitted Investments as of the end of the immediately preceding month.
- H. All other information which may be deemed reasonable from time to time by the governing body of the Township of Cranford.

# VIII. TERM OF PLAN

Attached to this Plan is a resolution of the governing body of the Township of Cranford approving this Plan for such period of time. The Plan may be amended from time to time. To the extent that any amendment is adopted by the Township Committee of the Township of Cranford, the Designated Official is directed to supply copies of the amendments to all of the parties who otherwise have received the copy of the originally approved Plan, which amendment shall be acknowledged in writing in the same manner as the original Plan was so acknowledged.

Good Evening. Thank you Pastor Rice, Mayor Fulop, Assemblyman Bramnick and Assemblywoman Munoz. It is a pleasure to see my friends Freeholder Kowalski, and Freeholder Mirabella here tonight also. (Asks for them to please stand) I think I also saw FMBA President Ed Donnelly in the audience.

Honored guests, ladies and gentlemen, it was an honor to have Mayor Fulop with us this evening. I am impressed with Mayor Fulop's tenure in Jersey City. His new ideas and the vitality he has brought to municipal government has been an inspiration. I look forward to working with him to tackle the challenges that face working families in Cranford and throughout New Jersey.

Three short years ago, I was elected to the Township Committee for my first term As I start the beginning of my second term, I am equally honored and grateful for the opportunity to serve the residents of

## Cranford once again.

I would like to thank my wife Cindy and my sons Tom and Dan, and my daughters Katie and Erin. As all of the members of this Township Committee will attest, the time away from one's family in running for office, preparing for meetings and carrying out the duties of our offices, is all time spent away from the ones we love and cherish, especially my patient, sainted wife. She has become adept at having control of the TV remote while I'm out. We serve at the pleasure of the people who elect us, but with the advice and consent of our spouses and families. I am additionally blessed to have with me tonight, my Mom. Mom is always there, watching our meetings asking me questions about what is going on, and lending a consoling ear when I'm frustrated. Thank you Mom.

When I was first elected, our Police and Fire Departments were at seriously low levels of manpower. Removing boots on the street to do administrative duties, especially dispatching, was a common occurrence. Exceeding budgeted overtime trying to handle Emergency Medical Services hampered efficient use of Fire Department manpower. Both of those departments have been brought up to appropriate staffing levels and allows the Township Committee to focus on other pressing issues in our community.

Our job is to continue to strive to keep Cranford affordable for our senior residents. The drain of senior talent in our community to more affordable towns, impacts the wealth of knowledge and commitment to keep Cranford a multigenerational strong community. Affordable housing for seniors looking to retire, while keeping ties to the community in which they raised their children and made Cranford a better place, should be a priority. Services for seniors are as important as services for other segments of the community if we wish to keep these valuable members of our community engaged in Cranford's future. A new senior bus, to replace the one in which we continue to spend thousands of dollars on repairs, should be a priority for this year's Capital budget.

Our downtown should also become a priority this year. Enhancing opportunities for businesses to locate and thrive in our downtown should be a major focus of the Township Committee. We are under pressure from neighboring community's growth in retail opportunities. To that end, next year's holiday season parking plan should make ALL areas of downtown available for free 3 hour parking, and not just the municipal lots that parking fees were waived in this year. The confusion that this caused to shoppers, and the tickets that were issued this year only continues to push shoppers down Walnut Avenue to the new mall in Clark and other towns that make parking free for the holiday season. A comprehensive plan for the development of North Avenue, to repeat the success of the businesses on South Avenue, I hope will show the Township Committee's focus on the downtown business district. As property values increase in the business district, it relieves pressure on residential property taxes.

Our pool complex will be getting an upgrade this year. This renews our commitment to provide safe recreational facilities and opportunities for our residents. I hope we continue our work on upgrading our parks and field sports facilities in the coming year. The Township's ability to combine County Kids Recreation Trust Funds with our own efforts to improve the safety and use of these fields benefits all of us.

Congratulations to the various sports teams that have excelled over the past year. Cranford's young athletes continue to make us proud of their efforts and dedication and the community spirit that continues to grow while watching the results of their hard work.

We have many exciting opportunities in Cranford this year. We have many assets as a community. Sports, recreation, a downtown waiting to be rediscovered, and transportation systems in New Jersey, transit rail and bus lines which all enhance our attractiveness as a community. All of these provide the backdrop for the most important asset of our community, its citizens. The many volunteer efforts by people in scouting, first aid, PAL, CBSL, soccer, lacrosse, church volunteer groups for the CROP walk, various charities, and the hosting of the homeless, the Jay-cees and all the others, continue to make Cranford a very special place. # **Commissioner Robert D'Ambola**

I would like to take the next 2 hours telling you what a great job we have done... I will not do for two reasons- 1, you will all hurt me, and 2, I would be lying.

There are over 175 municipal employees that are standing behind us that did a great job. That doesn't include the numerous legal, financial, engineering and health department firms along with hundreds of Cranford volunteers serving on numerous committees. With their assistance, they make us look good and they make it look easy to sit up here. Cranford residents are lucky to have this entire team to make this town the great place it is.

The Members of the Township Committee are just visitors passing through. Sure we get a handsome salary that comes to about .25 per hour, but hey someone has to get the perks. Our job is to provide direction. We are similar to the rulers of Spain back in 1492. We collect money from the residents and give it to Christopher Columbus who is represented by our Administrator. We tell him to go find a new world, keep it under budget and do it as fast as you can, with less people and less money than he needs to accomplish this goal. The only words of advice we provide is - watch out for the edge. We leave out the part about tidal waves, angry whales, and pirates that may severely impact their journey. We stand at the shore and bid him a bon voyage.

He steers the ship while his professional crew of department heads manage the day-to-day duties of the mission. The Department heads oversee their own respective crews that manage their respective part of the ship. It's a long tough trip but they always do a great job.

If you don't already know it, Cranford has excellent emergency services comprised of police, fire, and EMS. For the past two years I have had the privilege of working with what I call the invisible emergency service, which is the Department of Public Works. They also work outside, in every type of weather, sometimes at night or on weekends. They were working this Thanksgiving due to a major water main break. I call them invisible because they just show up whenever needed, without lights and sirens.

I often tell the story at the police academy about the lifeguard that spots a drowning boy way out in the ocean. Without hesitation he jumps into the frigid water and swims with all his might against the current. He latches on to the boy and fights his way back to shore. He breathes life back into the boy and then rolls over exhausted. The boy's grandmother comes up and stands over the panting lifeguard and says, "He had a hat."

I used this story to express to police recruits that whatever you do is never enough. It wasn't until I sat on the Township Committee did I understand that I was missing the real point of the story; and that is, you should always try to do more, no matter how hard it is, and not expect a thank you. If you do receive one, then that's just icing on the cake.

Every member of Cranford Township should do everything in their power to get to the results of a problem or a question. Sometimes the result is not what you were looking for, but the public should be satisfied that the result was arrived at after all options were explored and without bias. It is the public's

job to hold the Township to this standard. We didn't take this job to make friends or make people happy. We took this job to make Cranford a better place. We are getting better at this but there is always room for improvement.

Steve Jobs said, "The only way to do great work is to love what you do. If you haven't found it yet, keep looking. Don't settle."

I had a great time as Commissioner and learned something new every day. I would like to thank all of those people that I had the pleasure of working with and for. I thank you for the extreme privilege to sit here.

And we continue to fight against the Birchwood project. # Mayor Andis Kalnins

Happy New Year to everyone! I would like to thank everyone for being here today, especially Senior Pastor Rice. Thank you for your inspiring words and all of your work with the Cranford Clergy Council and the other organizations in town. I would also like to thank Assemblyman Bramnick and Assemblywoman Muñoz for participating in the swearing in ceremonies. They have all been very good friends to Cranford and support us at every turn. Thank you also to Mayor Fulop for participating in the swearing in ceremonies, and to Freeholders Kowalski and Mirabella for attending our reorganization meeting. We appreciate all of the support from Union County on our flood projects, parks and other various projects. We have several former commissioners here and many people from the public. This meeting each year is the most important as we start the New Year and the new direction of Cranford in 2016.

I am excited to have the opportunity to serve the people of Cranford for another year and especially to serve my 3rd term as Mayor. I believe that the consistency of the last couple of years have allowed us to achieve some significant accomplishments and I believe that the stability that this type of continuity will bring will allow us to hit the ground running in 2016 and to continue the work that we have started. We have put good people in place on the professional staff, we have built controls that will keep our government running more efficiently and at the same time we have started to reengage the government working with the public and responding to their needs. We have modified the hours of several of our departments to be more available to the public, who, after all, are our customers. We have updated our website to make it easier for people to get the information they need and we will work in 2016 to add additional functionality to the website so people can have access to the services they need on a 24x7 basis, as that is what people expect in today's world.

We will continue the progress of additional engagement with the Police and Fire Departments and the township staff working with the citizens and business communities.

We will continue the focus on rebuilding our roads and infrastructure. This is a problem that was decades in the making, and although we have made great strides over the last couple of years, we still have a lot of work to do. We will be able to do this by adhering to a financial plan that balances the work that needs to be done with the financial costs.

We have made some great strides in the downtown. We have several new buildings that are all fully occupied, both with residents and businesses. But we still have some buildings that are in desperate need of renovation. We have updated the zoning regulations to provide a good standard for the revitalization of the downtown buildings. We will continue to work toward getting some of the dilapidated buildings rebuilt and focus on the process of getting new businesses into the empty spaces as quickly as possible, by getting government out of the way.

We have rewritten the property maintenance codes to consolidate and simplify them. We have seen some good success with many of the properties that have been eyesores now being better maintained. We need to keep that focus on those properties, and make sure that they continue the maintenance or, better yet, get them out of the bank process and to people who want to live in Cranford and maintain their own homes.

We will also continue to work with the Mayors Council on Rahway River to insure that our project stays in the spotlight and that it continues to move forward through the Army Corps of Engineers process to finish the study so that we can get Congressional funding to build the project. I will be going down to Washington on January 26th to keep the focus on the importance of our project in Congress and to keep it moving as we go from the study to fighting to get the project funded for Construction. But while we push that project, we will continue to do what we can locally to maintain the river and finish the storm water management projects that have been on the books for over a decade. We have funded the engineering of the Orchard Brook Project last year, and have started the work with the DEP

and the preliminary engineer work. We have submitted the Phase IIB flood control project, on the North side of the river, for State funding, and we have applied for a grant to fund the Phase III, on the South side of the river, of the local flood control project.

And we have done all of this while keeping a continuing emphasis on keeping taxes down by balancing what we need and those services that we want. We have seen at least on a Municipal level some of the lowest tax increases over the last two years. We will continue to emphasize fiscal responsibility as we build the 2016 budget.

Lastly, I would like to thank my family who has given so much for me to be here. Without their support of letting me out night after night, weekend event after weekend event, and all of the times in between, I could not be here or be effective.
