Mayor Kalnins opened the public comments portion of the meeting and asked if there were any questions or comments. Hearing no comments, Mayor Kalnins closed the public comment portion of the meeting.

Review Official Meeting Agenda

Resolution No. 2016-140:

Township Attorney Dabulas informed the Township Committee that Resolution No. 2016-140, which authorizes the Township to enter into an agreement with Serv Behavioral Health System, Inc. for the expenditure of affordable housing trust funds, was removed from the agenda. Explained that the Township must formally approve a spending plan before Resolution No. 2016-140 can be adopted.

Late Starter – Parking Committee Recommendation

Deputy Mayor O'Connor discussed the Parking Committee's proposal for the addition of spaces and metered parking on South Avenue. Explained that determining the number of additional spaces at this time is difficult. Also explained that an ordinance already exists to allow for metered parking in that area. Feels safety issues would be addressed by striping the area for parking spaces.

Commissioner Hannen stated that he is not opposed to marking the area for spaces but does not agree with them being metered.

Deputy Mayor O'Connor feels the Township Committee should stripe the area and add meters as recommended by the Parking Committee.

The majority of the Township Committee was agreeable to striping for parking spaces and to including meters.

Salary step program

Township Administrator Wall discussed the proposed timeframe for the authorization of step increases for non-union employees. Also suggested a two (2%) percent cost of living adjustment for those employees who have reached the top step.
