RESOLUTION AUTHORIZING CONTRACT CHANGE ORDER FOR ADDITIONAL ROADWAY IMPROVEMENTS FOR THE 2015 PAVING PROJECT REGARDING THE RECONSTRUCTION OF CURB, SIDEWALK, MILLING AND PAVING OF ORANGE AVENUE (CRAIG PLACE TO MUNICIPAL BORDER), FOR THE TOWNSHIP OF CRANFORD, UNION COUNTY, NEW JERSEY

WHEREAS, Mark Paving Co. Inc., 77 Cutters Dock Road, Woodbridge, NJ 07095 was previously awarded a construction contract for the 2015 Paving Project with a total project price of \$2,378,830.90; and

WHEREAS, the project is currently on-going and it is understood that the Township of Cranford would like to expedite the paving of Orange Avenue from Craig Place to the Municipal Border;

WHEREAS, the Township Engineer has reviewed the request and prepared an Engineering Review Memorandum dated July 21, 2016 which outlines the estimated additional construction costs for said improvements to Orange Avenue in the amount of \$451,500.00;

- WHEREAS, the following summarizes the allocation of the \$451,500.00 Change Order:
 - Utilize the existing encumbered remaining funds of Purchase Order 15-03504: \$163,500.00
 - Utilize the available funding from Bond Ordinance O-15-24: \$246,867.26
 - Utilize available funding from Bond Ordinance O-16-12: \$41,132.74

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available within the current and/or previously adopted budget for said purpose.

NOW THEREFORE BE IT RESOLVED, by the Township Council of the Township of Cranford, Union County, New Jersey that the above referenced Change Order for the 2015 Paving Project is awarded to Mark Paving Co. Inc., 77 Cutters Dock Road, Woodbridge, NJ 07095 in the amount of \$451,500.00 (18.98% of the original contract amount of \$2,378,930.90).

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately.
