Discussion was held as to the potential reduction of a request for playground improvements and reallocating those funds to road resurfacing.

Commissioner O'Connor feels that if the Township Committee reduces funding for certain projects, she prefers to reduce the total budget to reduce debt rather than reallocating to road resurfacing.

Discussion held regarding the Police Department request for Zodiak Boat.

Township Committee agreeable to reducing park improvements by \$100,000 for a total Capital Budget of \$3,743,500.
