Review Official Meeting Agenda

Mayor Giblin stated that the resolution pertaining to the cancellation of general capital fund receivable balances (Resolution No. 2019-359) should be moved from a roll call vote to the consent agenda. Commissioner Hannen noted that he spoke to Fire Lieutenant Matt Lubin and Police Lieutenant Ed Davenport regarding generators. He learned that that Police could always use generators. Commissioner O'Connor spoke about the resolution noting that the original ordinance pertained to \$140,000 in grant money but the Township only received \$100,000 and elaborated. Commissioner O'Connor noted that CFO Lavona Patterson stated that the Finance Department would work with any department who needed a generator to obtaining the needed funding. Discussion ensued.

Mayor Giblin opened the public comments portion of the meeting and asked if there were any questions or comments. Hearing no comments, Mayor Giblin closed the public comment portion of the meeting.

Crown Castle's Proposed Upgrades to the 10 (ten) existing DAS node facilities

Mr. Peter Broy and Mr. Deividas Kavaliauskas of Crown Castle were present.

Mr. Jason Bottcher, Township Zoning Officer, was present.

Mr. Broy and Mr. Kavaliauskas presented Crown Castle's request to upgrade 10 (ten) existing Distributed Antenna Systems (DAS) located throughout the Township. They noted that 9 (nine) of the DAS' were on Cranford roads and 1 (one) DAS was on a County road. Township Attorney Ryan Cooper noted that per Township Code, this matter would be decided by the Zoning Officer, not the Township Committee. Mr. Broy and Mr. Kavaliauskas noted that they were present to answer any questions the Committee had. Discussion ensued regarding proposed dimensions, antennas, annual fees and one-time fees, how this proposal related to 5G and cell towers, installation, safety issues, work schedule and relation to Verizon fees.
