Public Comments

Mayor Giblin opened the public comments portion of the meeting and asked if there were any questions or comments. Hearing no comments, Mayor Giblin closed the public comment portion of the meeting.

<u>Late Starter – 2020 Professional Services</u>

Township Clerk Patricia Donahue handed out bid summary sheets for 2020 Professional Services Request for Proposals (RFPs) and Requests for Qualifications (RFQs) received on Friday, November 22nd. A brief discussion ensued. Committee consensus was reached to place the 2020 Professional Services matter on the December Township Committee meeting agendas.

Review Official Meeting Agenda

Commissioner Hannen asked a follow-up question regarding the proposed Birchwood PILOT ordinance (Ordinance No. 2019-14.)

Mayor Giblin noted that a third proclamation, pertaining to Thanksgiving, had been added to the agenda.

Vacation Carry Over

Administrator Jamie Cryan stated that the vacation carry-over matter was not codified. Mr. Cryan suggested that the Committee consider employee vacation carry-over time as they did in 2018, i.e., the December Township Committee meeting would include a proposed resolution with wording which would allow employees to carry over 5 (five) days of vacation time into 2020, to be used by June 30, 2020. Mr. Cryan stated that the backup for the proposed agenda topic would include employees' request for number of days to be carried over into 2020.

2020 Township Committee Meeting Schedule

Mayor Giblin spoke about the proposed 2020 Township Committee Meeting Schedule which had been distributed earlier that day.
