PUBLIC COMMENTS

Mayor Kalnins opened the public comments portion of the meeting and asked if there were any questions or comments.

Rosemarie Saladino, 24 Hillside Place, discussed the handicap access/curb cut next to the Garlic Rose. Explained that her husband has a handicap and must use a wheelchair and the curb cut by the Garlic Rose has a lip that is difficult to get the wheelchair over. Requested that it be repaired.

Mayor Kalnins assured Ms. Saladino that the matter would be addressed.

<u>Frank Krause, 20 Pittsfield Street</u>, congratulated Deputy Mayor O'Connor and Commissioner Bilger on their appointments and extended his best wishes. Discussed the "Greenway" entrance into Cranford on North Avenue. Also discussed signage in the downtown. Discussed recent development on North Avenue West and requested clarification as to how it was approved and if the appropriate protocol was followed concerning its approval.

Mayor Kalnins informed Dr. Krause that he contacted the Chairman of the Zoning Board who confirmed that it was approved by the Zoning Board at a public meeting. Stated that he agrees with Dr. Krause and feels the development is not appropriate.

Dr. Krause discussed his concern with the potential consequences of that development being approved. Feels the character of the neighborhood will change and it will contribute to an increase in traffic. Also expressed doubt as to whether the applicant filed for approval with the New Jersey State Highway Access Management Code. Requested the Township Committee review this issue.

Michael Petrucci, 437 Brookside Place, Candidate for Township Committee, congratulated Deputy Mayor O'Connor and Commissioner Bilger on their appointments. Informed the Township Committee that while campaigning he received positive feedback from residents, but residents are also seeking updates on certain issues, such as Union County College's proposed sports field. Stated that residents in that area are concerned with the noise, traffic and after game celebrations that would occur if a field is built on the Cranford campus. Requested input from the Township Committee as to its position on the matter.

Mayor Kalnins stated that the Township Committee opposes construction of the field at the Cranford campus. Discussed the Union County Board of Chosen Freeholder's (Freeholder Board) offer to allow construction of the field at Oak Ridge Park and expressed concern with the lack of progress concerning this matter.

Deputy Mayor O'Connor discussed her opposition to the field at the Cranford campus and suggested the Township Committee consider adoption of a secondary resolution to further clarify the Township Committee's position on this issue.

Mayor Kalnins discussed the Township Committee's efforts to address this matter.

Commissioner Hannen informed residents that he has gone before the Freeholder Board with Cranford residents to officially declare the Township Committee's opposition to the field. Assured residents that he has been monitoring this issue on a daily basis. Also expressed disappointment with the lack of progress regarding Union County College's negotiations with the Freeholder Board for construction of the field at Oak Ridge Park. In addition, Commissioner Hannen expressed concern with decisions that were made by Union County College concerning foundation scholarships.

Deputy Mayor O'Connor asked if the Freehold Board has adopted a resolution expressing its opposition to the field at the Cranford campus.

Commissioner Hannen explained that at the last Board of School Estimate's meeting, funds were not included in the budget for the installation of a field. Also stated that it does not appear that there is present or past support by the Freeholder Board for a field at the Cranford campus, which is why the Freeholder Board offered construction of the field at one of the Union County parks.

Deputy Mayor O'Connor requested that the Freeholder Board adopt a resolution officially opposing construction of a field at the Cranford campus.

Mayor Kalnins discussed efforts to monitor this issue.

Mr. Petrucci also discussed progress with street paving and paving that occurred at the corner of Central Avenue and Day Place. Informed the Township Committee that water is pooling at that intersection when it rains and suggested the matter be addressed.

Hearing no further comments, Mayor Kalnins closed the public comment portion of the meeting.

• Congratulated Deputy Mayor O'Connor and Commissioner Bilger on their appointments and extended his best wishes.

Commissioner Robert D'Ambola

• Congratulated Commissioner Bilger on her appointment and welcomed her back to the Township Committee;

- Congratulated Deputy Mayor O'Connor on her appointment as Deputy Mayor;
- Discussed various events being hosted by the Friends of the Public Library and provided contact information for those interested in attending;
- Discussed the Township's newsletter and the information that it provides. Also discussed new regulations which would require the removal of vehicles from certain roads when snow covered and informed residents that the newsletter includes a map of the streets impacted by the new regulations;
- Discussed the 2015 Paving Program and announced that a list of streets included in the program is available on the Township's website. Explained that paving would end in November, and depending on the weather, would begin again in the spring;
- Discussed an article in the Westfield Leader which included statements by Commissioner Hannen concerning costs related to the Township's consulting engineer, Maser Consulting, versus its former inhouse engineering department. It was stated in the article that costs related to Maser Consulting are upwards of \$360,000, while the costs associated with the former in-house engineering department were \$250,000. Commissioner D'Ambola explained that while the costs are higher with Maser Consulting, a significant number of projects are either moving forward or were completed, as compared to when the Township had an in-house engineer. Informed residents that in-depth reports as to the status of engineering projects are provided by Maser Consulting on a regular basis, which were not provided in the past. Also discussed the immediate or timely responses from Maser Consulting, regardless of whether it is after hours or during weekends. Also discussed the projects that are underway or have been completed under the direction of Maser Consulting as follows:

o Orchard Brook Flood Project

Explained that an outside engineer was retained approximately seven (7) years ago to prepare a plan for the Orchard Brook Project and due to the lack of follow up to obtain easements, the plan is now out of date and the Township must prepare a new plan. Stated that the money spent to prepare this plan was wasted, in addition to several years;

High Street Water Main Break

Explained that there was a persistent water leak on High Street coming from a property on South Avenue. The Township received a complaint from a nearby property owner who informed the Township that the leak had been an issue for at least five (5) years. Maser Consulting addressed the problem and corrected it within a short period of time;

Stormwater Management Regulations

Discussed the New Jersey Department of Environmental Protection's (NJDEP) Tier A Stormwater Management Regulations and explained that the Township was not in compliance with these regulations for a minimum of five (5) years. The Township was fined for its lack of compliance and for its failure to file required documentation. Maser Consulting has corrected this situation and has submitted a request to NJDEP requesting a waiver of the fines;

Community Rating System

Discussed efforts to participate in the National Flood Insurance Program's Community Rating System that would provide a discount to residents on flood insurance premiums. Explained that the Township is now participating in the program with assistance that was provided by Maser Consulting;

o 2014 Paving Program

Explained that prior to retaining Maser Consulting (years 2010 to 2013), approximately one-half (1/2) mile of roadway per year (.3 mile of a roadway) was paved. During Maser Consulting's tenure, approximately 4.4 miles (22 roadways) were paved. Also discussed Maser Consulting's efforts and coordination with utility companies for the paving of roadways;

o North Avenue Pedestrian Project

Discussed a grant in the amount of \$500,000 awarded to the Township for the North Avenue Pedestrian Project. Explained that the grant award was nearly rescinded by the State of New Jersey due to the Township's lack of progress with the project. Stated that the project was "saved" as a result of the efforts of the Township Administrator and Maser Consulting and is now underway. Also discussed the increased cost for the project due to the delay in moving it forward. In addition, explained that the former engineer failed to inform the Township Committee that twenty-two (22) parking spaces would be lost with the project. Once informed of this issue, the Township was able to identify locations for alternate parking for a majority of the lost spaces;

Engineering review of Zoning and Building Department applications

Discussed the number of zoning and construction code applications completed by Maser Consulting, which include both residential properties and large commercial development. Also discussed the collection of escrow fees in connection with these applications which was not collected in the past. Also discussed efforts of engineering, building and zoning departments to streamline the application process;

o Maser Consulting Costs

Explained that the Township pays an agreed upon rate for engineering services rendered by Maser Consulting, and the Township no longer pays for overtime, sick, vacation or personal time for an-house engineer. There is also no outstanding pension liability associated with Maser Consulting;

o <u>Various projects</u>

Discussed additional projects completed by Maser Consulting in 2015 including the Springfield Avenue Sanitary Sewer Project, renovations to the upper level of the Municipal Building, improvements to the Carpenter Place Basin and continued assistance by Maser Consulting with respect to the Township's opposition to the Union County College Sports Annex at the Cranford campus.

Commissioner Barbara Bilger

- Thanked the Township Committee for welcoming her back to the Township Committee. Also thanked her friends for attending the meeting this evening, along with Assemblywoman Munoz, Assemblyman Bramnick and Senator Kean;
- Congratulated former Deputy Mayor Lisa M. Adubato on her appointment as NJ Superior Court Judge;
- Thanked VFW Commander James Boxwell for attending the meeting this evening and for distributing POW/MIA pins to the Township Committee;
- Discussed her temporary appointment to the Township Committee and assured residents that she is committed to Cranford and would do her best to represent its residents;
- Announced that the Cranford PBA would be hosting a fundraiser on September 25, 2015 and provided information for those interested in attending.

Deputy Mayor Mary O'Connor

- Announced that the Historic Preservation Advisory Board is partnering with the Mayors Wellness Campaign to sponsor a Historic Walk through Downtown Cranford and provided information for those interested in participating;
- Encouraged residents to support the Farmers Market this weekend;
- Discussed recent rescue efforts by the Police Department and Fire Department and commended them for those efforts. Stated that she feels extremely fortunate to have great public safety officers who are dedicated to the community;
- Thanked former Deputy Mayor Lisa M. Adubato for her service to Cranford. Feels Ms. Adubato made a significant impact to the Township and always put the residents first. Discussed her tenure as a Township Committee member and congratulated her on her appointment as a NJ Superior Court Judge;
- Welcomed Commissioner Barbara Bilger to the Township Committee and stated that she feels she will be an asset to the Township Committee.

Mayor Andis Kalnins

- Thanked Senator Kean, Assemblywoman Munoz and Assemblyman Bramnick for attending the meeting this evening and for their constant support of Cranford;
- Announced that the Chamber of Commerce would be hosting a golf outing this week and provided information for those interested in attending;
- Announced that the Knights of Columbus would also be hosting a golf outing and provided information for those interested in attending;
- Discussed the 9/11 Remembrance Ceremony and commended the committee on hosting the event. Announced that the 9/11 committee is accepting donations to continue maintenance of Cranford's 9/11 Memorial Park;
- Welcomed Commissioner Barbara Bilger to the Township Committee;
- Thanked Deputy Mayor O'Connor for her willingness to serve as Deputy Mayor.

On motion of Commissioner Hannen, seconded by Deputy Mayor O'Connor and passed, the Township Committee adjourned at 9:15 PM.
