PUBLIC COMMENTS

Mayor Kalnins opened the public comments portion of the meeting and asked if there were any questions or comments.

<u>Tina Helmstetter, Tree Advisory Board</u>, discussed the decision of the Township Committee to remove the Pepperidge Tree and concerns that the tree poses safety hazards. Feels the tree is a historic icon of Cranford and feels there are options available to the Township to make the tree safe. Discussed reports by experts concerning historic trees in New Jersey. Feels the tree should not be removed based on its aesthetics and discussed options she feels would make the area safer. Commended Commissioner D'Ambola for discussing the topic with the Township Committee because she feels it is an issue that needs to be addressed, but feels all facts should have been heard before the decision was made to remove the tree.

<u>Ann Cusck, 102 South Union Avenue,</u> discussed her support for the Pepperidge Tree and feels the Township Committee should carefully consider this matter before moving forward with removal of the tree.

Mayor Kalnins explained that the decision is not final regarding the removal of the tree and assured residents that the Township Committee is willing to listen to their concerns.

Hearing no further comments, Mayor Kalnins closed the public comment portion of the meeting.

PROFESSIONAL COMMENTS

Township Administrator Wall

- Thanked the Girl Scouts for leading the flag salute;
- Thanked Deputy Mayor Adubato, Mayor Kalnins and the entire Township Committee for their support with the 2015 Municipal Budget. Also thanked Chief Financial Officer Lavona Patterson and her staff for their efforts with the budget. Discussed the budget process and various initiatives that were undertaken to increase efficiency and address costs. Also thanked Township Clerk Tara Rowley for her efforts regarding the budget process.

Township Attorney Dabulas

- Discussed the Superior Court's ruling on Affordable Housing regulations. Explained the general impact of the court's decision as well as the impact to Cranford. Also informed residents that the Director of Planning and Zoning would be completing the annual Affordable Housing Monitoring Report;
- Provided an update of litigation involving Cranford Development Associates (CDA). Informed residents that no date has been set for the appellate argument and an additional brief was filed by the Township.

COMMISSIONER REPORTS/COMMENTS

Commissioner Thomas H. Hannen, Jr.

- Discussed the Workshop meeting process. Explained that issues that affect the community are discussed
 and debated by the Township Committee during Workshop sessions. Discussed the decision to
 investigate the removal of the Pepperidge Tree. Feels safety measures could be taken by installing
 fencing around the tree. Also discussed the proposed tree ordinance which, if adopted, would have
 prevented removal of the Pepperidge Tree. Encouraged residents to attend the next Workshop Meeting
 and express opposition to the tree's removal;
- Discussed the snow sculptures created each year by a resident of Springfield Avenue. Thanked the Schott family for the sculptures and for making Cranford a special place;
- Discussed his attendance in Washington DC in connection with efforts to secure funding for flood control.

Commissioner Robert D'Ambola

- Thanked the Girl Scouts for leading the flag salute;
- Provided an Engineering update on the following projects:
 - Plans for the North Avenue Station Pedestrian Improvement Project have been submitted to the Department of Transportation (DOT). Once the plans are approved by DOT, a notice to bidders would be advertised. Also discussed the potential for discretionary aid to assist in Cranford's portion of the project and efforts for an informative process throughout this project with all impacted;
 - Paving of remaining roadways that were included in the 2014 Road Resurfacing Program are to begin. Discussed the schedule that would be followed and repairs that are needed;
 - The 2015 Road Resurfacing Program would be considered as part of the 2015 Capital Budget and the list of roadways to be included in the program would be reevaluated. Also discussed an award of \$35,000.00 to the Township for handicap ramp/curb cuts through the Union County Community Development Block Grant Program;
 - Discussed the on-line system for reporting potholes;
- Discussed various events being hosted by the Friends of the Public Library and provided contact information for those interested in attending;
- Discussed the decision to remove the Pepperidge Tree. Discussed reports from several experts that examined the tree. Explained that the Township would be moving forward with the installation of new playground equipment at Lincoln Park and cannot risk potential injury from falling limbs. Stated that he understands why residents do not want the Pepperidge Tree to be taken down, but according to Cranford's risk management consultant, the Township would not have a defensible position in the event someone is injured or something is damaged from the tree's falling limbs. Stated that he would be meeting with the Recreation and Parks Committee, the Cranford Historical Society and the Tree Advisory Board in an effort to develop a plan for the park. Stated that he welcomes any suggestions regarding the site. Also informed residents that several options as to the potential carving of the tree's trunk are being considered. Also discussed the potential for constructing benches from the tree's limbs.

Commissioner Mary O'Connor

- Thanked the Girl Scouts for leading the flag salute;
- Announced that the Mayors Wellness Champaign would be sponsoring the annual Pedal, Paddle Fun Event. Provided information for those interested in participating;
- Discussed the success of the Artisan Market and announced that it would continue for a few more weeks. Encouraged residents to support this event and its vendors;

• Commended public safety personnel Sergeant Finney and Officer Holcomb for their efforts in two (2) separate incidents. Both were commended by citizens for going above and beyond and were noted for their judgement, compassion and professionalism under vey trying circumstances;

- Congratulated the Cranford Fire Department for prevailing over the Police Department in the Dodge Ball Challenge;
- Thanked Deputy Mayor Adubato, Township Administrator Wall, Chief Financial Officer Patterson and support staff for their efforts regarding the 2015 Municipal Budget. Extended special thanks to Mayor Kalnins for his guidance in the budget process and for his presentation this evening;
- Wished everyone a Happy Passover and a Happy Easter.

Deputy Mayor Lisa M. Adubato

- Congratulated the Cranford Daughters of the American Revolution (DAR) for receiving an award in connection with the restoration of the historic murals. Feels it was a very inspiring ceremony that was well deserved;
- Discussed the decision to take down the Pepperidge Tree. Explained that the consequences are not only safety related but the financial consequences would be devastating to the Township if someone were injured. Discussed the fact that many experts have rendered opinions and feels the tree must come down;
- Thanked everyone involved in the 2015 Municipal Budget process;
- Discussed the passing of her uncle.

Mayor Andis Kalnins

- Announced that the Cranford Jaycees would be hosting its annual Easter Egg Hunt and its annual Pancake Breakfast and provided information for those interested in attending;
- Discussed his attendance in Washington DC with Commissioner Hannen, various Union County Mayors and other officials to thank federal representatives for their support and for authorizing funding to complete the Army Corps of Engineers' Study. The objective was to continue efforts to obtain funding to complete the study and to move to the construction phase. Explained that there is still a lot of work that needs to be done. Assured residents that the Township Committee is doing as much as possible to be proactive in helping the Army Corps of Engineers complete the study. Extended his thanks to Senator Menendez, Senator Booker, Congressman Lance, Congressman Payne and Congressman Frelinghuysen for their constant support with this initiative;
