## MAYORAL ANNOUCEMENT

## COVID-19 Update by Health Officer Michael Fitzpatrick

Health Officer Fitzpatrick provided an update on the COVID-19 pandemic. Discussed the current number of residents that are affected. Stated that New Jersey is the second leading state with the virus due to its close proximity to New York. Expects the numbers to stabilize and begin to decrease within the next few weeks. Mentioned that more patients are being released from the hospitals. Informed the residents that all public safety employees will be tested if they have had exposure.

Mayor Giblin asked for clarification as to why Cranford's death toll jumped in one day.

Health Officer Fitzpatrick explained that the number that was given was over an extended ten (10) day period. Discussed the reason for the delay in receiving the numbers. Assured Mayor Giblin that he will continue to provide the exact numbers to the residents on a daily basis.

Commissioner Hannen asked if there is a net figure for those diagnosed through the system and have since recovered.

Health Officer Fitzpatrick stated that it would be difficult since the Prosecutor's office handles that on the County level. Also explained why receiving the numbers for those that have recovered would be an issue.

Commissioner Hannen spoke about individuals that might have been exposed and are being denied from being tested unless they have symptoms. Questioned if testing in Union County has improved to the point that more individuals are being tested other than those that are symptomatic.

Health Officer Fitzpatrick stated that only those that present COVID-19 symptoms are being tested. Mentioned that it could change in a few weeks so there can be a better idea as to what is going on in the general population.

Mayor Giblin stated that Cranford's message is to follow the orders of social distancing so no one should be coming in contact with infected individuals. Discussed the testing site at Kean University and stated that Cranford's goal is to obtain some testing kits for employees with possible exposure. Thanked Health Officer Fitzpatrick for his daily updates and appreciates all the hard work from Mr. Fitzpatrick and his staff.

### Resolution No. 2020-189:

**WHEREAS,** on August 13, 2019, pursuant to a fair and open process in accordance with N.J.S.A. 19:44A-20.4, the Township of Cranford engaged the firm **Nassau Capital Advisors, LLC**, with offices located at 12 Vandeventer Avenue, Princeton, New Jersey 08542, as an expert in financial planning services to assist with the preparation of an amended Master Plan Housing Plan Element and Fair Share Plan; and

**WHEREAS**, at a meeting held January 7, 2020, the Township of Cranford adopted Resolution 2020-102, approving a contract between Nassau Capital Advisors and the Township of Cranford, for the 2020 budget year not to exceed \$10,000; and

**WHEREAS**, it is necessary to amend said contract for an additional amount not to exceed \$10,000; and **WHEREAS**, the Chief Financial Officer and Finance Director have certified as to the availability of funds which is on file in the office of the Township Clerk; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Cranford, be and hereby amends the contract awarded to **Nassau Capital Advisors, LLC** to provide expert financial planning services in an amount for the 2020 budget year not to exceed \$20,000.

**WHEREAS,** Local Finance Notice 2020-06 of the Division of Local Government Services also advised that municipalities with a Storm Recovery Trust Fund may use those funds for the coronavirus response; and, any reimbursement of these expenditures shall be deposited back into the reserve; and **NOW, THEREFORE, BE IT RESOLVED**, by the Governing Rody of the Township Committee of the
