Mentioned that Hartz Mountain requested a Payment In Lieu of Taxes (PILOT) but has yet to propose a structure that's acceptable to the Township and assured the residents that there is no scenario where Hartz Mountain would not pay taxes for any year under a PILOT. The conventional taxes remain in effect until the project is completed with a payment every year in lieu of taxes which would be substantial.
