MAYORAL ANNOUNCEMENTS

Recognition of Service - Fire Chief Leonard R. Dolan, III

WHEREAS, Chief Leonard R. Dolan III has been a career member of the Cranford Fire Department for over thirty-seven (37) years, not only as a second generation firefighter, but also a second generation Fire Chief; and WHEREAS, Chief Dolan was appointed to the career department on August 1, 1977, and was subsequently appointed as Fire Inspector, promoted to Lieutenant in 1985 and promoted to Captain in 1989, which set the course for his appointment as Fire Chief in 1997, a position he proudly held for seventeen (17) years; and WHEREAS, Chief Dolan was responsible for the development of the Union County Mutual Aid agreement and served as Mutual Aid Coordinator; and

WHEREAS, Chief Dolan made firefighter safety a top priority by instituting various practices that would ensure that firefighters would not be exposed to additional hazards when entering a burning structure; and

WHEREAS, Chief Dolan advocated continual training and professional development to ensure that the Cranford Fire Department was the most highly trained department possible; and

WHEREAS, Chief Dolan championed the Fire Prevention Bureau, ensuring that all residents and businesses in Cranford were properly educated about fire safety, and requiring nightly public assembly inspections in which firefighters would drive through the Township inspecting all public assembly places, schools and assisted living facilities to ensure the safety of those occupying the space; and

WHEREAS, Chief Dolan instituted an "acting officer" policy to allow firefighters the opportunity to be an officer when only one sworn officer was on duty to give a firefighter the experience of supervising a platoon of men and gaining knowledge from the experience; and

WHEREAS, Chief Dolan was always available to the members of the Fire Department to promote a sense of family and community.

PUBLIC COMMENTS

Mayor Kalnins opened the public comments portion of the meeting and asked if there were any questions or comments.

<u>Frank Krause</u>, 20 <u>Pittsfield Street</u>, commended Fire Chief Dolan for his service and congratulated Patrick Dolan on his appointment as firefighter.

Dr. Krause also discussed the fire that occurred in Edgewater and feels similar construction is occurring at 555 South Avenue East. Feels the fire in Edgewater should "open a new chapter" for Cranford with respect to public safety. Feels Cranford has outstanding public safety departments and discussed presentations by Police Chief Wozniak and Fire Captain Stratton at recent Workshop meetings in which the impact of redevelopment projects to public safety was discussed.

Dr. Krause also discussed a report he provided to the Township Committee concerning decisions made by the Zoning Board of Adjustment and requested an opportunity to discuss his report with the Township Committee at a Workshop meeting. Also discussed his recommendation to invite Governor Christie to visit Cranford and speak with residents.

John Hrebin, 414 Cranford Avenue, requested an update regarding Birchwood Avenue.

Township Attorney Dabulas informed residents that the appeal of litigation has been fully briefed and the Township is waiting for the dates for oral arguments. As to the Department of Environmental Protection's (DEP) ruling concerning the issuance of a Flood Hazard Area permit to Cranford Development Associates (CDA), explained that the Township filed an appeal of DEP's decision and has received the briefing schedule.

Mr. Hrebin questioned the resolution authorizing an award of contract to Florio, Perrucci & Steinhardt for affordable housing legal services.

Mayor Kalnins explained that the Township solicited Request for Proposals for this service on two (2) occasions and only one firm submitted a response on both occasions. Explained that the Township Committee is also working with the firm that is handling the Township's appeal and would be considering that firm as another option.

Hearing no further comments, Mayor Kalnins closed the public comment portion of the meeting.

PROFESSIONAL COMMENTS

Township Administrator Wall

• Provided an update regarding the 2015 Municipal Budget, stating that all Department Managers have presented their budget requests to the Township Committee;

• Discussed the Township's website and informed residents that it is continuously being updated. Announced that the Township's newsletter and a calendar of events are available on the website. Also encouraged residents to contact his office with any concerns, input or feedback they may have on any Township matter.

COMMISSIONER REPORTS/COMMENTS

Commissioner Thomas H. Hannen, Jr.

• Referred to Dr. Krause's comments regarding Governor Christie visiting Cranford. Feels Birchwood Avenue would be the main topic residents would like to discuss with the Governor and is hopeful that the Governor would visit.

Commissioner Robert D'Ambola

- Congratulated Patrick Dolan on his appointment as firefighter and Chief Dolan on his retirement. Feels it is special when a public safety career is passed down from one generation to another;
- Provided an update regarding the North Avenue Station Pedestrian Improvement Project. Stated that updated drawings were presented during last evening's Workshop Meeting. Explained that this project has been planned for several years and is finally on track to begin in May with an estimated completion time of four (4) months. Also explained that construction would impact the downtown and feels communication with Special Improvement District personnel, business and property owners is essential. Announced that North Avenue would remain open because it is a state highway, but approximately twenty (20) parking spaces would be lost. Efforts to alleviate this issue are being considered, such as signage improvements, and the reconfiguration of other areas to create additional parking spaces. Explained that the Township would have a better idea of how to assess the problem once the capital budget is adopted. Also announced that all businesses affected by this project would remain open during construction;
- Discussed a proposed ordinance to prohibit parking on roads covered with three (3) or more inches of snow. Urged residents to remove vehicles from roadways when there is snow, as unmoved vehicles hinder plowing efforts and create a public safety issue. Discussed a current state statute that considers cars unmoved for forty (48) hours as abandoned vehicles;
- Discussed various events being hosted by the Friends of the Public Library and provided contact information for those interested in attending those events.

Commissioner Mary O'Connor

- Discussed the Rain Barrel Workshop being held by the Environmental Commission on March 21, 2015 at the Cranford Community Center and provided contact information for those interested in attending;
- Announced that an information session concerning the Pilgrim Pipeline is being held by Chatham and Madison officials and encouraged residents to attend;
- Feels there is misleading information regarding the subject of conflicts of interest and explained that these regulations do not apply to voting on municipal budgets. Explained that the bylaws of the Township Committee were amended to ensure that members of the Township Committee adhere to the current state law and take the appropriate action. Read an excerpt from this law and discussed instances in which Mayor Kalnins, Commissioner D'Ambola, and Commissioner Hannen needed to recuse themselves from discussions pertaining to employment in the Police and Fire Departments because of a potential conflict of interest. Feels since all three (3) of these commissioners were treated equally proves there is no political intent. Stated that while residents elect individuals to the Township Committee based upon their knowledge and experience, feels residents expect Township Committee members to act ethically and put the best interest of Cranford above all other interests;
- Referred to Dr. Krause's comments regarding public safety. Assured residents that the Township Committee is doing everything possible to ensure that Cranford has adequate and well-trained public safety professionals;
- Congratulated Patrick Dolan on his appointment as firefighter and for carrying on a family tradition. Welcomed him and wished him good luck;
- Congratulated Chief Dolan on his retirement. Stated that she has had the privilege of working with Chief Dolan for the past fourteen (14) months as Public Safety Commissioner and thanked him for his insight and knowledge, and for his many dedicated years of service to Cranford.

Deputy Mayor Lisa M. Adubato

• Congratulated Chief Dolan on his retirement and thanked him for his many years of service to the community;

• Congratulated Patrick Dolan on his appointment as firefighter and wished him luck, and commended all public safety personnel for their efforts;

• Announced that the Cranford High School Girls Swim Team won the title of Central Group C Sectional Champions and explained that this is the first sectional title in the school's history. Also announced that five (5) girls from the team would be competing this weekend at the Meet of Champions in Gloucester County and wished them luck.

Mayor Andis Kalnins

- Congratulated Chief Dolan on his retirement and thanked him for his many years of service to Cranford;
- Congratulated Patrick Dolan on his appointment as firefighter and stated that he is proud to see the Dolan family tradition continuing;
- Assured residents that the Township Committee supports its public safety personnel and would address
 any concerns or issues to ensure proper staffing levels. Explained that issues regarding construction
 have been discussed with the Construction Code Office. The Construction Code Official assured the
 Township Committee that it has been fully engaged since the beginning of these projects to ensure that
 construction meets and exceeds state requirements. Also mentioned that the Township would continue to
 make recommendations to state leaders regarding code requirements;
- Discussed upcoming events being sponsored by the Cranford Jaycees and provided information for those interested in attending. Informed residents that all proceeds would be donated to the Cranford First Aid Squad.

On motion of Commissioner O'Connor, seconded by Deputy Mayor Adubato and passed, the Township Committee adjourned at 9:05 PM.
