# MAYORAL REMARKS

Mayor Miller Prunty stated that she would like to speak about the North Avenue Gateway

Redevelopment Area. She spoke about the Township's designation of this area as in area in need of redevelopment because it presents a tremendous opportunity to transform an important part of Cranford and the downtown area. She further elaborated. Mayor Miller Prunty stated that she would invite public input. She spoke about the Request for Expressions of Interest's (RFEI) specifications. Mayor Miller Prunty spoke about previous-year redevelopment efforts for the North Avenue Gateway Redevelopment Area in 2008 and 2017. She spoke about the RFEI process and noted that the process was non-binding. Mayor Miller Prunty spoke about expected next steps for the North Avenue Gateway Redevelopment process, i.e., formation of a Review Team to evaluate and score the received proposals, the Township's Planning Consultant drafting of a Redevelopment Plan, a period of community input and a Request for Proposals based on the Redevelopment Plan. Mayor Miller Prunty spoke about the importance for planning for our future. She asked members of the public to consider this matter based on facts.

#### **INFORMAL MEETING**

Mayor Miller Prunty opened the informal meeting portion of the meeting and asked if there were any questions or comments.

Ms. Rita LaBrutto of 104 Arlington Road state that she had submitted an OPRA request on April 14<sup>th</sup> to view the RFEI's received. Ms. LaBrutto stated that the OPRA response received stated that if Ms. LaBrutto reviewed the RFEI's, an advantage would be given to competitors or bidders. She further elaborated. Mayor Miller Prunty stated that she would ask the Township Attorney to respond to Ms. LaBrutto's comment. Mayor Miller Prunty requested that everyone let the Township officials do their work. Mayor Miller Prunty stated that both she and members of the Township Committee are committed to public input. Township Attorney Ryan Cooper stated that the RFEI materials were consultative and deliberative materials. He spoke about the upcoming review and scoring of the RFEI's by the Township professionals and elaborated. Mr. Cooper stated that he RFEI materials would be subject to OPRA after the review process was completed and elaborated.

Mayor Miller Prunty asked Township Clerk Patricia Donahue if she had received public comments correspondence. # APPROVING THE FOOD WASTE COLLECTION PROGRAM AT THE CONSERVATION CENTER

**WHEREAS,** consistent with its goal to make the Township of Cranford a more sustainable community, the Township Committee of the Township of Cranford authorized the Cranford Green Team to explore ideas to help residents initiate cost-effective, environmentally sound changes to keep our community greener and cleaner; and

**WHEREAS**, the Cranford Green Team has identified a local solution to help the Township of Cranford reach its sustainability goals by providing residents the opportunity to divert their food material waste into renewable, sustainable energy; and

**WHEREAS,** Green Bucket Compost, LLC of 1270 Cambridge Avenue, Plainfield, New Jersey, 07062, provides food scrap diversion services for households and businesses; and

**WHEREAS**, the Township Committee of the Township of Cranford recognizes the need to encourage and develop an easy and accessible voluntary food scraps drop-off pilot program for residents through Green Bucket Compost, LLC to perform weekly pick-ups transporting collected materials to nearby sustainable waste management facilities set up to convert the waste into compost or biofuel; and

**WHEREAS,** the Purchasing Agent has determined and certified in writing that the value of the services will not exceed the quote or bid threshold; and

**WHEREAS**, the Chief Financial Officer has certified to the availability of funds which is on file in the office of the Township Clerk; and

**NOW, THEREFORE, BE IT RESOLVED** that the Township Committee of the Township of Cranford approves the creation of a Food Waste Collection Program for residents of the Township of Cranford and establishes an organics collection location at the Conservation Center located at 210 Birchwood Avenue, Cranford, New Jersey, 07016 as described herein; and

**BE IT FURTHER RESOLVED** that the Township Committee of the Township of Cranford directs the Township Administrator to instruct the Department of Public Works to work with the Green Team to develop and implement a public education program for residents to increase awareness of this Food Waste Collection Program and additional food waste prevention/reduction strategies.

**WHEREAS**, the Township of Cranford recognizes the increase of low-flying aircrafts in the community since May 2018; and

**WHEREAS**, the increased flight traffic has created excessive noise in the community throughout various times of the day and night; and

**WHEREAS**, such extreme noise has disrupted the quality of life for Cranford residents as it has become increasingly difficult for residents to enjoy normal behaviors such as outdoor activities, watching television and listening to music; and

**WHEREAS**, the volume and frequency of the noise caused by low-flying aircrafts continue irrespective of time thus often interfering with the sleep patterns of Cranford residents of all ages; and

**WHEREAS,** the Township Committee is deeply disturbed by the impact such noise has on the health, safety and welfare of its residents; and

**WHEREAS**, the Township Committee is aware of and very concerned about the deleterious health effects such noise has on its residents, including disruption to children's learning, hearing problems, elevated blood pressure and increased stress levels; and

**WHEREAS,** the Township Committee is very concerned about the ongoing state of low-level flying especially after witnessing the detrimental effects of the 1987 Expanded East Coast Plan (EECP); and

**WHEREAS,** the Township Committee seeks to restore the aircraft routes to where they were prior to May 2018; and

WHEREAS, the Township Committee requests an explanation for the change in flight patterns absent proper notice and with total disregard to the effects such change has had on the environment and the residents of Cranford; and

**WHEREAS**, the Township Committee seeks assurances that Cranford's noise concerns will be addressed by city and county noise committees; and

**NOW THEREFORE, BE IT RESOLVED,** the Township of Cranford expresses its opposition to the continued low flying aircrafts and the maladies associated with such activity which is imposed onto its residents, and

**BE IT FURTHER RESOLVED,** that this resolution be sent expeditiously to the U.S. Representative Tom Malinowski, U.S. Senator Robert Menendez, U.S. Senator Cory Booker and that copies be sent to the Flight Standards District Offices (FSDO) which is the local field office of the Federal Aviation Administration (FAA) servicing Union County, located at Park 80 West, Saddle Brook, NJ 07663 as well as the Port Authority of New York and New Jersey Noise Office, c/o The Port Authority of New York and New Jersey Corporate Offices, 4 World Trade Center, 150 Greenwich Street, New York, NY 10007.

### **RESOLUTION NO. 2021-199**

**WHEREAS**, the COVID-19 pandemic, resulting Executive Orders, and public health guidance have curtailed businesses', particularly restaurants and dining establishments, indoor capacity and operations; and

WHEREAS, as the Township Committee wishes to utilize a portion of Eastman Street, between North Avenue West and Miln Street, which is a local street in the Township of Cranford, as a public plaza for outdoor seating and gathering space for the businesses in the vicinity; and

**WHEREAS**, the New Jersey Department of Transportation (NJDOT) requires that a municipality obtain a NJDOT permit prior to closing any street within 150 feet of a State Highway; and

**WHEREAS**, Eastman Street is not a State or County road, but is adjacent to North Avenue West, which is also known as State Highway 28, but operates as a local street running through the communities of Cranford, Garwood, Westfield, and others; and

**WHEREAS**, North Avenue West is a local road with a speed limit of 25 miles per hour for the portion adjacent to Eastman Avenue, which traverses a quiet downtown community of locally owned businesses struggling with the impacts of the pandemic, and is not a limited access highway or high-speed thoroughfare; and

**WHEREAS**, the Township of Cranford has submitted an application for such permit, which process can take a minimum of 45 days, during which Cranford's local business will be further impacted by the negative effects of the COVID-19 pandemic and its devastating impact on local businesses.

**NOW THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Cranford, that the Township requests that Governor Phil Murphy support efforts by local communities to assist local businesses by permitting street closures by expediting the NJDOT's permitting of street closures or waiving such permit requirement for the closure of non-State highways within downtown business districts.

**BE IT FURTHER RESOLVED** that a copy of this resolution be forwarded to Governor Phil Murphy.

#### **PUBLIC COMMENTS**

Mayor Miller Prunty opened the public comments portion of the meeting and asked if there were any questions or comments.

Ms. Rita LaBrutto stated that she would read an excerpt from the (Hartz Mountain) Memorandum of Understanding (MOU), specifically Section 3.2, paragraph Article 3. Ms. LaBrutto asked about the PILOT wording in the MOU, specifically a sentence regarding the PILOT is a material and essential term of the Settlement. Ms. LaBrutto spoke about the need to be transparent. She stated that the Township had never received a presentation on this PILOT and elaborated. Ms. LaBrutto commented about the expected number of school children and financial expectations for the property at750 Walnut Avenue as compared to today's use of the property. She commented that the settlement was signed in December (of 2020) and the Township still doesn't know the impact and the agreement. Ms. LaBrutto then spoke about the Wells Fargo site and the associated five (5) year tax abatement and a possible tax break at North Avenue Redevelopment. She stated that as a taxpayer she has had enough of discussions of tax breaks and further elaborated about her frustration.

Mayor Miller Prunty stated that there was a presentation scheduled for 750 Walnut Avenue on May 6<sup>th</sup>. Mr. Cooper spoke about presentations held regarding various Settlements including those with Hartz Mountain and Fair Share, as well as presentations, both on-line and in person. He stated that the MOU had been posted on the Township website. He stated that Hartz Mountain's position was that it must get a PILOT. Mr. Cooper stated that when the Township gets to the stage (to discuss a PILOT with Hartz Mountain) he expected that there would be a full presentation on all of the impacts of the Settlement such as the impact on the Affordable Housing obligation, the school system and our taxpayers. Mr. Cooper suggested that Ms. LaBrutto keep in mind the consequences of this project as opposed to alternative proposals such as the (previous-year) proposal of 900 apartments. Discussion ensued. Ms. LaBrutto further elaborated about her opposition to PILOT's.

Hearing no further comments, Mayor Miller Prunty closed the public comment portion of the meeting.

#### **Township Clerk Patricia Donahue**

• Stated that Deputy Municipal Clerk Heather Capone had resigned from the Township and would be moving to a promoted position in another municipality. Stated that Ms. Capone had served the Township quite well for close to fifteen (15) years. Requested All to join her in wishing Ms. Capone continued career success.

# **Township Administrator Jamie Cryan**

• Stated that the Township was losing three (3) long-time employees. Stated that he wanted them to know that they were appreciated and that we wished them well. Spoke about the service of Ms. Jean McComb, Ms. Heather Capone and Mr. Rich Belluscio.

#### COMMISSIONER REPORTS/COMMENTS

#### **Commissioner Mary O'Connor**

- Spoke about development in Cranford's future due to Affordable Housing Laws. Stated that it was more important than ever, that we, your representatives, are as open as possible during every step of the process. Stated she was unable to attend the previous night's Workshop Meeting but learned that Commissioner Hannen requested that the (North Avenue Gateway Redevelopment) matter be discussed in public (open session.) She stated that she supported his request and elaborated. Spoke about keeping the public as informed as possible. Stated that public discussion should take place in an arena that is a proper arena -- that is, at meetings that we set. Commissioner O'Connor further elaborated;
- Spoke about upcoming events: Relay for Life on May 22<sup>nd</sup> at Cranford High School and a Cranford High School JSA-sponsored Blood Drive on May 3<sup>rd</sup>;
- Thanked Ms. McComb, Mr. Belluscio and Ms. Capone for their service to Cranford and noted their remarkable work for the Township and the residents and wished them "all the best";
- Encouraged residents to be safe, continue wearing masks, practice social distancing and get vaccinated.

# Commissioner Thomas H. Hannen, Jr.

- Stated that he would echo Commissioner O'Connor's comments regarding Mr. Belluscio, Ms. McComb and Ms. Capone, i.e., he stated his "best wishes" to them. Stated that each of them served the Township of Cranford and its citizens in an exemplary fashion and noted his appreciation;
- Stated that he wanted to comment on Ms. LaBrutto's questions and comments. Spoke about the Township Committee's previous consideration of the 750 Walnut Avenue proposals. Stated that he believes that the Township Committee has not committed to a PILOT (with Hartz Mountain) but noted that he will now do additional homework on this matter. Noted that he did vote against the South Avenue proposal as he was concerned that it was too generous to the developers; thanked Ms. LaBrutto for bringing our attention back to this and briefly elaborated;
- Spoke about the previous evening's Executive Session discussion (of North Avenue Gateway Redevelopment) and his desire that such discussion would have been conducted in Open Session and elaborated;
- If they hadn't already done so, Commissioner Hannen encouraged residents to view Tyler Perry's acceptance speech for the Jean Hersholt Humanitarian Award (at the Academy Awards)
- Commissioner Hannen stated that as Commissioner O'Connor suggested, he encouraged residents to stay safe, get vaccinated and be healthy.

### **Commissioner Jason Gareis**

- Encouraged anyone interested in a career in law enforcement to consider applying to the Cranford Police Department and elaborated;
- Thanked all the residents who participated in the first town-wide Clean-Up event. Thanked Mayor Miller Prunty and the Clean Communities Committee for organizing the event;
- Thanked Ms. McComb, Mr. Belluscio and Ms. Capone for their service and wished them well in their future endeavors;
- Congratulated the Cranford Lacrosse Club members for their participation in the Trilogy MetLife Stadium Classic during the weekend of April 10<sup>th</sup>; Commended the Club's President, Mr. Mike Robel, and the Lacrosse Club coaches;
- Noting his comments would be similar to the previous Commissioner comments, Commissioner Gareis encouraged "masks up," and to stay safe.

# **Deputy Mayor Brian Andrews**

• Stated that he would like to comment on the Redevelopment proposal for the North Avenue Gateway Redevelopment project; stated that this initiative was an important way to take control over our destiny including getting ahead of developer lawsuits; thought the public attention to this matter was good; encouraged engagement with the process; spoke about getting public input and being transparent;

- Joined Commissioner Gareis in recognizing Green initiatives such as tonight's authorization of the food composting option (thanked the Green Team;) spoke about the Town-wide clean-up (thanked the Clean Communities Committee and the Mayor;)
- Spoke about the Township Committee's authorization pertaining to the closure of a portion of Eastman Street;
- Provided a Memorial Day Parade update and noted its postponement until 2022;
- Thanked Ms. McComb, Mr. Belluscio and Ms. Capone for their service to the Town;
- Provided Downtown Management Corporation (DMC) updates including the upcoming Crantucky Derby event and the new feature on the DMC website pertaining to the collection of all Cranford menus;

#### **Mayor Kathleen Miller Prunty**

- Wished Ms. McComb, Mr. Belluscio and Ms. Capone the "very best" and thanked them for their contributions and elaborated;
- Spoke about two (2) quality of life issues: 1) the Township Committee passed a resolution that evening regarding increased air traffic; stated that a letter would be sent to Senator Booker, Senator Menendez and Congressman Malinowski seeking an explanation as to why the flight pattern had changed and requesting that the flight pattern be restored to what it was before 2018; 2) Garbage pickup before the approved hours. Stated that the Administrator's office had reached out to garbage haulers regarding the allowed hours; Noted that letters have now been sent to the garbage haulers regarding the allowed hours of operation and the Township would be enforcing such hours;
- Spoke about the previous week's ribbon cutting event she attended with Commissioner O'Connor at Eye Décor on Centennial Avenue;
- Spoke about the upcoming Centennial Village Group's Velocity 5k Race on June 6th;
- Thanked the Scouts and members of the Clean Communities Committee for their work on the town-wide Clean-Up event; spoke about soon-to-be released signs pertaining to litter pick-up in Township playgrounds;
- Encouraged residents to social distance, wear masks and get vaccinated.
