WHEREAS, Mark Paving Co. Inc., 77 Cutters Dock Road, Woodbridge, NJ 07095 was previously awarded a contract for the above-referenced project with a Total Bid Price in the amount of \$330,802.00; and

WHEREAS, the project has been completed to date in the <u>total dollar amount of \$217,517.67</u> that reflects the as-built construction quantities necessary to properly construct this project to date and is within the total amended contract value; and

WHEREAS, the Township Engineer, as per a memorandum dated January 15, 2016, has reviewed the as-built final quantities and finds that the request has merit, is in the best interest of the Township and has recommended to the Township Administrator, Township CFO and Township Finance Office to pay the total final as-built amount in the amount of \$15,691.97; and

WHEREAS, the Township Engineer, as per a letter of transmittal dated January 15, 2016, is in receipt of the 2 year maintenance bond specific to said project; and

WHEREAS, the final recommend payment is within the contract value and funds are currently encumbered within the existing construction contract for the Parking Lot Improvements; and

NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Cranford, that the above-referenced dollar amount of **\$15,691.97** is authorized by way of final as-built quantities for the Renovations to the Municipal Building Parking Lot is granted to contractor of record, Mark Paving Company, Inc. 77 Cutters Dock Road, Woodbridge, NJ 07095.

AUTHORIZING SUSTAINABLE JERSEY GRANT APPLICATION

WHEREAS, a sustainable community seeks to optimize quality of life for its residents by ensuring that its environmental, economic and social objectives are balanced and mutually supportive; and

WHEREAS, the Township of Cranford strives to save tax dollars, assure clean land, air and water, improve working and living environments; and

WHEREAS, the Township of Cranford is participating in the Sustainable Jersey Program; and

WHEREAS, one of the purposes of the Sustainable Jersey Program is to provide resources to municipalities to make progress on sustainability issues, and they have created a grant program called the Sustainable Jersey Small Grants Program;

THEREFORE, the Township Committee of the Township of Cranford has determined that the Township of Cranford should apply for the aforementioned Grant.

THEREFORE, BE IT RESOLVED, that the Township Committee of the Township of Cranford, County of Union, State of New Jersey, authorizes the submission of the aforementioned Sustainable Jersey Grant.

Resolution No. 2016-126:

WHEREAS, The Governor declared a state of emergency on January 22, 2016 due to the expectations of winter storm Jonas; and

WHEREAS, winter storm Jonas dropped approximately 28 inches of snow in Cranford.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Cranford that the Township Administrator in consultation with the Superintendent of Public Works is hereby authorized to spend up to \$75,000 (seventy-five thousand dollars) on snow removal activities in the Township of Cranford to effectuate the cleanup efforts.

PUBLIC COMMENTS

Mayor Kalnins opened the public comments portion of the meeting and asked if there were any questions or comments.

<u>Cranford resident, 42-44 West Holly Street,</u> discussed his support for military personnel. Feels the treatment of soldiers when they returned home was atrocious. Sang a song in support of the military. Also discussed his support for the reactivation of Muhlenberg Hospital and other hospitals that were closed in the area.

<u>Frank Krause, 20 Pittsfield Street</u>, discussed the proposed development of property on the corner of 4th Avenue and Brookside Place in Garwood that borders Cranford. Provided a description of the property and the number of units proposed for construction. Also discussed drainage plans for the project and expressed concern that the project was approved by the Garwood Zoning Board with no Cranford representatives present at the hearing. Discussed former Township Engineer Gregory Sgroi and his involvement with flood control efforts in Cranford. Discussed flooding that occurred in the area prior to the construction of the Brookside Detention Basin. Feels Cranford needs a hydraulic engineer to review the plans for this project. Also questioned why Cranford representatives were not present at the hearing.

Mayor Kalnins explained that this is a bifurcated process and there are currently no storm water management designs for Cranford to review at this time. Assured Dr. Krause that the Township Engineer has been communicating with Garwood's Engineer on the design and is currently awaiting a report from Garwood. Also discussed state statute with respect to storm water regulations.

Dr. Krause asked if Cranford would have representation at the next hearing.

Commissioner O'Connor stated that she would attend the hearing but is uncertain as to what she could contribute.

Dr. Krause feels the Township Committee should file a suit against Garwood if Garwood moves forward with the project.

Township Attorney Dabulas feels it is not appropriate for the Township Committee to discuss or comment on Dr. Krause's suggestion to file a suit without having all of the facts.

Joseph Traynor, 15 Dartmouth Road, requested an update of plowing, specifically on Dartmouth Road.

Mayor Kalnins explained that it was a difficult storm and the Department of Public Works is continuing to plow.

Township Administrator Wall informed Mr. Traynor that Dartmouth Road is scheduled for plowing tomorrow morning.

Hearing no further comments, Mayor Kalnins closed the public comment portion of the meeting.

PROFESSIONAL COMMENTS

Township Administrator Terence Wall

- Congratulated and welcomed Commissioner John Mallon to the Township Committee;
- Also congratulated the Cranford High School Varsity Football Team on winning the State Championship.

Township Attorney Diane U. Dabulas

- Discussed litigation involving Cranford Development Associates and informed residents that a decision has not been made regarding the Township's appeal;
- Congratulated Commissioner John Mallon on his appointment to the Township Committee.

COMMISSIONER REPORTS/COMMENTS

Commissioner Thomas H. Hannen, Jr.

- Congratulated Commissioner John Mallon on joining the Township Committee;
- Discussed the resolution adopted this evening which authorizes the Department of Public Works to hire additional contractors for emergency snow removal services. Assured residents that the Township Committee understands their concerns and is working on resolving the issue. Explained that the Township's priority was to make sure schools were accessible. Thanked residents for bringing the issue to the Township Committee's attention and encouraged anyone with a problem to contact the Administrator's Office;
- Congratulated the Cranford High School Varsity Football Team on winning the State Championship;
- Mentioned that the school schedule for students would be staggered tomorrow. Provided information for those affected.

Commissioner Patrick F. Giblin

- Congratulated and welcomed Commissioner John Mallon to the Township Committee and stated that he looks forward to working with him;
- Congratulated the Cranford High School Varsity Football Team on winning the State Championship;
- Discussed the Library Board Meeting scheduled for Thursday, January 28, 2016 and mentioned that it is open to the public;
- Announced that the 2016 Municipal Budget process is underway. Discussed the departments scheduled
 to present budgets and announced that the meetings are open to the public. Encouraged residents to
 attend.

Commissioner John Mallon

- Thanked Assemblyman Bramnick for administering his Oath of Office this evening;
- Thanked former Commissioner Robert D'Ambola for his service to Cranford;
- Thanked the Township Committee for allowing him the opportunity to serve the Township of Cranford. Stated that he has been a resident for twenty-two (22) years and feels honored to serve the Township in this capacity. Also stated that he looks forward to working with each of his fellow commissioners and thanked his family for their support;
- Congratulated the Cranford High School Varsity Football Team on winning the State Championship;
- Referred to Commissioner Hannen's comments regarding snow removal. Discussed his appointment as Engineering/Department of Public Works Commissioner and explained that the Township is dedicated to clearing the streets, but the first order of business was to make sure schools were accessible. Also expressed his appreciation to residents for bringing the issue to the Township Committee's attention.

Deputy Mayor Mary O'Connor

- Thanked Fire Lieutenant DiPaolo for his efforts with the Toys for Tots drive that was held by the Fire Department;
- Discussed a recent house fire that was a result of inoperable smoke detectors. Urged residents to check all smoke detectors and to contact the Fire Department with questions;
- Reminded residents and business owners that sidewalks must be cleared of snow and ice to allow for safe pedestrian passage, including sidewalk openings to crosswalks. Stated that summonses would be issued to those who have not cleared their sidewalk. Also asked residents to clear snow away from fire hydrants;
- Discussed the opening of Cranford schools tomorrow and encouraged drivers to carpool to the high school and train station due to limited parking;
- Mentioned that vehicles abandoned during the storm would begin to be ticketed tomorrow;

• Thanked the Department of Public Works and the Cranford First Aid Squad for their hard work and efforts during the storm;

- Congratulated the Cranford High School Varsity Football Team on winning the State Championship. Feels they represent the best of Cranford's youth and are role models for all students who attend public schools:
- Congratulated Commissioner John Mallon on his appointment to the Township Committee and stated that she looks forward to working with him.

Mayor Andis Kalnins

- Congratulated the Cranford High School Varsity Football Team on winning the State Championship. Feels this is another "great light" that shines on Cranford;
- Commended the Department of Public Works on their hard work and efforts during the storm. Explained that employees worked for thirty-six (36) hour to keep the streets as clean as possible so emergency vehicles could get through. Also thanked all emergency personnel for protecting the community;
- Announced that snow removal efforts would continue and discussed the hiring of additional contractors to assist with snow removal;
- Discussed the adoption of an ordinance in 2015 which prohibits on-street parking when the road is snow covered. The Department of Public Works found that this new requirement allowed for easier plowing during the storm and urged residents to remove cars from streets when snow is expected;
- Discussed the trip to Washington DC to meet with legislators to discuss funding for flood mitigation. Informed residents that while the meeting was canceled due to the storm, the Township Committee is fully committed to continuing to address this issue. Encouraged residents to write to legislators concerning this matter.

On motion of Commissioner Hannen, seconded by Deputy Mayor O'Connor and passed, the Township Committee adjourned at 9:27 PM.
