WHEREAS, the Township of Cranford, in the County of Union, New Jersey (the "Township") from time to time issues bonds, notes and other obligations the interest on which is excluded from gross income for Federal income tax purposes and desires to take such action as may be necessary or advisable to establish and maintain such exclusion; and

**WHEREAS,** the Internal Revenue Code of 1986, as amended (the "Code"), contains provisions with respect to the exclusion from gross income for Federal income tax purposes of interest on obligations, including provisions, among others, which require issuers of tax-exempt obligations, such as the Township to account for and rebate certain arbitrage earnings to the United States Treasury and to take other action to establish and maintain such Federal tax exclusion; and

**WHEREAS,** the Township intends to issue a \$9,700,000 bond anticipation note, dated January 29, 2016 and payable January 27, 2017 (the "Note"); and

**WHEREAS,** the Township desires to designate the Note as a "qualified tax-exempt obligation" pursuant to Section 265(b)(3) of the Code;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Cranford, in the County of Union, New Jersey, as follows:

<u>SECTION 1</u>. The Township Committee hereby covenants on behalf of the Township, to the extent permitted by the Constitution and the laws of the State of New Jersey, to do and perform all acts and things permitted by law

and necessary to assure that interest paid on bonds, notes or other obligations of the Township (including the Note) be and remain excluded from gross income of the owners thereof for Federal income tax purposes pursuant to Section 103 of the Code.

SECTION 2. The Mayor, Township Clerk, Chief Financial Officer and other officials of the Township are hereby authorized and directed to take such action, make such representations and give such assurances as they may deem necessary or advisable to effect compliance with the Code.

SECTION 3. The Note is hereby designated as a "qualified tax-exempt obligation" for the purpose of Section 265(b)(3) of the Code.

SECTION 4. It is hereby determined and stated that (1) the Note is not a "private activity bond" as defined in the Code and (2) the Township and its subordinate entities, if any, do not reasonably anticipate issuing in excess of \$10 million of new money tax-exempt obligations (other than private activity bonds) during the calendar year

SECTION 5. It is further determined and stated that the Township has not, as of the date hereof, issued any taxexempt obligations (other than the Note) during the calendar year 2016.

SECTION 6. The Township will, to the best of its ability, attempt to comply with respect to the limitations on issuance of tax-exempt obligations pursuant to Section 265(b)(3) of the Code; however, said Township does not covenant to do so, and hereby expressly states that a covenant is not made hereby.

SECTION 7. The issuing officers of the Township are hereby authorized to deliver a certified copy of this resolution to the original purchaser of the Note and to further provide such original purchaser with a certificate of obligations issued during the calendar year 2016 dated as of the date of delivery of the Note.

<u>SECTION 8</u>. This resolution shall take effect immediately upon its adoption.

# **PUBLIC COMMENTS**

Mayor Kalnins opened the public comments portion of the meeting and asked if there were any questions or comments.

<u>John Pritchard, 42-44 West Holly Street</u>, discussed his support for military personnel. Discussed military personnel from Cranford lost during Vietnam. Sang a song in support of the military. Also discussed his support for the reactivation of Muhlenberg Hospital and other hospitals that were closed in the area.

Rita Mason, 16 Alan Okell Place, asked why Cranford does not have an elected Mayor.

Mayor Kalnins explained Cranford's current form of government and the process to change the form which was considered three (3) years ago.

Ms. Mason expressed concern with construction permit fees and the permitting process. Also feels inspectors do not conduct inspections so permits are not closed.

Mayor Kalnins stated that he disagrees with Ms. Mason's comments concerning inspections. Explained that the purpose of the permit process is to ensure that inspections are conducted. Also discussed the recent closing of permits which allowed for added assessment.

Ms. Mason expressed concern with the increase in property taxes in Cranford. Feels there should be a simpler process in place for residents to appeal property taxes. Feels the Township Committee should change the process.

Mayor Kalnins explained that municipal government taxes are only a portion of the tax bill and the Township Committee does its best to keep its portion of the tax bill as low as possible.

Ms. Mason expressed concern with the Handyman Program that is offered to seniors in Cranford. Also discussed a portion of the tax bill that is required for the Cranford Library and feels it should not be required.

Mayor Kalnins explained that the Library's portion of the tax bill is mandated by the State of New Jersey.

Hearing no further comments, Mayor Kalnins closed the public comment portion of the meeting.

- Discussed the meeting in Washington DC with legislators to discuss the Rahway River flood control project. Urged residents to visit the Cranford website and submit letters of support to Congressmen and Senators;
- Wished Township Administrator Wall a speedy recovery.

On motion of Commissioner Hannen, seconded by Deputy Mayor O'Connor and passed, the Township Committee adjourned at 8:51 PM.
