WHEREAS, the Commission is a public body corporate and politic incorporated under the laws of the State of New Jersey that was established in or about 1996 under a joint agreement between Clark Township and Cranford Township providing for the creation and operation of the Golf Facility and providing, among other things, for the formation of a Golf Course Commission;

WHEREAS, it continues to be in the public interest of Clark Township and Cranford Township to facilitate for the benefit of Township residents the operation of a first-class Golf Facility, which includes a full-service restaurant:

WHEREAS, the parties continue to seek to maintain the full-service restaurant at the Golf Facility, and as such, to have the restaurant continue to serve alcoholic beverages under a permit or permits issued by the State of New Jersey, Department of Law and Public Safety, Division of Alcoholic Beverage Control;

WHEREAS, the parties desire to amend the Agreement as it pertains to the management and operation of the restaurant and food & beverage operations, and to extend the Agreement's term; and

WHEREAS, all other terms and conditions under the Agreement shall remain in full force and effect except as specifically amended herein;

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Cranford hereby authorizes the Mayor to execute a First Amendment to Agreement between Hyatt Hills Golf Course Commission and Revitalizing Auto Communities Environmental Response Trust and Racer Properties LLC, substantially in the form attached hereto and subject to approval by the Township Attorney.

PUBLIC COMMENTS

Mayor Kalnins opened the public comments portion of the meeting and asked if there were any questions or comments.

<u>John Pritchard, 42-44 West Holly Street</u>, spoke in support of military personnel and members of the community that were lost fighting in Vietnam. Sang a song in support of the military. Urged the Township Committee to request that legislators reactivate Muhlenberg Hospital and other hospitals in the area due to their proximity to Ground Zero.

Township Attorney Diane U. Dabulas, discussed litigation in connection with Cranford Development Associates (CDA) and provided an update of the appeal the Township filed concerning the Department of Environmental Protection's issuance of a Flood Hazard Area (FHA) permit to CDA and the Township's appeal of court action regarding CDA. Announced that both appeals were denied by the Appellate Division and the Township would review the opinions and decide if further review by the Supreme Court is necessary.

Rita LaBrutto, 104 Arlington Road, discussed the Appellate Division's decision and does not feel Cranford had appropriate legal representation. Discussed properties that she feels the Township failed to receive credit for as affordable housing units and also feels the Appellate Division's opinion indicates that the Township did not pursue affordable housing opportunities. Also discussed the decision regarding the site plan and stated that the Township did not object to any of the issues with the site plan. Discussed a statement in the Appellate Division's opinion which indicated that the application submitted by Woodmont Properties' for development of this property was denied by the Planning Board. Discussed the fact that this statement is not correct because Woodmont Properties withdrew its application. Also discussed the fact that the site plan hearings were heard by a Special Hearing Officer in the courthouse in Elizabeth rather than by the Planning Board in Cranford. Stated that the Appellate Division's opinion indicated that the site plan hearings were held in Elizabeth because of local hostility to the application and feels this statement is inaccurate. Also stated that Cranford Planning Board members never received a copy of the site plan and feels they had the right to receive a copy. Discussed an issue in which the site plan was erroneously sent to Deputy Mayor O'Connor's home address. Feels the site plan hearings should have been held at the Cranford Municipal Building during evening hours, not at another location during working hours. Also feels it is every resident's constitutional right to protect his/her property.

Deputy Mayor O'Connor referred to Ms. LaBrutto's comment concerning the site plan and it being sent to her home address in error and clarified that when this occurred, she immediately contacted the Township to have the plans picked up.

Township Attorney Dabulas explained to Ms. LaBrutto that she should not assume that all of the statements contained in the Appellate Division's opinion are accurate. Discussed instances in which CDA made factual allegations that were incorrect and were refuted by the Township's legal counsel.

Mayor Kalnins assured Ms. LaBrutto that the Township Committee is reviewing the Appellate Division's opinions and its options. The Township will continue to retain Jeffery R. Surenian & Associates as its lead representation concerning this matter. Suggested that residents provide input regarding the opinions to the Township. Feels all points of view should be considered.

Ms. LaBrutto discussed statements in the opinion as to local hostility toward the application. Also discussed soil sampling conducted by CDA on the property without proper authorization.

Hearing no further comments, Mayor Kalnins closed the public comment portion of the meeting.

PROFESSIONAL COMMENTS - None

COMMISSIONER REPORTS/COMMENTS

Commissioner Thomas H. Hannen, Jr.

- Discussed the FY 2016 Flood Mitigation Assistance (FEMA) Grant Program. Announced that the Township is interested in hearing from residents who are interested in participating in this program. Explained that it is a multi-year program and provided contact information for interested residents;
- Discussed the Appellate Division's opinions regarding the CDA litigation. Believes this project will exacerbate flooding within the Township and feels it is contradictory that FEMA is offering grant funding opportunities to the Township through the flood mitigation program for home elevation and the Department of Environmental Protection (DEP) is granting exemptions to allow development in an active floodway. Also expressed concern with the statement in the Appellate Division's opinion in which CDA is referred to as having no expectation of approval by the Planning Board based on residents' opposition to the application. It appears that the Appellate Division felt that residents expressing concerns with the application prejudiced the Planning Board. Explained that he does not understand this statement, as it is every citizen's right to petition its government, express opinion, and disagree when applicable. Assured residents that the Township Committee plans to keep all options open. Thanked all for their participation and encouraged residents to continue to provide input.

Commissioner Patrick F. Giblin

- Discussed the Appellate Division's opinions concerning the CDA litigation and stated that the Township would continue to fight against this project;
- Congratulated Allen Davis and Maya Jones on receiving the Student Outstanding Achievement Recognition Award;
- Congratulated the Fund for Excellence on hosting its first annual Trivia Night. Also congratulated the winners;
- Thanked all volunteers involved with the recent river cleanup;
- Thanked Township Administrator Wall for his efforts with the FY 2016 Flood Mitigation Assistance (FEMA) Grant Program.

Commissioner John Mallon

- Discussed the opinions concerning the CDA litigation and stated that he is also disappointed with the outcome. Assured residents that the Township Committee would continue to fight against this development and act in the best interest of the Township;
- Commended the Police Department on its Active Shooter Training Program. Feels this training is necessary in today's world and also feels honored to have participated in one of the training sessions. Explained that this training would be extended to all municipal employee and the schools for both teachers and students;
- Discussed an article in the Westfield Leader regarding Union County's tax increase and explained the impact to Cranford and its residents.

Deputy Mayor Mary O'Connor

• Discussed her attendance at the Appellate Division's hearings and stated that she is surprised that not one judge felt there was merit to the Township's case. Also stated that it is her opinion that the Township should continue to fight the decision. Believes it is worth the fight because residents deserve a continued commitment to this issue;

• Discussed complaints regarding airplane noise due to a change in flight patterns. Requested that all affected residents file a complaint with the Port Authority or contact her, and announced that information is available on the Township's website;

- Discussed the significant increase in Union County's taxes this year. Although it is not required, feels Union County should work at keeping its tax rate below the two (2%) percent CAP. Explained that the Township Committee has worked extremely hard to ensure its municipal tax rate is well below the CAP and one of the lowest in the county. Informed residents that she would be proposing a resolution requesting that Union County keep its budget within CAP;
- Congratulated members of the Fire Department and the Police Department on receiving the Group Effort Award at the New Jersey Valor Awards Banquet, stating that they were honored for their heroic team effort during a river rescue last September;
- Discussed the Active Shooter Training Program in which she participated. Feels the training is necessary in today's world and is hopeful that training would be extended to all public buildings;
- Announced that members of the Police Department have also participated in Stress Management Training;
- Discussed the Hillside Avenue School Spring Scramble;
- Mentioned that the Police Department, Fire Department, and Department of Public Works participated in the annual Dodge Ball Tournament, and the Fire Department celebrated its second annual victory;
- Discussed the Police Unity Tour and wished those officers participating good luck. Announced that funds would be raised to benefit the families of fallen officers;
- Congratulated Allen Davies and Maya Jones for receiving the Student Outstanding Achievement Recognition Award;
- Announced that the Cranford Spring Fair would be held this Sunday and hopes to see everyone there.

- Congratulated Allen Davies and Maya Jones on receiving the Student Outstanding Achievement Recognition Award and thanked Deputy Mayor O'Connor for establishing the program;
- Discussed the decision regarding the CDA litigation and his disappointment with the decision. Stated that the Township Committee would continue to fight against the decision and weigh all options;
- Discussed the hearing that was held on April 18, 2016 for the proposed development of the Casale property located on South Avenue in Garwood. Informed residents that there were statements made about some of Cranford's development projects during the hearing to which he disagrees. Feels Cranford's redevelopment projects have been beneficial to Downtown Cranford and the comments made during the hearing "diminished" those projects. Also discussed affordable housing credits that were obtained through those projects.
