WHEREAS, Fromage, a new restaurant, is located in a unique location on the fringe of the downtown commercial district and further, the existing building is located on the property line and thus any signage or awning would necessarily encroach on the Township Right-or-way; and

WHEREAS, the location of the restaurant fronts on Eastman Street although the address is on Miln Street. Former business located in this space indicated they closed in due in part to lack of visibility.

WHEREAS, Fromage proposes to place an awning which would encroach 3'11.5" into the Right-of-Way and the projected lighting and hanging sign will encroach 25" into the Township Right-of Way; and

WHEREAS, given the uniqueness of the location and building of Fromage, it is in the best interest of the Municipality and its citizenry for the municipality to grant consent to Fromage to occupy said Rights-of-Way within the Township for this purpose; and

WHEREAS the consent granted herein to Fromage is for the non-exclusive use by Fromage of the public Rights-of-Way for the stated purposes and will be subject to a Right-of-way use agreement.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Cranford hereby authorizes the Mayor and Township Clerk to execute a Right-Of-Way Use Agreement with Fromage governing the terms and conditions of the awning, lighting and signage to be installed in a form to be approved by the Township Attorney.
