- Congratulated the Eagle Scouts that were recognized this evening and feels their projects are beneficial to Cranford's community;
- Announced Cranford's Fourth of July events;
- Announced that the camping season at the Cranford West location in Hope, New Jersey would begin Fourth of July weekend through September. Provided contact information for anyone interested.

Commissioner John Mallon
