Ordinance No. 2016-22:

The Township Clerk read by title only Ordinance No. 2016-22 entitled, "AN ORDINANCE TO AMEND CHAPTER 124 "HOURS OF OPERATION" OF THE CODE OF THE TOWNSHIP OF CRANFORD" Said ordinance having been advertised and posted in accordance with law, Commissioner Mallon opened the public hearing.

Jason Tuvel, attorney representing Seven-Eleven Inc., informed the Township Committee of a pending application before the Zoning Board of Adjustment for a Seven-Eleven convenience store. Discussed the benefits of twenty-four (24) hour businesses. Also discussed the legal standards concerning hours of operation and explained that business operations are a constitutional property right and evidence/data is required in order to restrict hours of operation. Discussed an Open Public Records Act (OPRA) request that was submitted for notes, data, etc. related to Ordinance No. 2016-21, and stated that it is his understanding that no such records exist. Requested that the Township Committee postpone the adoption of Ordinance No. 2016-22 and allow businesses to open and operate under the Township's current ordinance, with the proper measures in place, and if problems occur, the ordinance could be revisited at the appropriate time, with the appropriate data collected.

Peter McArthur, Azrack & Associates, 627 Newark Pompton Turnpike, Pompton Plains, spoke on behalf of Quick Chek, Corp., and informed the Township Committee that Quick Chek is currently a land use applicant in Cranford. Feels Ordinance 2016-22 is unconstitutional "on its face", and as it applies specifically to his client and the property. Stated that there are witnesses present to provide testimony concerning Quick Chek's application.

Township Attorney McCarthy explained that this is a public hearing for an ordinance, not a trial or a hearing before a land use board. Anyone is permitted to speak on the ordinance, but testimony is not taken.

Mr. McArthur stated that he has been permitted to present testimony in other municipalities and asked that his opposition to Mr. McCarthy's opinion be noted for the record.

<u>Tung-to Lam, Bohler Engineering</u>, stated that he has reviewed the ordinance and the proposed requirements for convenience stores and gasoline service stations located within 200 feet of a residential area. Does not feel noise would be a factor because noise from the existing roadway far exceeds noise that would be created by the business' operation. Also stated that the applicant has complied with state regulations if there are safety concerns with the gas station.

Township Attorney McCarthy Mr. Lam's comments are more appropriate for a land use board and requested that his comments be related to the nature of the ordinance pending before the Township Committee.

<u>Peter McArthur, Azrack & Associates, 627 Newark Pompton Turnpike, Pompton Plains, reiterated his prior comment, stating that the ordinance is unconstitutional as applied to the application and the property.</u>

Matthew Seckler, Senior Project Manager, Stonefield Engineering Design, 75 Orient Way, Rutherford, New Jersey, discussed a traffic study that was conducted in connection with the Quick Chek application. Explained that this type of use basically "lives" off of the traffic on the roadways around it because it is not a destination use, such as a movie theater or a restaurant. Also feels there would be little impact to traffic during the overnight hours and no pedestrian traffic would be generated. As such, feels there would be very little impact to the residences within 200 feet of the site. Overall, feels the operation during the overnight hours would have little impact to traffic and noise from vehicles.

John McDonough, Professional Planner, stated that he testified on behalf of the Quick Chek application at the Zoning Board of Adjustment meeting a few weeks back. Discussed the criteria Planner's use when establishing an ordinance. Feels the Quick Chek application is a good application because it is repurposing a blighted, underutilized building along the corridor, which is in line with the Township's Master Plan and the land use ordinance adopted in 2014.

Mr. McCarthy explained that the Township Committee is not considering Quick Chek's land use application, and is prohibited from doing so. Further explained that the ordinance being considered by the Township Committee is not a land use ordinance.

Mr. McDonough feels that Ordinance 2016-22 is a "de facto" land use ordinance because it impacts use and distances, which are two of the core reasons why land is regulated in New Jersey. Feels a twenty-four (24) hour business provides a public benefit. Discussed statistics for commuting times and stated that commuting has increased during the hours between 12:00 AM and 6:00 AM. Also discussed overnight and shift workers, such as first responders and hospital workers, who depend upon twenty-four (24) hour businesses. Feels the Township Committee should carefully consider this ordinance.

<u>Peter McArthur, Azrack & Associates, 627 Newark Pompton Turnpike, Pompton Plains,</u> discussed the provision of Ordinance 2016-22 as it relates to the location of a gasoline service station and convenience store within 200 feet of a residence and case law related to that provision.

Mayor Kalnins provided clarification and explained to Mr. McArthur that the ordinance does not restrict gas stations and convenience stores from being located within 200 feet of a residence, it restricts the hours of operation if they are located within 200 feet of a residence.

Mr. McArthur stated that he respectfully disagrees with Mayor Kalnins' comment. Discussed the "essence" of the conditional use concept and feels the Quick Chek application is being "arbitrarily and automatically excluded from eligibility of the conditional use standard section of the ordinance". Discussed testimony he provided to the Zoning Board of Adjustment concerning this application. Also stated that he believes Ordinance 2016-22 violates the Time of Application Rule, explaining that that the ordinance changes the application from a conditional use variance to a use variance during the pendency of the proceeding, which is illegal pursuant to land use law. Feels, if adopted, Ordinance 2016-22 would discriminate against Quick Chek in favor of a competitor. Also referred to reports submitted by the Cranford Fire Department and Cranford Police Department concerning Quick Chek's application which indicate that there would be no issue with overnight hours. Respectfully requested that the Township Committee refrain from adopting Ordinance 2016-22.

<u>Marla Sattler</u>, 812 <u>Springfield Avenue</u>, stated that she has been a resident of Cranford for twenty (20) years, and has no need to utilize a twenty-four (24) hour business. Stated that she is opposed to a Seven-Eleven or twenty-four (24) hour business in her neighborhood. Stated that if this was a question on the ballot, she would vote against it.

Wendie Walsh, 24 Lincoln Avenue, referenced comments by previous speakers as to Ordinance 2016-22 being unconstitutional. Feels residents also have constitutional rights. Stated that she lives three doors from the proposed location of the Seven-Eleven, and disagrees with statements that this business would have no impact to noise. Explained that if this ordinance is not adopted, future and existing businesses would want twenty-four (24) hour operations. Requested clarification as to who monitors the security measures outlined in the ordinance. Also asked if individuals working from home were included in the statistics provided by a previous speaker. Stated that she is opposed, for the record, to twenty-four (24) hour businesses.

<u>Jason Tuvel</u>, attorney representing Seven-Eleven Inc., stated that the ordinance is unclear as to enforcement of existing stores and applications that have already been filed. Stated that Seven-Eleven reserves its rights as to invoking the Time of Application rule.

Commissioner Hannen referred to Mr. Tuvel's previous statement concerning the benefits of twenty-four (24) hour businesses and asked Mr. Tuvel if he could provide information concerning the proximity of Seven-Eleven stores in other communities that border Cranford.

Mr. Tuvel stated that he would have to obtain that data from Seven-Eleven, Inc.

Commissioner Hannen discussed Seven-Eleven stores in neighboring towns, stating that he is uncertain as to their proximity to Cranford's border, and that he is interested in this information. Feels those stores in close proximity to Cranford currently provide the benefits described by Mr. Tuvel.

Mr. Tuvel explained that regardless of the proximity of other Seven-Eleven stores to Cranford, the Township Committee does not have the right to adopt an ordinance restricting the hours of a business without obtaining data that demonstrates there is a problem or a public need to restrict hours of operation. Feels the issue should be revisited if problems are created from twenty-four (24) hour businesses. This would also allow the Township to collect the proper data.

<u>Marla Sattler</u>, 812 Springfield Avenue, referred to Mr. Tuvel's previous comment and feels it would be a mistake to allow something to move forward and address the problems that are created after the fact.

Mayor Kalnins provided clarification of the ordinance and explained that the Township currently allows twenty-four (24) hour businesses. The ordinance being proposed would restrict the hours of operation between the hours of 12:00 AM and 5:00 AM if those businesses are located within 200 feet of a residence.

<u>Peter McArthur, Azrack & Associates, 627 Newark Pompton Turnpike, Pompton Plains, provided the Township Committee with an exhibit demonstrating the proximity of the proposed Quick Chek to residential and commercial sites.</u>

Commissioner Hannen asked if Mr. McArthur is aware of the location of Quick Chek stores and other convenience stores in proximity to Cranford.

Mr. McArthur stated that he is not aware of those stores in proximity to Cranford.

Wendie Walsh, 24 Lincoln Avenue, discussed the proximity of convenience stores in other municipalities to Cranford and stated that they are less than one mile from Cranford.

Mayor Kalnins explained that this ordinance does not pertain to any specific location or application that might be before another board. It also does not ban the use of convenience stores or gas stations, it pertains to hours of operation and only in certain areas that are considered to be characteristic of residential neighborhoods. Lastly, the state law defers planning use to the municipality, and the Township enacts land use ordinances which are within the overall character of the municipality.

Mr. McCarthy also explained that Ordinance 2016-22 is not a land use ordinance, otherwise it would have been referred to the Planning Board. It is an ordinance that is enacted under the Township's general police powers.

Hearing no further comments, Commissioner Mallon closed the public hearing.

WHEREAS, the shutdown of the TTF detrimentally effects the Township of Cranford's ability to provide a safe and effective Train Station for its citizens, to provide safe travel on the roadways of the Township and detrimentally effects the finances of the Township of Cranford.

- Announced that the Cranford Fire Department was asked to participate in the Urban Water Rescue Team, which consists of Union County municipalities prone to flooding. As per the Urban Water Rescue Team leader, the Cranford Fire Department was the best group to work with and its positive attitude and eagerness to learn placed them above other municipalities. As a result of its participation, Union County provided the Fire Department with four (4) new water rescue suits, and a new boat might be purchased for the department. Commended Cranford firefighters for their efforts;
- Thanked everyone who supported National Night Out. Feels the event was a success and commended Detective Reider for efforts in coordinating the event;

• Announced that Towns Hall meetings would be held in the fall to inform the public of progress being made concerning capital improvements. The first meeting is scheduled for September 15, 2016 and the pedestrian safety project will be the topic;

- Mentioned that the Pepperidge Tree project would begin this fall and would involve harvesting old saplings from the site. Additional information will be available on the Township's website in early September;

- Extended best wishes to students going back to school and encouraged drivers to be mindful of children and to drive safely.
