**WHEREAS**, the Property most recently contained a building used as a gathering and worship space which was not consistent with the zoning laws in the Township of Cranford and previously was a residential home;

**WHEREAS**, the Property was demolished by the Currens and a single-family home was constructed which was consistent with the zoning laws in the Township of Cranford; and

**WHEREAS**, the Township of Cranford Zoning Official imposed the Development Fee Ordinance on the Property, however, the Currens objected on various basis including but not limited to fact that the purposed of the Development Fee Ordinance was not directed to the expansion of a single family home; and

**WHEREAS**, the Development Fee Ordinance applies to an increase in "density," where density is defined narrowly as an increase in "dwelling units per gross area of land," N.J.S.A. 40:55D-4; and

**WHEREAS**, the Currans are not increasing the Property's density but rather replacing a non-conforming structure with a conforming structure frequently-occupied building for another and which new structure is likely *decreasing* the Property's impact on the Township as there will be a reduction of the traffic in their neighborhood since the previous use of the Property was for regular church meetings, where large groups of people would congregate; and

**WHEREAS,** the Township Committee agrees that the use of the Property as a single family home is a more consistent use with the Township of Cranford Master Plan and zoning code and that the demolition and construction of a single family home in these particular circumstances are not consistent with the application of the Development Fee Ordinance.

WHEREAS, the Township Committee of the Township of Cranford has legitimate concerns about the safety of its residents in Lenape and Nomahegan Parks during the Deer Management Program due to the existence of playground equipment in the park in the vicinity of hunters who carry or discharge weapons; and

**WHEREAS**, the Township Committee of the Township of Cranford requests that if the Deer Management Program occurs, the parking lots and playground area of Lenape and Nomahegan Parks shall be closed during the specific days of the 2017 Deer Management Program;

**NOW, THEREFORE, BE IT RESOLVED** that the Township of Cranford respectfully requests that if the Union County Freeholders approve the 2017 Deer Management Program in Lenape and Nomahegan Parks, it is requested that the County of Union provide signage at all entrances to the Lenape and Nomahegan Parks stating ACTIVE HUNTING FIREARMS IN USE WARNING TO USE CAUTION AND TO STAY ON TRAILS OR PATHS and close the parking lot and playground area on all the days of the Deer Management Program.

#### **PUBLIC COMMENTS**

Mayor Kalnins opened the public comments portion of the meeting and asked if there were any questions or comments.

George Galan, 513 Lexington Avenue, discussed a letter that was distributed to several homes requesting that residents share their concerns with traffic issues in the Township. Feels there has been a good response to the letter and asked the Township Committee what would be required to have these issues addressed or resolved. Feels speed bumps and rumble strips are viable solutions. Also commended the Township for the quality of work of paving done on Lexington Avenue, but the improvements have resulted in speeding. Shared various concerns expressed by residents with the Township Committee, such as obstructions at intersections, motorists disregarding stop signs, and the potential for additional crossing guards. Feels there are solutions that could be implemented on a temporary basis and requested information as to the next step in the process.

Mayor Kalnins suggested that any letters/information be provided to the Township Committee, which would be forwarded to the Police Department for review. Also feels a discussion could be held with Lieutenant Davenport of the Traffic Division.

Mr. Galan also stated that he has been monitoring the speed bumps located on Willow Grove Road in Westfield. Feels they are a successful traffic calming measure and could be an option for Cranford. Commended the Police Department for its efforts and thanked the Township Committee for its time and consideration.

Mayor Kalnins thanked Mr. Galan for providing the Township Committee with possible solutions and stated that the information he provided would be forwarded to Lieutenant Davenport for review. Also suggested participation in the Citizens Police Academy, as it provides residents with an opportunity to work with the Police Department directly, through classroom lectures and hands on demonstrations in many areas.

Deputy Mayor O'Connor discussed efforts made by the Police Department to resolve traffic issues. Feels that one of the many benefits offered by Cranford is education, and discussed various educational programs conducted by the Police Department.

Commissioner Hannen thanked Mr. Galan and other residents for attending this evening. Discussed the Township Committee's review of various committees for 2017 and the high level of volunteerism in Cranford. Feels a new volunteer committee should be considered to address traffic issues.

<u>Barbara Krause</u>, 20 <u>Pittsfield Street</u>, thanked the Township Committee for their service in 2016. Also thanked Commissioner Mallon for his service. Commented on the tree preservation ordinance and feels Cranford should put itself among "forward thinking" communities in this regard. Feels trees are one of the main reasons people move to Cranford. Mentioned that this ordinance is basically for the protection and enhancement of Cranford's environment and would be used as a mechanism to monitor trees that are being removed.

Mrs. Krause also requested clarification of Resolution No. 2016-373 and asked when the deer hunt would be conducted.

Commissioner Giblin stated that the deer hunt would be conducted on Mondays in January and February.

Mrs. Krause discussed her attendance at a recent luncheon at which many were discussing an issue with the deer population. Feels a deer management program is necessary because she feels the deer population creates safety issues.

Mayor Kalnins thanked Mrs. Krause for her comments.

<u>Tina Helmstetter</u>, 70 <u>Burnside Avenue</u>, thanked the Township Committee for their time and consideration on the tree preservation ordinance. Discussed the number of years in which the ordinance was discussed. Also discussed its benefits and thanked the Township Committee for moving forward with the ordinance.

Mayor Kalnins stated that he recently returned to his hometown and noticed that many trees have been removed.

<u>Jessica Orr, 7 Mitchell Place</u>, thanked Commissioner Hannen and Commissioner Giblin for donating the pedestrian safety stanchion. Also thanked the Police Department and the Township Committee for efforts made with the implementation of recent pedestrian safety measures.

Mayor Kalnins referred to Commissioner Hannen's comment regarding the creation of a new committee to address traffic safety issues, and encouraged residents to volunteer.

Anthony Durante, 100 Bloomingdale Avenue, thanked the Township Committee for their service and efforts regarding pedestrian safety. Also discussed the suspension of parking meter fees during the holiday season and asked the Township Committee to consider keeping the fees in place next year. Feels the fees collected at that time could be dedicated funding for downtown projects/initiatives.

<u>John Nowakowski, 507 Lexington Avenue</u>, discussed issues with traffic on Lexington Avenue, such as speeding and vehicle damage, and feels it is a safety issue for residents of the area. Also discussed poor lighting on the roadway. Feels a four-way stop should be considered at the corner of Denman Road and Lexington Avenue.

Mayor Kalnins assured Mr. Nowakowski that his request would be considered and PSE&G would be contacted to address the lighting issue.

<u>Patricia Gallagher, 15 Alan Okell Place,</u> discussed the intersection at Walnut Avenue and Chester Lang Place. Feels the intersection is dangerous and pedestrian safety measures should be considered.

Mayor Kalnins explained that Walnut Avenue is a Union County road and Union County would need to be contacted.

Ms. Gallagher also discussed issues with the corner of South Union Avenue and Lexington Avenue. Feels a flashing stop sign should be considered.

Mayor Kalnins discussed traffic data that is reviewed to determine if pedestrian safety measures are required and if necessary, the type that should be installed.

Ms. Gallagher also asked who coordinates the placement of speed signs on roadways. Feels there is no point in having the signs if they are not used.

Deputy Mayor O'Connor explained that the signs are not used continuously because complacency can occur.

Commissioner Mallon also explained that the speed signs run on battery power and need to be used on a schedule.

Ms. Gallagher discussed the potential for obtaining solar powered speed signs.

Hearing no further comments, Mayor Kalnins closed the public comment portion of the meeting.
