**WHEREAS**, the TSP includes consists of two alternative project elements in three different areas in the circumference of the Rahway River Basin: Alternative 4a, which includes channel improvements in Cranford, N.J. and modification to the Orange Reservoir Dam spillway in West Orange, N.J., and Alternative 2a, which is a non-structural plan in the 10-year floodplain for the Robinson's Branch in the City of Rahway, N.J.; ad

**WHEREAS**, The TSP provides various levels of flood risk management to the Townships of Cranford, Springfield, Millburn, and the City of Rahway;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Cranford that the Township Committee hereby urges that the U.S. Army Corps of Engineers adopt Alternative 4a. as its Tentatively Selected Plan, complete the Integrated Feasibility Report and Environmental Impact Statement, and commence construction on the project elements in 2017 to address the flooding problems in the Rahway River Basin; and

**BE IT FURTHER RESOLVED** that a copy of this resolution be sent to the U.S. Army Corps of Engineers, New York District Planning Division-Environmental Branch, to Congressman Leonard Lance, to the Commissioner of the New Jersey Department of Environmental Protection, to Senators Menendez and Booker, the Union County Board of Chosen Freeholders, and the Union County municipalities of Springfield, Union, Clark and Rahway, Kenilworth and Winfield.

Mayor Hannen opened the public comments portion of the meeting and asked if there were any questions or comments

Kent Lucas, 17 Beech Street, Captain of the Cranford First Aid Squad, wished a Happy 100<sup>th</sup> Birthday to his neighbor.

Mr. Lucas also discussed the First Aid Squad's goals and accomplishments for 2016. Discussed the amount of phone calls received, the purpose of each call, and the number of volunteers available to respond. - Discussed the snow that occurred over the weekend and reminded residents of snow removal regulations, and of those roads that are considered snow emergency streets. Asked those who reside near fire hydrants to clear them from snow. Also mentioned that information concerning snow removal is located on the Township's website and the map of snow emergency streets is located in the Township's newsletter;
- Discussed the "See Click Fix" app that allows residents to alert the Township of potholes;
- Discussed the Army Corps of Engineers' public information meeting scheduled for January 11, 2017 to
  discuss the draft Integrated Feasibility Report and Environmental Impact Statement in connection with
  the Rahway River Flood Risk Management Study. Explained that these are extremely important flood
  mitigation efforts for Cranford and encouraged residents to attend and provide comment. Informed
  residents that a second meeting would be held on Thursday, January 12, 2017 at the Rahway Public
  Library;
- Discussed the Municipal Alliance's presentation during the Township Committee's Workshop Meeting of January 9, 2017 and requested that Township organizations enforce a zero tolerance policy with respect to alcohol at children's events. Quoted the Municipal Alliance's motto, "In Cranford 21 Means 21":
- Announced that the Cranford Clergy Council invites everyone to attend the Dr. Martin Luther King, Jr. ceremony. Also announced that residents are invited to volunteer at the Fourth Annual Cranford Community Service Project Fair in honor of Dr. Martin Luther King.

# **Commissioner Andis Kalnins**

- Announced that the 2017 Municipal Budget process has begun and discussed the Workshop Meeting scheduled for Saturday, February 4, 2016 for budget presentations. Stated that updates would be provided as the process continues, and thanked all Township professionals for their efforts with the budget;
