INFORMAL MEETING

Mayor Hannen opened the informal meeting portion of the meeting and asked if there were any questions or comments.

<u>Frank Krause, 20 Pittsfield Street</u>, referenced a previous meeting in which the Township Committee authorized the purchase of the Birchwood Avenue property and discussed the history and hydraulic engineering issues related to the site. Stated that former Township Engineer Gregory Sgroi was responsible for the construction of two detention basins in Cranford, and had intended to construct a third. Feels Mr. Sgroi's files, which were

provided to the Township after his passing, are very beneficial. Also discussed measurements taken by former Township Engineer Rick Marsden in connection with the detention basin and stream water in the Birchwood Avenue area. Discussed advantages a third detention basin would provide to the Township if it were simultaneously constructed with the Birchwood site. Feels it would be disappointing if the Birchwood Avenue site were to flood after it is developed, and is hopeful that the Township Committee will look into the studies conducted by both former Township Engineers.

Hearing no further comments, Mayor Hannen closed the informal meeting portion of the meeting.

RESOLUTION AUTHORIZING THE EXECUTION OF THE FIRST AMENDMENT TO AGREEMENT FOR SALE OF REAL ESTATE FOR THE ACQUISITION OF CERTAIN PROPERTIES KNOWN AS BLOCK 291, LOT 15.01 AND BLOCK 292, LOT 2, A/K/A 215 AND 235 BIRCHWOOD AVENUE FOR PURPOSES OF REDEVELOPMENT AND MODIFICATION TO A CONTINGENT RE-PURCHASE AGREEMENT FOR THE BUY-BACK OF THE PROPERTIES

WHEREAS, Pursuant to Resolution No. 2016-394, the Township of Cranford ("Purchaser" or the "Township") Entered into an Agreement for Sale of Real Estate with Samuel P. Hekemian, Peter S. Hekemian, Richard Hekemian, Mark Hekemian and Cranford Development Associates, LLC ("CDA") (collectively, "Seller") dated January 5, 2017 ("Sale Agreement") to acquire certain properties known as Block 291, Lot 15.01 and Block 292, Lot 2 a/k/a 215 and 235 Birchwood Avenue in the Township of Cranford, Union County, New Jersey (the "Property");

WHEREAS, Purchaser and Seller have reached agreement to change certain provisions of the Sale Agreement;

WHEREAS, Purchaser and Seller intend to memorialize their agreement by executing a First Amendment to Agreement for Sale of Real Estate ("First Amendment");

NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Cranford, in the County of Union, New Jersey does hereby authorize execution of the First Amendment, with the following salient provisions:

- 1. The Township's Due Diligence Period set forth in Section 9 of the Agreement and the Due Diligence Termination Date shall be extended to expire at 11:59 P.M. EST, Tuesday, January 24, 2017.
- 2. The Township agrees that it will not conduct any invasive investigation or testing on the Property prior
- 3. At Closing, Seller will place \$250,000 for nine months with the Escrow Agent ("Environmental Escrow Holdback") for the purpose of reimbursing the Township for remediation costs it may incur for

remediation of conditions in violation of Environmental Law, including but not limited to contamination of soil and groundwater or any hazardous waste, solid waste or other non-native debris present prior to Closing and expressly excluding site investigation costs and fees ("Remediation Costs").

- 4. The Re-Purchase Agreement attached to the Agreement as Exhibit E will be replaced with a new Re-Purchase Agreement that:
 - a. Reflects the change in terms of the purchase price in favor of a conventional tax structure from \$50,000/unit to \$63,000/unit based on construction of 225 housing units and other terms; and
 - b. CDA is prohibited from conducting invasive investigation or testing on the Property during CDA's due diligence period through closing, except to the extent CDA's Preliminary Assessment and/or Phase I Environmental Site Assessment identifies new Areas of Concern ("New AOCs") that did not exist on the date the Township acquired of the Property.
- 5. The Closing Date set forth in Section 6 of the Agreement shall be extended from 10 A.M. January 31, 2017 to 10 A.M. February 7, 2017.
- 6. Certified to be a true copy of a resolution adopted by the Township Committee of the Township of Cranford at a meeting held January 24, 2017.

PUBLIC COMMENTS

Mayor Hannen opened the public comments portion of the meeting and asked if there were any questions or comments. Hearing no comments, Mayor Hannen closed the public comment portion of the meeting.

PROFESSIONAL COMMENTS - None

COMMISSIONER REPORTS/COMMENTS

Commissioner Mary O'Connor

- Discussed the Street Smart Program to be initiated in the spring by the Cranford Police Department and the North Jersey Transportation Authority. Explained that the program addresses pedestrian safety concerns through education and enforcement, and its fundamental aspect is to change the behavior of both drivers and pedestrians to create a safer environment for everyone. Stated that the public would be kept informed of important dates and information related to the program. Also urged those walking and running outside in the dark to wear reflective gear or light colored clothing;
- Discussed the Army Corps of Engineers' public information meeting that was held at Union County College, and thanked residents who attended. Explained that the Township is working on consolidating all of the information concerning this initiative to one area on the website in an effort to keep residents updated on the project through its various stages. Provided the Army Corps of Engineers' website address for those interested, and announced that the public comment period has been extended to February 7, 2017. Urged residents to take advantage of this opportunity and to submit comments. Also announced that members of the Township Committee would be traveling to Washington DC next month to show its continued support for the project, its funding and to hopefully expedite the process;
- Congratulated the 2017 recipient of the Martin Luther King, Jr. award;
- Discussed her appointment as Commissioner of Public Affairs and discussed plans to improve the communication of events and initiatives through social media and other platforms. Encouraged residents to contact her with any ideas they may have in this regard;
- Announced that she would be holding office hours for residents once a month beginning February 7, 2017:
- Thanked Redevelopment Attorney Wanda Monahan, former Township Attorney Diane Dabulas, Township Attorney Ryan Cooper, and Township Administrator Terence Wall for their efforts with the Birchwood Avenue project. Feels this transaction will help move the Township in a positive direction.

Commissioner Andis Kalnins

- Discussed his attendance at the Chamber of Commerce's 2017 Retreat. Also discussed the role of the Chamber of Commerce and encouraged residents to support local businesses;
- Announced that the Chamber of Commerce's kickoff party would be held on January 31, 2017. Explained that this is a networking event and encouraged residents to participate and meet business owners. Provided information for those interested;
- Discussed the Mayors Council on the Rahway River Watershed. Stated that he would be attending the next meeting in Washington DC, the purpose of which is to request that legislators expedite the project. Encouraged residents to continue to contact legislators regarding this initiative;
- Announced that a Budget Workshop Meeting has been scheduled for Saturday, February 4, 2017 from 8:00 AM until 12:00 PM and invited the public to attend. Stated that he would also be holding office hours for residents wishing to meet with him regarding the 2017 Municipal Budget.

Commissioner Ann Dooley

• Discussed the recent nor'easter and preparation methods that were taken. Also discussed de-silting plans for the Rahway River and improvements planned for the flood gates;

- Discussed a cost proposal for improvements to the WWI Flagpole located at Post Office Plaza and discussed the schedule for those improvements, weather permitting;
- Discussed the Birchwood Avenue project and congratulated everyone on the committee for their efforts in investigating and analyzing the pros and cons related to this transaction. Also extended her thanks to Mayor Hannen, Redevelopment Attorney Wanda Monahan and Township Administrator Terence Wall for their efforts with this issue;
- Congratulated Cranford resident Carol Blazejowski on being named to the New Jersey Hall of Fame.

Deputy Mayor Patrick Giblin

- Discussed various events being hosted by the Friends of the Public Library and provided contact information for those interested in attending;
- Announced that there would be a 2017 Municipal Budget meeting on Saturday, February 4, 2017 from 8:00 AM till 12:00 PM. Explained that the goal is to hold a meeting at a time that might be more convenient to residents and encouraged residents to attend;
- Announced that the river cleanup would take place on April 22, 2017 and a meeting is scheduled for March 22, 2017 for those interested in participating;
- Extended his appreciation to public safety personnel for their efforts when his son was bitten by a dog. Stated that the Fire Department's Emergency Medical Services personnel and Police Department personnel were very professional and responsive.

Mayor Thomas H. Hannen, Jr.

- Extended his thanks to the professionals involved with the Birchwood Avenue property;
- Encouraged residents to submit letters to the Army Corps of Engineers in support of the proposed regional flood mitigation project. Also discussed the Township's efforts to expedite the process;
- Announced that the Army Corps of Engineers would be holding another public meeting on January 26, 2017 in City Hall in the City of Orange. Encourage residents to attend if they missed previous meetings;
- Discussed additional information that is posted on the website in connection with Township Committee meeting agendas.
