PUBLIC COMMENTS

Mayor Hannen opened the public comments portion of the meeting and asked if there were any questions or comments.

John Pritchard, 42-44 West Holly Street, feels politicians need to understand the difference between legal and illegal immigrants. Expressed concern with Sanctuary cities and does not want Cranford to be involved with that initiative. Also expressed concern with certain actions by Mayor DiBlasio of New York City. Spoke in support of military personnel and members of the Cranford community who were lost fighting in Vietnam. Sang a song in support of the military. Urged the Township Committee to request that legislators reactivate Muhlenberg Hospital and other hospitals in the area due to their proximity to Ground Zero.
