#### Preeclampsia

The Township will, to the best of its ability, attempt to comply with respect to the limitations on issuance of tax-exempt obligations pursuant to Section 265(b)(3) of the Code; however, said Township does not covenant to do so, and hereby expressly states that a covenant is not made hereby.

<u>SECTION 5</u>. The issuing officers of the Township be and they hereby are authorized to deliver a certified copy of this resolution to the original purchaser of the Note and to further provide such original purchaser with a certificate of obligations issued during the calendar year 2017 dated as of the date of delivery of the Note.

#### **PUBLIC COMMENTS**

Mayor Hannen opened the public comments portion of the meeting and asked if there were any questions or comments.

John Pritchard, 42-44 West Holly Street, discussed the Police Department awards presented earlier this evening and stated that he was pleased that these officers were recognized. Also commended the Fire Department for their efforts. Discussed police officers and firemen who lost their lives on 9/11. Announced that Armed Forces Day and Memorial Day are in the month of May and feels residents should always remember those who served our country and those who were lost during war. Sang a song in support of the military. Urged the Township Committee to request that legislators reactivate Muhlenberg Hospital and other hospitals in the area due to their proximity to Ground Zero.

<u>Frank Krause</u>, <u>20 Pittsfield Street</u>, discussed safety issues he believes exists along Springfield Avenue and feels the Township Committee should consider investigating a reduction in the speed limit from 35 mph to 25 mph.

Dr. Krause also discussed the role of the Planning Board and Zoning Board of Adjustment and the role of the Zoning Officer. Feels the Planning Board's operations are acceptable because the Mayor and a Commissioner are members.

Dr. Krause discussed the role of the Zoning Board of Adjustment and the role and authority of the Zoning Officer. Stated that all major decisions concerning variances are made by the Zoning Board of Adjustment rather than the Zoning Officer. Also discussed the Zoning Board of Adjustment's decisions with respect to specific applications. Feels the Zoning Board of Adjustment does not have the right to plan and feels certain decisions were made because of input of residents. Discussed the application submitted by 7-Eleven and stated that residents opposed to this application were upset with the cost they incurred to oppose the application.

Mayor Hannen explained that the Township Committee is not permitted to comment due to pending legal matters.

Dr. Krause feels the Township Committee has the ability to appeal decisions of the Zoning Board of Adjustment. Also feels notice to residents of applications to be heard by the Zoning Board of Adjustment needs to improve.

Commissioner Dooley discussed the appointment of a new Zoning Officer and efforts to reorganize the Office of Planning and Zoning. Feels improvements will occur in this area. Also discussed noticing requirements, and although discussion has been held concerning potential changes to noticing requirements, there is little that can be done because they are set by statute. Also discussed the potential for having more applications heard by the Planning Board, in an effort to remove some of the burden from the Zoning Board of Adjustment. Informed Dr. Krause that this has been considered but requires a legal analysis by attorneys to determine those applications that can be heard by the Planning Board

Dr. Krause asked Commissioner Dooley to clarify the definition of variance.

Commissioner Dooley explained that she cannot comment on a particular application but explained that a use variance must be heard by the Zoning Board of Adjustment.

Hearing no further comments, Mayor Hannen closed the public comment portion of the meeting.

- Discussed the Preeclampsia Walk that took place last weekend. Stated that many lives are touched by this disease and discussed the symptoms related to this condition;
- Discussed the Memorial Day Parade and provided information for those interested in attending events planned for the weekend. Encouraged residents to support veterans and to remember those who made the ultimate sacrifice;
- Discussed the events held during Cranford Family Weekend;
- Discussed the Annual Service Academy Fair to be hosted by Senator Leonard Lance and provided information for those interested in attending;
- Stated that he has received many inquiries regarding the application submitted for 750 Walnut Avenue and explained that the applicant is requesting that the Township consider rezoning the property.

#### **Commissioner Ann Dooley**

- Discussed the capital budget as respects road repaving and the replacement of DPW equipment. Discussed the road resurfacing program and explained that she is not convinced that the five-year road re-pavement plan developed in 2014/2015 is appropriate for Cranford's current needs, and feels these needs were exasperated by the challenging years of recession and the financial impact it had on the Township. Explained that the plan resulted in a thirty (30%) percent reduction in funding for road resurfacing for 2017 and 2018, and feels this needs to be readdressed during the 2018 budget process. Explained that some additional funding was identified during the 2017 budget process for roadwork and the replacement of DPW equipment, and discussed the age of current DPW equipment. Also explained that the DPW equipment selected for replacement is used for the repair and preservation of roads. Stated that the increase over last year's capital budget is \$300,000, which calculates to less than a \$14 increase per residence. Also assured residents that the selection of roadways for paving would be based on engineering, construction and maintenance assessments. Feels the 2018 budget should be more strategic and less ad hoc, with the goal of improving the sequence and efficiency of work. Thanked everyone who voted in favor of the capital budget.

#### **Deputy Mayor Patrick Giblin**

- Discussed the Memorial Day Parade and the number of Cranford residents lost in various wars. Provided information for those interested in attending Memorial Day events;
- Discussed the Office of Emergency Management (OEM) meeting to be broadcasted on TV35 and encouraged residents to watch the meeting when it is aired. Explained that OEM meetings are held to prepare Cranford for any and all emergencies it might face. Mentioned that OEM is seeking volunteers with experience and provided contact information for those interested;
