WHEREAS, on May 22, 2013, Honorable Lisa F. Chrystal, J.S.C. entered a Final Judgment of Compliance in favor of the Township of Cranford; and

WHEREAS, among other things, the Judgment of Compliance approved the Township's <u>Mount Laurel</u> development fee ordinance; and

WHEREAS, the development fee ordinance establishes an affordable housing trust fund that may include, for example, development fees, payments from developers in lieu of constructing affordable units on-site, barrier free escrow funds, rental income, repayments from affordable housing program loans, recapture funds, and proceeds from the sale of affordable units; and

WHEREAS, regulations adopted by the New Jersey Council on Affordable Housing_("COAH") have consistently required a municipality with an affordable housing trust fund to receive approval of a Spending Plan by COAH prior to spending any of the funds in its housing trust fund; and

WHEREAS, these regulations required a Spending Plan to include the following:

1. A projection of revenues anticipated from imposing fees on development, based on pending, approved and anticipated developments and historic development activity;

2. A projection of revenues anticipated from other sources, including payments in lieu of constructing affordable units on sites zoned for affordable housing, funds from the sale of units with extinguished controls, proceeds from the sale of affordable units, rental income, repayments from affordable housing program loans, and interest earned;

3. A description of the administrative mechanism that the municipality will use to collect and distribute revenues;

4. A description of the anticipated use of all affordable housing trust funds;

5. A schedule for the expenditure of all affordable housing trust funds;

6. If applicable, a schedule for the creation or rehabilitation of housing units;

7. A pro-forma statement of the anticipated costs and revenues associated with the development if the municipality envisions supporting or sponsoring public sector or non-profit construction of housing; and

8. A plan to spend the trust fund balance within four years of COAH's approval of the Spending Plan, or in accordance with an implementation schedule approved by COAH;

9. The manner through which the municipality will address any expected or unexpected shortfall if the anticipated revenues are not sufficient to implement the Plan; and

10. A description of the anticipated use of excess affordable housing trust funds, in the event more funds than anticipated are collected, or projected funds exceed the amount necessary for satisfying the municipal affordable housing obligation.

WHEREAS, Cranford Township has prepared a Spending Plan consistent with COAH's longstanding rules and policies; and

WHEREAS, because COAH is no longer a functioning administrative agency, it will not approve the Township's Spending Plan; and

WHEREAS, the Township of Cranford shall therefore seek review and approval of its adopted Spending Plan by the court.

NOW THEREFORE BE IT RESOLVED that the Governing Body of the Township of Cranford, County of Union hereby adopts the Spending Plan attached hereto;

BE IT FURTHER RESOLVED THAT the Township of Cranford hereby requests that the court review and approve its adopted Spending Plan.

SOIL REMEDIATION FOR THE SALE AND REDEVELOPMENT OF PROPERTY AT BLOCK 291, LOT 15.01 AND BLOCK 292, LOT 2, CRANFORD, UNION COUNTY, NEW JERSEY AND EXECUTION OF DEED NOTICE AND SOIL REMEDIAL ACTION PERMIT

WHEREAS, on February 7, 2017, the Township of Cranford acquired property located at 215 and 235 Birchwood Avenue, Block 291, Lot 15.01 and Block 292, Lot 2, in Cranford, Union County, New Jersey (hereinafter the "Property"); and

WHEREAS, by Resolution dated April 26, 2017 (No. 2017-188A), the Township Committee of the Township of Cranford designated the Property a Non-Condemnation Area in Need of Redevelopment; and

WHEREAS, as part of evaluation of the Property for sale and redevelopment, the Township's environmental expert, Excel Environmental Resources, Inc. (Excel), has identified soil contamination at concentrations exceeding the applicable standards of the New Jersey Department of Environmental Protection at the Property (NJDEP); and

WHEREAS, Excel provided the Township Committee of the Township of Cranford with a draft Deed Notice to serve as an Institutional Control to address soil contamination at the Property and a Soil Remedial Action Permit from NJDEP will be required as part of the Deed Notice before Excel may issue a Response Action Outcome; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Cranford, New Jersey, as follows:

- 1. The Township of Cranford is committed to the sale and redevelopment of the Property; and
- 2. The Township of Cranford adopts Excel's recommendation that the soil contamination be addressed through a combination of engineering and institutional controls; and
- 3. The selected engineering control will include use of the existing perimeter fence; and
- 4. The institutional control will be a Deed Notice documenting the soil contamination and the engineering control, along with the NJDEP-required Soil Remedial Action Permit; and
- **5.** Mayor Thomas Hannen is authorized to execute documents on behalf of the Township of Cranford related to addressing the soil contamination, including the Deed Notice and the associated Soil Remedial Action Permit application.

WHEREAS, as part of evaluation of the Property for sale and redevelopment, the Township's environmental expert, Excel Environmental Resources, Inc. (Excel), has identified soil contamination at concentrations exceeding the applicable standards of the New Jersey Department of Environmental Protection at the Property (NJDEP); and

WHEREAS, Excel provided the Township Committee of the Township of Cranford with a proposal recommending a remediation of the impacted soil with cost estimate; and

WHEREAS, Excel also installed a groundwater monitoring well and took samples for laboratory analysis, which data confirmed that no contamination of the groundwater at the Property exists;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Cranford, New Jersey, as follows:

- 1. The Township of Cranford is committed to the sale and redevelopment of the Property; and
- 2. The Township of Cranford adopts Excel's recommendation that the soil contamination be addressed through a combination of engineering and institutional controls; and
- 3. The selected engineering control will include use of the existing perimeter fence; and
- 4. The institutional control will be a Deed Notice documenting the soil contamination and the engineering control, along with the NJDEP-required Soil Remedial Action Permit; and
- 5. Excel is authorized to perform the necessary work on the existing perimeter fence as the engineering control, to arrange for the proper abandonment of the monitoring well, prepare the Deed Notice and Soil Remedial Action Permit and then issue a site-wide Restricted Use Response Action Outcome for soil and a site-wide Unrestricted Use Response Action Outcome for groundwater; and
- 6. Excel's proposal and cost estimate to perform this work is \$14,210 and is attached hereto as Exhibit "A"; and

7. The Township Committee of the Township of Cranford authorizes the execution and recording of the Deed Notice and execution and filing of the Soil Remedial Action Permit application and other NJDEP forms that may be necessary and appropriate.

BIRCHWOOD AVENUE (BLOCK 291, LOT 15.01 AND BLOCK 292, LOT 2) IN THE TOWNSHIP OF CRANFORD, UNION COUNTY

WHEREAS, by Resolution No. 2017-393, dated December 14, 2016, and pursuant to the Local Redevelopment and Housing Law, N.J.SA. 40A: 12A-1 *et seq*. (the "Redevelopment Law"), the Township Committee of the Township of Cranford ("Township Committee") directed the Planning Board of the Township of Cranford ("Planning Board") to conduct a preliminary investigation and public hearing to determine whether all or part of the area known and designated on the Tax Map of the Township of Cranford as Block 291, Lot 15.01, and Block 292, Lot 2 (collectively the "Property") is an Area in Need of Redevelopment in accordance with N.J.S.A. 40A:12A-6; and

WHEREAS, the Planning Board, following an initial review of the proposed area for redevelopment, directed that a map be prepared depicting the boundaries of the Property, pursuant to N.J.S.A. 40A:12A-6(b)(l); and

WHEREAS, the firm of Maser Consulting submitted a report dated February 6, 2017 to the Planning Board entitled "Redevelopment/Rehabilitation Study Area Determination of Need, Birchwood Avenue Study Area" ("Preliminary Investigation"); and

WHEREAS, as required by N.J.S.A. 40A:12A-6, the Planning Board held a public hearing on April 20, 2017, to determine whether all of part of the Property is an area in need of redevelopment in accordance with the Redevelopment Law and determined that conditions as set forth in N.J.S.A. 40A:12A-5 are found to be present at the Property; and

WHEREAS, following the public hearing of April 20, 2017, the Planning Board issued a Resolution dated April 20, 2017 recommending that the Township Committee adopt a resolution designating the Property a Non-Condemnation Area in Need of Redevelopment; and

WHEREAS, at its Official Meeting on April 25, 2017, the Township Committee evaluated the Preliminary Investigation of the Property and the testimony presented by Kristin J. Russell, the Planner from Maser Consulting, who prepared the Preliminary Investigation, in accordance with the requirements of N.J.S.A. 40A:12A-6; and

WHEREAS, by Resolution No. 2017-188A, dated April 26, 2017 ("Redevelopment Resolution"), the Township Committee designated the Property as a Non-Condemnation Area in Need of Redevelopment, as provided in N.J.S.A.40A:12A-5; and

WHEREAS, the Redevelopment Resolution was transmitted to the Commissioner of the New Jersey Department of Community Affairs ("DCA") via overnight delivery on April 26, 2017, in accordance with N.J.S.A. 40A: 12A-6; and

WHEREAS, the DCA had 30 days to respond to the Redevelopment Resolution and did not respond to the Township Committee, the Resolution is deemed approved as of May 26, 2017, in accordance with N.J.S.A. 40A:12A-6(b)(5)(c); and

WHEREAS, by Resolution No. 2017-182 dated April 18, 2017, the Township authorized the issuance of a Request for Proposal ("RFP") to elicit proposals for purchase and redevelopment of the Property; and

WHEREAS, a redevelopment project located in an Area in Need of Redevelopment must be undertaken in accordance with a Redevelopment Plan, in accordance with N.J.S.A. 40A:12A-7.

NOW, THEREFORE, BE IT RESOLVED, on this 13th day of June 2017:

- 1. The Township Committee directs the Planning Board to adopt a resolution and authorize preparation of a Redevelopment Plan for the Township Committee to review in furtherance of the sale and redevelopment of the Property, in accordance with N.J.S.A. 40A:12A-7(f).
