Commissioner Giblin explained that the bond includes \$960,000 for a matching grant application to expand the children's wing of the Cranford Public Library. Funding to upgrade various playgrounds was also included along with a new pumper for the Fire Department and new equipment for TV35.

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF CRANFORD, IN THE COUNTY OF UNION, NEW JERSEY, DESIGNATING A \$9,500,000 BOND ANTICIPATION NOTE, DATED MAY 18, 2018, PAYABLE MAY 17, 2019, AS A "QUALIFIED TAX-EXEMPT OBLIGATION" PURSUANT TO SECTION 265(b)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED WHEREAS, the Township of Cranford, in the County of Union, New Jersey (the "Township") intends to issue a \$9,500,000 Bond Anticipation Note, dated May 18, 2018, payable May 17, 2019 (the "Note"); and

WHEREAS, the Township desires to designate the Note as a "qualified tax-exempt obligation" pursuant to Section 265(b)(3) of the Internal Revenue Code of 1986, as amended (the "Code");

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Cranford, in the County of Union, New Jersey, as follows:

<u>SECTION 1</u>. The Note is hereby designated as a "qualified tax-exempt obligation" for the purpose of Section 265(b)(3) of the Code.

SECTION 2. It is hereby determined and stated that (1) said Note is not a "private activity bond" as defined in the Code and (2) the Township and its subordinate entities, if any, do not reasonably anticipate issuing in excess of \$10 million of new money tax-exempt obligations (other than private activity bonds) during the calendar year 2018.

<u>SECTION 3</u>. It is further determined and stated that the Township has, as of the date hereof, issued the following tax-exempt obligations (other than the Note) during the calendar year 2018, viz:

Amount Dated - Due \$9,700,000 Bonds 1/15/18 - 1/15/19-28

<u>SECTION 4</u>. The Township will, to the best of its ability, attempt to comply with respect to the limitations on issuance of tax-exempt obligations pursuant to Section 265(b)(3) of the Code; however, said Township does not covenant to do so, and hereby expressly states that a covenant is not made hereby.

<u>SECTION 5</u>. The issuing officers of the Township be and they hereby are authorized to deliver a certified copy of this resolution to the original purchaser of the Note and to further provide such original purchaser with a certificate of obligations issued during the calendar year 2018 dated as of the date of delivery of the Note.

<u>SECTION 6</u>. This resolution shall take effect immediately upon its adoption.

WHEREAS, there were 625 motor vehicle fatalities in New Jersey in 2017; and

WHEREAS, a large percentage of the motor vehicle occupants killed in traffic crashes were not wearing a seat belt; and

WHEREAS, use of a seat belt remains the most effective way to avoid death or serious injury in a motor vehicle crash; and

WHEREAS, the National Highway Traffic Safety Administration estimates that 135,000 lives were saved by safety belt usage nationally between 1975-2000; and

WHEREAS, the State of New Jersey will participate in the nationwide *Click It or Ticket* seat belt mobilization from May 21 – June 3, 2018 in an effort to raise awareness and increase seat belt usage through a combination of high visibility enforcement and public education; and

WHEREAS, a further increase in seat belt usage in New Jersey will save lives on our roadways;

PUBLIC COMMENTS

Mayor Hannen opened the public comments portion of the meeting and asked if there were any questions or comments.

<u>John Pritchard, 42-44 West Holly Street</u>, mentioned that Memorial Day is approaching. Feels residents should always remember those who served our country and those who were lost during war. Sang a song in support of the military, and urged the Township Committee to request that legislators reactivate Muhlenberg Hospital and other hospitals in the area due to their proximity to Ground Zero.

<u>Dr. Frank Krause, 20 Pittsfield Street,</u> expressed concerns with the Downtown Business District and the potential negative impact it will have on the surrounding residential properties. Discussed current design standards that are related to over density in the Downton. Also discussed the standards of the Special Improvement District. Mentioned a discussion he had with Mayor Hannen regarding the source of restate taxes. Explained that real estate taxes are made up of three sources: commercial property owners, the Downtown business owners and the residential property owners and provided a breakdown of the percentages contributed by each source. Stated that the concerns of the residential property owners should be recognized. Also feels a survey is needed to determine how the constituents feel about the density and the changes that are happening in the downtown and to see if they are being protected by the Planning and Zoning Boards.

Mayor Hannen feels Dr. Krause's comments are something that should be taken into consideration. Commissioner Maisonneuve will follow up with the DMC.

Dr. Krause feels the Zoning and Planning Board members along with the members of the DMC should have information regarding all the standards.

<u>James Carvalho</u>, <u>9 Orange Avenue</u>, discussed the repaving of streets. Questioned who is responsible for conducting road resurfacing and traffic volume assessments for the paving program.

Mayor Hannen stated that the Traffic Bureau is responsible for the traffic volume study and the Township Engineer along with the Department of Public Works handles the road resurfacing.

Mr. Carvalho asked which process was used to conduct the assessment during Mayor Hannen's tenure on the Township Committee.

Mayor Hannen does not recall the method used.

Mr. Carvalho questioned where the results are stored for public review.

Mayor Hannen is not sure where the results are kept because the Engineering Department has just been constituted but going forward they will be stored with the Township Engineer.

Mr. Carvalho discussed the condition of Riverside Drive and the surrounding streets in his neighborhood. Expressed concern that certain streets are being neglected. Mentioned that he's contacted various department heads and the Township Committee regarding the paving program and to date has received no answer. Stated that the current Township Engineer confirmed that there is no assessment process and there are no documented assessment results. Discussed the approved minutes of the September 11, 2017 Workshop Meeting in which he feels the minutes were incorrect. Stated that he spoke to the Township Attorney regarding this matter and was assured the minutes would be amended to correct the discrepancy. Pointed out that as of today the minutes have not been amended. Corrected the recorded by stating that there is no assessment process in place and there are no documented assessment results and these facts were related to him by the Mayor and the Commissioner of Engineering at the September 11, 2017 Workshop Meeting but were not documented in the official minutes. Thanked the Township Committee for making him an avid reader of agendas, minutes, Financial Disclosure Statements and campaign finance reports.

Hearing no further comments, Mayor Hannen closed the public comment portion of the meeting.
