PUBLIC COMMENTS

Mayor Hannen opened the public comments portion of the meeting and asked if there were any questions or comments.

<u>John Pritchard</u>, 42-44 West Holly Street, supports the Police Department promotions and service awards given out tonight. Feels residents should always remember those who served our country and those who were lost during war. Sang a song in support of the military and urged the Township Committee to request that legislators reactivate Muhlenberg Hospital and other hospitals in the area due to their proximity to Ground Zero.

James Carvalho, 9 Orange Avenue, continued his discussion from the May 22, 2018 Official meeting regarding the street paving program and public records. Mentioned that Township professionals explained to him that streets are chosen for the paving program based on road surface conditions and traffic volume. It was confirmed that the Engineering Department and the Department of Public Works are responsible for conducting road surface assessments as part of the process for choosing the streets most eligible for inclusion in the paving program while the Police Department is responsible for conducting the traffic volume assessment. Discussed the OPRA he submitted for information from 2012 – 2017 which indicated 78 streets were chosen for the paving program with no road surfacing assessments or traffic volume assessments conducted during that time period. Mentioned that he asked for the definition and description of the selection process including the process used to assess road conditions and the process used to assess traffic volume. Was told documents regarding the assessment results for each of the streets chosen for the paving program during those six (6) years did not exist. Feels the absence of these documents means the assessments were never performed.

Mr. Carvalho also discussed a conflict of the Township Committee as to whether the Engineering Department should be in-house or outsourced. Provided a breakdown of work that was completed by an in-house Engineer and an outsourced contractor during the six-year period of 2012-2017. Feels both systems are insufficient for taxpayers. Mentioned that Deputy Mayor Dooley is the Commissioner/Liaison of the Engineering Department and the Department of Public Works and referred to comments she made at the June 12, 2018 meeting that the Township spent an average of \$160,000 per year for the inspection portion of the municipal paving program. Feels at that price there should be assessments to prove why the streets were chosen.

Mayor Hannen explained that the inspections were done post paving to assure the contractor fulfilled the contract.

Mr. Carvalho apologized and clarified what he meant by his statement.

Hearing no further comments, Mayor Hannen closed the public comment portion of the meeting.
