MAYORAL ANNOUNCEMENTS

Pancreatic Cancer Month

WHEREAS, in 2018, an estimated 55,400 people will be diagnosed with pancreatic cancer in the United States and 44,330 will die from the disease;

WHEREAS pancreatic cancer is one of the deadliest cancers, is currently the fourth leading cause of cancer death in the United States and is projected to become the second by 2020;

WHEREAS pancreatic cancer is the only major cancer with a five-year relative survival rate in the single digits at just six percent;

WHEREAS when symptoms of pancreatic cancer present themselves, it is generally late stage, and 73 percent of pancreatic cancer patients die within the first year of their diagnosis while 94 percent of pancreatic cancer patients die within the first five years;

WHEREAS approximately 1300 deaths will occur in New Jersey in 2018;

WHEREAS the *Recalcitrant Cancer Research Act* was signed into law in 2013, which calls on the National Cancer Institute to develop a scientific framework, or strategic plans, for pancreatic cancer and other deadly cancers, which will help provide the strategic direction and guidance needed to make true progress against these diseases; and

WHEREAS the Pancreatic Cancer Action Network is the national organization serving the pancreatic cancer community in Cranford and nationwide through a comprehensive approach that includes public policy, research funding, patient services, and public awareness and education related to developing effective treatments and a cure for pancreatic cancer;

WHEREAS the Pancreatic Cancer Action Network and its affiliates in New Jersey support those patients currently battling pancreatic cancer, as well as to those who have lost their lives to the disease, and are committed to nothing less than a cure;

WHEREAS the good health and well-being of the residents of Cranford are enhanced as a direct result of increased awareness about pancreatic cancer and research into early detection, causes, and effective treatments; NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Cranford designates the month of November 2018 as "Pancreatic Cancer Awareness Month" in the Township of Cranford.

Township Attorney Cooper addressed the public regarding various updates. On November 20th the Township filed a complaint in Superior Court asking the court to approve its plan to satisfy its Third Round Affordable Housing obligation. The complaint with attachments is available on the Township's website. Provided some key elements of the summary attached to the complaint: 1) the summary has a detailed description of the Township's past efforts to satisfy its obligation; and 2) the plan to satisfy the obligation is also included in Table 3 of the plan. Explained that the plan only requires and anticipates two more new projects that have not yet been submitted and approved and will be located in the Downtown core. Currently the plan anticipates only 57 total units inclusive of the affordable units for Cranford to satisfy its anticipated Third Round Affordable Housing obligation. Mentioned that there are existing overlay zones contemplated by the plan which have been in existence since the prior housing element. There will be some tweaks to the overlay zones. Discussed other credits in the plan and units that are available to help satisfy the criteria but are not eligible for credits and that is why they are not listed in the plan. The full plan will be finalized and will be noticed for public comments and a full hearing for the Planning Board at a future hearing in December.

PUBLIC COMMENTS

Mayor Hannen opened the public comments portion of the meeting and asked if there were any questions or comments.

<u>John E. Pritchard, 42-44 West Holly Street</u>, mentioned that the Christmas season is approaching. Feels residents should always remember those who served our country and those who were lost during war. Sang a song in support of the military, and urged the Township Committee to request that legislators reactivate Muhlenberg Hospital and other hospitals in the area due to their proximity to Ground Zero.

<u>Rita LaBrutto, 104 Arlington Road,</u> Thanked the Township Committee for their efforts with the Affordable Housing plan. Realizes that some things need to be flushed out. Questioned the number of motions filed.

Township Attorney Cooper explained that a motion was filed Wednesday to continue the Township's immunity that expires on December 31, 2018 while the court considers the relief being requested in the complaint.

Ms. LaBrutto questioned if the immunity is continued would he anticipate more than one Planning Board hearing and go beyond December 31, 2018 if the extension is granted until March.

Township Attorney Cooper stated that he cannot speak for the Planning Board. Said it is a Master Plan document that only requires one hearing and approval by the Township Committee. Explained that it will be noticed with a minimum of ten days' notice for at least one hearing which the Planning Board will handle from there.

Ms. LaBrutto stated that there are towns that have Affordable Housing Committees. Honestly feels it should have been a more collaborative effort throughout the year for more information forthcoming on this issue. Feels one hearing is not enough time to digest all that information. Mentioned November 30th and December 7th as hearing dates. Seeking which date is correct so she can attend.

Township Attorney Cooper explained that the November 30th hearing is on the Township's pending motion to resolve the change in the number of units in the Birchwood project and December 7th is the hearing for the motion on the Township's immunity.

Ms. LaBrutto discussed the number of units proposed for the North Avenue Redevelopment Plan. Confused how the units are included in the plan when the public has not heard about a design or a concept.

Township Attorney Cooper clarified that the plan states that the units will be built. Explained that the plan requires the Township to identify property that can be redeveloped and the regulations require calculations of how many units can be built on that property. Also stated that any proposed development for any of those sites will be subject to a development process that would require multiple public hearings.

Ms. LaBrutto questioned the pending credits and stated that she feels the public should be entitled to see a list of those. Also questioned if the Township runs out of rental bonus credits, could it change to for sale units. Feels the Township should diversify its mix of housing units. Concerned with the north and south overlay zones. Feels some areas make sense and others do not. Also discussed the redevelopment on 310 Centennial Avenue. Feels it would be nice if in the future the town accomplishes its affordable housing goal a lot better. Cautioned the Township Committee that this effects the school system. Also discussed the Lost and Found application and the Just for Pooches application which is in the same zone and was required to have six parking spaces. Stated that there is a parking requirement for retail services.

Deputy Mayor Dooley stated that the parking ordinance has been amended. Explained that the previous ordinance did not require parking because it was poorly drafted. Assured Ms. LaBrutto that the error has been corrected. Clarified that the application for 310 Walnut Avenue was not in the Township Committee's jurisdiction.

Ms. LaBrutto stated that the Zoning Board heard the application for 310 Walnut Avenue.

Deputy Mayor Dooley stated that the Zoning Board is an independent body. Clarified how various boards of the Township work.

Township Attorney Cooper addressed concerns Mr. Carvalho brought forth to the Township Committee at a prior meeting. Discussed litigation regarding the property known as Swan Cleaners. The case was settled last year between the property owners and the adjacent property owners. A settlement was reached by Principal which means many of the terms were agreed upon but the agreement needs to be written up. There were a number of sticking points which were finally resolved at a hearing on November 23, 2018. The settlement agreement will be on the December 18, 2018 Township Committee meeting for approval. The case has been settled as a compromise and does not acknowledge liability. Assured Mr. Carvalho that the lack of liability does not expose Cranford taxpayers to additional lawsuits. The settlement amount is for \$300,000 which has been appropriated from the Township's Operating Budget. Explained that since 2015 the Township's insurance has been paying 70% of all legal fees associated with this litigation as a result of a comprise reached in 2015.

<u>James Carvalho 9 Orange Avenue</u>, questioned if the Township is reimbursed for paying 70% of the legal fees. Referred to a recent resolution.

Township Attorney Cooper explained that the Township pays the attorney directly and elaborated. Explained that the resolution to amend the contract is only appropriating the money so it is reserved and not spending it. This is required by State law.

Deputy Mayor Dooley explained that the money needs to be set aside but does not have to be spent.

Township Attorney Cooper answered the question why the Township has not filed suit against the party that caused damage. The Township didn't need to because they were already a part of the lawsuit. The Township does have a judgment against the property owners of Swan Cleaners for all our attorney fees and costs. Also mentioned that the Township will be applying to court in the future for a judgement to indemnify to reimburse the Township for the full amount of the settlement. Anticipates to have judgements in hand by the end of January to allow the Township to recoup 100% of its expenses in the course of this litigation from all of the parties. Explained that when litigation is listed on the agendas it is for updating purposes only with no discussion.

Mr. Carvalho thanked Township Attorney Cooper for answering his questions. Spoke about how this litigation was not presented clearly on agendas. Discussed an adopted resolution for a signed settlement in the amount of \$300,000 for Swan Cleaners. Questioned why this was referred to as signed instead of a proposed settlement.

Township Attorney Cooper stated that it was an oversight.

Mr. Carvalho discussed comments he made at last night's Workshop meeting regarding 44 North Avenue.

Barbara Krause, 20 Pittsfield Street, looking for clarification regarding the adoption of Ordinance No. 2018-17.

Mayor Hannen explained that it allows the town to have more leeway in where the cellphone tower sites are chosen.

Ms. Krause looking for clarification as to the current situation.

Mayor Hannen explained that the Township currently has an ordinance on the books. This ordinance adds additional language to give the Township leeway.

Ms. Krause questioned how the process works.

Mayor Hanen explained that it depends on the type of tower. Is unaware if there is a current application before the Planning or Zoning Board. Stated that this type of application would not go before the Township Committee.

<u>James Carvalho 9 Orange Avenue (continued)</u>, read various titles of articles regarding prior litigation that were published in the paper. Mentioned that the Township has not published any articles regarding the current litigation with Swan Cleaners.

Mayor Hannen stated that the Township Committee cannot be held responsible for how the press reports on the Township Committee meetings. The Township does its best to publish the agendas and make them as public as possible.

Mr. Carvalho asked if the Township Committee could ensure the taxpayers that no one associated with the Township of Cranford has implicitly asked anybody from those publications to not publish information.

Mayor Hannen stated that not to his knowledge, no one from the Township Committee had asked the newspapers to not publish information.

Hearing no further comments, Mayor Hannen closed the public comment portion of the meeting.

- Thanked Cub Scout Pack 103 Den 15 for leading the flag salute;
- Discussed seminars she attended at the League of Municipalities Conference. Discussed two bills that have potential impact to towns including Cranford: 1) restricted liquor permits to any food establishment meeting certain space criteria. This allows BYOBs the ability to have table service for beer and wine on one level and full alcohol service on another level. 2) legalization of recreational marijuana. Discussed a proposal to assemble a local panel that brings together experts in law, public safety, planning and zoning, education, church and community originations and residents to look at this issue objectively and do the research of how this legislation will pertain to Cranford and present these findings to the public. Provided contact information for those interested in serving on this panel;
- Discussed events that took place and will be taking place to kick off the holiday season;
- Wished everyone a Happy Chanukah.

Commissioner Patrick Giblin

- Reminded residents to change their smoke and carbon monoxide detectors every ten years. Provided the Fire Departments contact phone number for anyone with questions;
- Announced that there will be additional commuter and shopper parking starting tomorrow morning with the opening of Lot #8 on South Avenue. Permit holders will be notified tomorrow morning. Thanked Detective D'Ambola, and the Traffic Department for their efforts in making this happen;

- Discussed the Northeast Quadrant Stormwater Management Plan Phase 2B. This project has started and the work has been completed on the Riverside Drive portion. This project has been delayed approximately two weeks due to the weather. Hopeful this project will be completed by the end of 2018;
- Discussed the desilting project. Looks like the town will be able to desilt in the first part of 2019. The dam gates will hopefully be repaired and replaced prior to the fish embargo;
