## Ordinance No. 2019-10:

The Township Clerk read by title only Ordinance No. 2019-10 entitled, "AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF CRANFORD, PART II GENERAL LEGISLATION (pertaining to disposable plastic bags and other single-use plastics)"

## COMMISSIONER COMMENTS:

Deputy Mayor Dooley explained that the ordinance provides for a transition to restrictions on certain single-use plastics. The transition period is one full year to allow businesses to prepare and educate themselves. The businesses will be supported through education and other resources by various Township Committee commissions.

Commissioner Hannen applauds the thought behind the introduction and appreciates the passion of Deputy Mayor Dooley. Discussed problems he has with the way the Ordinance was written. Agrees with the concept of the ordinance and feels the town should move in that direction but not with the way the ordinance is currently structured.

Deputy Mayor Dooley explained the straw exemption. Stated that either the recycling officer or a health department employee will be designated by the Mayor to enforce the rules. Also explained that the ordinance allows for a member of the public to request a plastic straw, lid and utensils but they will be transitioned out. Wishes Commissioner Hannen would have expressed his concerns prior to the ordinance's introduction. Believes Commissioner Hannen understands the issues regarding plastics and is hopeful that he will vote in favor of the restrictions. The \$1,000 fine already exists in the recycling ordinance and has never been implemented. Stated that the entire recycling ordinance will have to be redone. Discussed how recycling demands have changed and why Cranford no longer benefits from the program. Mentioned that sixteen other municipalities have adopted this ordinance and the state is moving forward with similar legislation. Discussed a survey the business owners took which showed they highly support the ordinance. Stated that Cranford is a river town and the plastics are

finding their way into the Rahway River. Made a motion to amend the ordinance allowing customers to request plastic lids for beverages.

Commissioner O'Connor stated that the ordinance is not perfect but you have to weigh the good and the bad and make a decision. Served on the Environmental Committee for a number of years and feels it is a good idea to reduce and reuse as effective ways to help the environment. Feels this ordinance is a good starting place. If it needs to be amended in the future then it can be revisited.

Commissioner Maisonneuve feels it is important that the Township Committee moves forward with this ordinance. Other communities and countries have done this to great effect.

**WHEREAS**, the Mayor and Township Committee of the Township of Cranford wish to acknowledge the value of the Cranford Heritage Corridor and support efforts to promote and exploit it for its cultural significance and as much needed outdoor space;

**NOW THEREFORE, BE IT RESOLVED**, that the Mayor and Township Committee pledge the Township's support and cooperation toward the enhancement of the Cranford Heritage Corridor by, among other means, seeking the assistance of various committees, boards and departments of the Township toward achieving this goal, particularly along the aforementioned Droescher Mill section of the Corridor and, in furtherance therewith, request that the Deputy Mayor determine if the formation of a committee be appropriate, and, if so, recommend the appointment of members and serve as the Township Committee's liaison to such committee.

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF CRANFORD, IN THE COUNTY OF UNION, NEW JERSEY, DESIGNATING \$9,700,000 OF NOTES CONSISTING OF \$8,412,863 GENERAL BOND ANTICIPATION NOTES AND \$1,287,137 SWIM POOL UTILITY BOND ANTICIPATION NOTES, BOTH ISSUES DATED JUNE 28, 2019 AND PAYABLE JUNE 26, 2020, AS "QUALIFIED TAX-EXEMPT OBLIGATIONS" PURSUANT TO SECTION 265(b)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED.

**WHEREAS**, the Township of Cranford, in the County of Union, New Jersey (the "Township") intends to issue \$9,700,000 of Notes consisting of \$8,412,863 General Bond Anticipation Notes and \$1,287,137 Swim Pool Utility Bond Anticipation Notes, both issues dated June 28, 2019, payable June 26, 2020 (the "Notes"); and

**WHEREAS**, the Township desires to designate the Notes as "qualified tax-exempt obligations" pursuant to Section 265(b)(3) of the Internal Revenue Code of 1986, as amended (the "Code");

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Cranford, in the County of Union, New Jersey, as follows:

<u>SECTION 1</u>. The Notes are hereby designated as "qualified tax-exempt obligations" for the purpose of Section 265(b)(3) of the Code.

<u>SECTION 2</u>. It is hereby determined and stated that (1) said Notes are not "private activity bonds" as defined in the Code and (2) the Township and its subordinate entities, if any, do not reasonably anticipate issuing in excess of \$10 million of new money tax-exempt obligations (other than private activity bonds) during the calendar year 2019.

<u>SECTION 3</u>. It is further determined and stated that the Township has, as of the date hereof, issued the following tax-exempt obligations (other than the Notes) during the calendar year 2019, viz:

<u>SECTION 4</u>. The Township will, to the best of its ability, attempt to comply with respect to the limitations on issuance of tax-exempt obligations pursuant to Section 265(b)(3) of the Code; however, said Township does not covenant to do so, and hereby expressly states that a covenant is not made hereby.

<u>SECTION 5</u>. The issuing officers of the Township be and they hereby are authorized to deliver a certified copy of this resolution to the original purchaser of the Notes and to further provide such original purchaser with a certificate of obligations issued during the calendar year 2019 dated as of the date of delivery of the Notes. SECTION 6. This resolution shall take effect immediately upon its adoption.

#### **PUBLIC COMMENTS**

Mayor Giblin opened the public comments portion of the meeting and asked if there were any questions or comments.

<u>David Pringle, 333 Walnut Avenue</u>, thanked Deputy Mayor Dooley for her leadership on introducing Ordinance No. 2019-10 regarding the disposal of plastic bags and other single-use plastics. Also supports the adoption of Resolution No. 2019-249 which supports the Cranford Heritage Corridor. Also asked for an update regarding the PSE&G High Voltage Power Lines project.

Mayor Giblin provided an update. Explained that PSE&G has begun its assessment and Engineering Feasibility Analysis of the Conrail tracks. Appreciates the citizens' efforts, patience and perseverance with this issue.

Mary O'Flynn, 347 Walnut Avenue, member of No High Voltage Cranford, thanked the Township Committee for their help on this effort. Questioned when the next update might be for the PSE&G project.

Mayor Giblin provided an update. Mentioned that July 8<sup>th</sup> PSE&G was able to access the Conrail track. PSE&G did not have enough time to cover the five-mile track in one day so they will have to revisit. Will keep the residents posted as to when PSE&G will revisit the track. Feels the residents have been doing a great job and appreciates their efforts.

Ms. O'Flynn thanked the Township Committee for all their help.

<u>Rita Mason, 16 Alan Okell Place</u>, questioned the amount of property tax that she pays annually. Discussed a tree that fell on her house. Questioned why the elderly residents of Cranford pay such high property taxes. Stated that Cranford was a beautiful place when she first moved here. Feels there should be a freeze on property taxes for the elderly so they can continue to live in Cranford. Discussed a water issue that she had that took four weeks to fix. Praised the Township's Insurance Representative, Kathy Willis. Feels the town should help the elderly.

<u>Gary White, 289 Old Tote Road, Mountainside,</u> discussed the annual fundraiser he started in 2002 for Fibrodysplasia Ossificans Progressiva (FOP) to raise money for the research lab at the University of Pennsylvania. Also discussed a letter him and his son sent to all 21 municipalities in Union County to consider adopting a proclamation. Cranford was the fourth town in Union County to support FOP. Is trying to get all municipalities in the State to adopt a resolution or proclamation. To date, only two municipalities have refused to support the cause. Asked that the Township of Cranford send a letter of support for FOP to the two unsupportive municipalities.

Mayor Giblin thanked Mr. White for his dedication to this illness. It is meaningful to know that the Township Committee's efforts have a long-lasting impact. Would be happy to write a letter on Cranford's behalf.

Mr. White spoke about his acceptance of the Jefferson Award a couple years ago.

Donna Bacich, 5 Denman Place, Green Team Member, spoke on behalf of the Green Team in support of Ordinance No. 2019-10 which bans single-use plastic. This issue is important to the community.

Zach McCue, 7 Oraton Drive, supports Ordinance No. 2019-10 which bans single-use plastic. Believes with the right attention, the Commissioners have committed to helping businesses adjust and helping the community adjust to the transition. Thanked the Township Committee for taking action. Commended the Department of Public Works for filling a pothole located on Oraton Drive.

Hearing no further comments, Mayor Giblin closed the public comment portion of the meeting.
