## **MAYOR COMMENTS**

#### **Mayor Kathleen Miller Prunty Remarks**

Welcome to the 2022 Reorganization Meeting. At this point, I suppose we shouldn't be surprised at the virtual format considering current events. I want to begin by welcoming Commissioner Gina Black as a colleague on the Township Committee. We've already begun working together and I look forward to a good year. Thank you, Senator Kean for joining us virtually to administer the oath to Commissioner Black.

Thank you, Rev. Alfred Brown, pastor of the First Baptist Church, for sharing thoughtful and important words that we should think about every day. I have the pleasure of working with Rev. Brown on the Equity & Inclusivity Initiative and so I am so pleased that he was able to join us today.

This annual meeting is possible because of those who work diligently behind the scenes. Our Township Clerk Patty Donohue, Deputy Clerk Ashley Kurbanoglu, Sue Welsh and Patty Kozloski worked many, many hours during the holiday season to prepare hundreds of letters and almost 100 Resolutions. Thank you for all for your dedication.

And, to those watching on TV 35 or online, we wish this special meeting was in person but I urge you to protect yourself, your families and friends until we can safely be together again.

We begin 2022 facing many of the same challenges as we did 12 months ago. This year, we continue dealing with the impacts of the Pandemic on our residents and businesses. We are grateful for the support shown for our local shops, restaurants and service businesses and it is important that we continue that effort in these still unpredictable times.

Advocating – no fighting for - a regional flood control project is a priority. Too many of our neighbors' lives were turned upside down and for many, they once again lost so much. We need a regional solution to flooding and we must visible and vocal in demanding it. Just a few days after Ida, I reached out to Mayor Prupis of Millburn and we discussed organizing the mayors from towns impacted by Rahway River flooding. Since then, we have met with NJ Commissioner of Environmental Protection and met with federal, state and county legislators. We are visible, vocal and demanding with no intention of stopping.

But waiting and hoping for the BIG project is no longer enough. Simultaneously, we need to work on a parallel track to identify what we can do locally to mitigate flooding throughout Cranford. The Township has already brought in experts to examine what has been done and what measures we should consider in Cranford. Also, the Flood Control Advisory Board will be restructured and refocused to work with the Township Committee and our professionals on this major issue.

Discussions about development and investment in the Downtown Business District will continue. I am proud of our business districts, downtown, Centennial Avenue, Raritan Road. They each have a character that makes Cranford desirable but we cannot take it for granted or think that a few ribbon cuttings means the job is done. We need to encourage investment and reinvestment that attracts businesses and people. This is important and deserves reasonable, respectful debate about ideas, possibilities as well as genuine concerns.

We are at our best and achieve the best results, when we ALL show a willingness to listen, cooperate and remember that we are all on TEAM CRANFORD even when we have a different point of view. Ideas and healthy debate can make Cranford more interesting. Collaboration can make us stronger.

Beyond the big, headline issues we know that providing day-to-day services that affect your quality of life is important. That's not always easy with rising costs but we will continue to explore ways to streamline processes using technology and shared services. Last year, we paved and repaired more roads than in past years, held neighborhood meetings to inform residents about the projects and that will continue in 2022.

After two years of closure because of COVID-19, declining membership and financial constraints, we were able to announce recently that Centennial Outdoor Pool will reopen this summer. The Swim Pool Utility Advisory Board working with the Township Committee, Administrator and Chief Finance Officer continue to explore options to keep the Cranford pools in excellent condition and financially sound for the future.

The past two years have been nothing short of a challenge because of the Pandemic and number of retirements but Township employees didn't miss a beat adjusting to new protocols and new coworkers. So, thank you Jamie, our department heads and every employee for your dedication to Cranford.

Finally, today we appointed resident volunteers to Boards and Committees and I am particularly proud that the long list is diverse in makeup. It includes lifelong residents who will serve alongside people who recently chose Cranford as their home; women, men, seniors and teenagers; people who will bring their special talent, experience and perspective to the discussions about how we make Cranford more desirable and provide the best, most efficient services.

No matter your background or how long you have lived here, Cranford is your community and we welcome your input. We may not always agree and even when we do, we may not be able to make the changes you seek. But you will have a voice and will be treated with respect.

To my Township Committee colleagues, we have much on our plate this year and I truly look forward to working together for Cranford.

To Cranford residents, thank you for placing your trust in us. I wish you a healthy and joyful New Year.

To my dear friends and family, THANK YOU. A million times, THANK YOU.

This Cash Management Plan (the "Plan") is prepared pursuant to the provisions of N.J.S.A. 40A:5-14 in order to set forth the basis for the deposits ("Deposits") and investment ("Permitted Investments") of certain public funds of the Township of Cranford, pending the use of such funds for the intended purposes. The Plan is intended to assure that all public funds identified herein are deposited in interest-bearing Deposits or otherwise invested in Permitted Investments hereinafter referred to. The intent of the Plan is to provide that the decisions made with regard to the Deposits and the Permitted Investments will be done to ensure the safety, the liquidity (regarding its availability for the intended purposes), and the maximum investment return within such limits. The Plan is intended to ensure that any Deposit or Permitted Investment matures within the time period that approximates the prospective need for the funds deposited or invested so that there is not a risk to the market value of such Deposits or Permitted Investments.

### II. IDENTIFICATION OF FUNDS AND ACCOUNTS TO BE COVERED BY THE PLAN

1. The Plan is intended to cover the deposit and/or investment of the following funds and accounts of the Township of Cranford.

1. Current Funds	6. General Capital Fund
2. Trust Assessment Fund	7. Swim Pool Operating Fund

## III. DESIGNATION OF OFFICIALS OF THE TOWNSHIP OF CRANFORD AUTHORIZED TO MAKE DEPOSITS AND INVESTMENTS UNDER THE PLAN

The Chief Financial Officer of the Township of Cranford [and the Treasurer] (the "Designated Official") is hereby authorized and directed to deposit and/or invest the funds referred to in the Plan.

## **IV. DESIGNATION OF DEPOSITORIES**

The following banks and financial institutions are hereby designated as official depositories for the Deposit of all public funds referred to in the Plan, including any Certificates of Deposit which are not otherwise invested in Permitted Investments as provided for in this Plan:

# All New Jersey Banks that provide a certificate of eligibility. Depositories for 2022 are Investors Bank and TD Bank.

A "Certificate of Eligibility" is the certification issued by the New Jersey Department of Banking, Division of Banking, that a public depository if eligible to act as a depository for public funds and qualifies as a participant in the New Jersey Governmental Unit Depository Protection Act (GUPA). The Township of Cranford shall designate said depositories by resolution of the governing body each year in accordance with N.J.S.A. 40A:5-15.1.

## V. AUTHORIZED INVESTMENTS

- A. Except as otherwise specifically provided for herein, the Designated Official is hereby authorized to invest the public funds covered by this Plan, to the extent not otherwise held in Deposits, in the following Permitted Investments:
  - (1) Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America;
  - (2) Government money market mutual funds;
  - (3) Any obligation that a federal agency or a federal instrumentality has issued in accordance with an act of Congress, which security has a maturity date not greater than 397 days from the date of the purchase, provided that such obligation bears a fixed rate of interest not dependent on any index or other external factor;
  - (4) Bonds or other obligations of the Local Unit or bonds or other obligations of school districts of which the Local Unit is a part or within which the school district is located;
  - (5) Bonds or other obligations, having a maturity date not more than 397 days from the date of purchase, approved by the Division of Investment of the Department of the Treasury for investment by Local Units;
  - (6) Local government investment pools;
  - (7) Deposits with the State of New Jersey Cash Management Fund established pursuant to section I of P.L. 1977, c. 281 (C.52:18A-90.4); or
  - (8) Agreements for the repurchase of fully collateralized securities if:
    - (a) the underlying securities are permitted investments pursuant to paragraphs (1) and
       (3) of this subsection a;
    - (b) the custody of collateral is transferred to a third party;
    - (c) the maturity of the agreement is not more than 30 days;
    - (d) the underlying securities are purchased through a public depository as defined in section I of P.L. 1970, c.236 (C.17:9-41); and
    - (e) a master repurchase agreement providing for the custody and security of collateral is executed.

For purposes of the above language, the terms "government money market mutual fund" and "local government investment pool" shall have the following definitions:

Government Money Market Mutual Fund. An investment company or investment trust:

- (a) which is registered with the Securities and Exchange Commission under the "Investment Company. Act of 1940," 15 U.S.C. sec. 80a-1 et seq., and operated in accordance with 17 C.F.R. sec. 270.2a-7.
- (b) the portfolio of which is limited to U.S. Government securities that meet the definition of any eligible security pursuant to 17 C.F.R. sec. 270.2a-7 and repurchase agreements that are collateralized by such U.S. Government securities; and
- (c) which has:
  - (i) attained the highest ranking or the highest letter and numerical rating of a nationally recognized statistical rating organization; or
  - (ii) retained an investment advisor registered or exempt from registration with the Securities and Exchange Commission pursuant to the "Investment Advisors Act of 1940," 15 U.S.C. sec. 80b-1 et seq., with experience investing in U.S. Government securities for at least the most recent past 60 months and with assets under management in excess of \$500 million.

Local Government Investment Pool. An investment pool:

- (a) which is managed in accordance with 17 C.F.R. sec. 270.2a-7;
- (b) which is rated in the highest category by a nationally recognized statistical rating organization;
- (c) which is limited to U.S. Government securities that meet the definition of an eligible security pursuant to 17 C.F.R. sec. 270.2a-7 and repurchase agreements that are collateralized by such U.S. Government securities;
- (d) which is in compliance with rules adopted pursuant to the "Administrative Procedure Act," P.L. 1968, C.410 (c.52:14B-l et seq.) by the Local Finance Board of the Division of Local Government Services in the Department of Community Affairs, which rules shall provide for disclosure and reporting requirements, and other provisions deemed necessary by the board to provide for the safety, liquidity and yield of the investments;
- (e) which does not permit investments in instruments that: are subject to high price volatility with changing market conditions; cannot reasonably be expected, at the time of interest rate adjustment, to have a market value that approximates their par value; or utilize an index that does not support a stable net asset value; and
- (f) which purchases and redeems investments directly from the issuer, government money market mutual fund, or the State of New Jersey Cash Management Fund, or through the use of a national or State bank located within this State, or through a broker-dealer which, at the time of purchase or redemption, has been registered continuously for a period of at least two years pursuant to section 9 of P.L. 1967 c.9 (C.49.3-56) and has at least \$25 million in capital stock (or equivalent capitalization if not a corporation), surplus reserves for contingencies and undivided profits, or through a securities dealer who makes primary markets in U.S. Government securities and reports daily to the Federal Reserve Bank of New York its position in and borrowing on such U.S. Government securities.

# VI. SAFEKEEPING CUSTODY PAYMENT AND ACKNOWLEDGMENT OF RECEIPT OF PLAN

To the extent that any Deposit or Permitted Investment involves a document or security which is not physically held by the Township of Cranford, then such instrument or security shall be covered by a custodial agreement--with an independent third party, which shall be a bank or financial institution in the State of New Jersey. Such institution shall provide for the designation of such investments in the name of the Township of Cranford to assure that there is no unauthorized use of the funds or the Permitted Investments or Deposits. Purchase of any Permitted Investments that involve securities shall be executed by a "delivery versus payment" method to ensure that such Permitted Investments are either received by the Township of Cranford or by a third party custodian prior to or upon the release of the Township's funds.

To assure that all parties with whom the Township of Cranford deals either by way of Deposits or Permitted Investments are aware of the authority and the limits set forth in this Plan, all such parties shall be supplied with a copy of this Plan in writing and all such parties shall acknowledge the receipt of that Plan in writing, a copy of which shall be on file with the Designated Official(s).

## **VII. REPORTING REQUIREMENTS**

The Designated Official(s) referred to in Section III hereof shall submit to the governing body of the Township of Cranford a monthly written report of any Deposits or Permitted Investments made pursuant to this Plan, which shall include, at a minimum, the following information:

- A. The name of any institution holding funds of the Township of Cranford as a Deposit or a Permitted Investment.
- B. The amount of securities or Deposits purchased or sold during the immediately preceding month.
- C. The class or type of securities purchased or Deposits made.

- D. The book value of such Deposits or Permitted Investments.
- E. The earned income on such Deposits or Permitted Investments. To the extent that such amounts are actually earned at maturity, this report shall provide an accrual of such earnings during the immediately preceding month.
- F. The fees incurred to undertake such Deposits or Permitted Investments.
- G. The market value of all Deposits or Permitted Investments as of the end of the immediately preceding month.
- H. All other information which may be deemed reasonable from time to time by the governing body of the Township of Cranford.

## VIII. TERM OF PLAN

Attached to this Plan is a resolution of the governing body of the Township of Cranford approving this Plan for such period of time. The Plan may be amended from time to time. To the extent that any amendment is adopted by the Township Committee of the Township of Cranford, the Designated Official is directed to supply copies of the amendments to all of the parties who otherwise have received the copy of the originally approved Plan, which amendment shall be acknowledged in writing in the same manner as the original Plan was so acknowledged.

#### Resolution No. 2022-49:

WHEREAS, pursuant to N.J.S.A. 54-67 taxes are due and payable on the first day of February, May, August, and November of each year, and become delinquent if not paid on or before said days; NOW, THEREFORE, BE IT RESOLVED that a grace period of ten (10) days is hereby established; within which any installment of taxes or assessments may be received after the due date therefore without an additional charge of interest. The interest on delinquent installment of Taxes or Assessments shall be charged at the rate of eight (8) per cent (%) per annum on the first \$1,500 and eighteen (18) per cent (%) per annum on any amount in excess of \$1,500 to be calculated from the date that Tax was payable until the date of actual payment. Calculations are to be made in accordance with Chapter 75 of the Laws of 1991; and,

**BE IT FURTHER RESOLVED** that a penalty of six (6) per cent (%) will be imposed to any taxpayer with a delinquency in excess of \$10,000 who fails to pay that delinquency prior to the end of the calendar year. A delinquency consists of any Tax, Assessment or Interest amount due.

Finally, thank you to the many residents that have joined our Cranford Community as volunteers on numerous boards and committees that help to make our town strong.

As we look forward to 2022, we have some challenging discussions ahead and we'll need to take decisive action that will affect the future of Cranford. I campaigned and won on a platform that includes responsible growth, support of public safety and engagement of our residents and business owners. I believe these to be common sense principles and I will continue to work with this in mind.

As I close, I'd like to share a quote *I came upon recently* from Helen Keller that embodies my thoughts on how we can be successful as a team: "Alone we can do so little, together we can do so much". No one of us here can or should do it alone. As a committee, we should be prepared to provide, as well as listen, to a diverse set of viewpoints. I encourage residents to participate by coming to public meetings and/or reaching out to any of us-the more voices we hear on any side of an issue, the better informed our decisions will be.

In the end, let us focus on what we can agree on, respectfully debate what we disagree on and work together to promote the best solutions for the residents and businesses of Cranford. Best wishes to everyone for a happy and healthy 2022.

#### Commissioner Brian Andrews Thank you, Mayor.

Thank you to Reverend Brown and special thanks to Patty Donahue and her team. A lot of us get a little period of rest between Christmas and New Years and this is probably when she is the absolute busiest and they grind it out but it is important work because it is how we get people involved in our community, how we get more public input to continue to improve and strengthen our town. Thank you, Jamie, I know you were in town over the holiday weekend so thank you for all you did to support this process.

I am pleased to support Kathleen Miller Prunty again for another term as mayor in our town. As many know she's been a leader in improving our community in many roles for a number of years and we will be very well served in 2022, I'm also happy to support my friend Jason Gareis for Deputy Mayor. I appreciated his support last year to serve in a similar role, and if I could give one piece of advice, the position is what you make of it, and I loved it. I know you are going to serve admirably and do the town a lot of good this year.

Welcome and congratulations to our new colleague Gina Black, as others have noted, we have a big agenda ahead and I think there is a lot of room for common ground on steps that make sense for our town so I look forward to governing with Gina and the other Commissioners this year.

We are starting 2022 with a bit of a feeling of going backwards (as) many of us have friends who are sick right now. Some of them are very sick, including in our Municipal Government Community/Family. It is particularly frustrating because most people in Cranford have done everything we were told, get vaccinated, social distance, mask up, and yet we just seem to be in this very frustrating loop. Cases right now are shockingly high and we need to respond to changing circumstances as we are here today and thank you to everyone who was able to pull this virtual meeting together so quickly.

I don't know how or when this disruption in our lives is going to end but I am sure that they will. And I know that we are fortunate to live in a community like Cranford that really comes together when times get tough and the number of neighbors and friends, I've heard doing grocery runs for others, picking things up and checking in is really inspiring.

We, as we look ahead to the year have a duty as the Township Committee to serve Cranford and do our best to make it even stronger. I would just like to touch on very briefly, four areas that I plan to prioritize and I think we all should. One, the issue of livability. For too long, we did not make the investments in our town's infrastructure that we should have. From roads to flooding, Storm Ida laid this bare. We must and we will do more on this front. I know Deputy Mayor Gareis has been a leader on this as well as the Mayor and I am looking forward to seeing more this year. We also have to focus on more quality-of-life issues from pedestrian safety and bike safety to the environment. I think there is a lot more that can be done and I am excited our agenda for 2022.

Two, our local economy. We must be responsible with the taxpayers' monies while doing what we can to build our economy by attracting new businesses not just to the Downtown, but to Centennial Village and to the Business Park as well as other areas of town and while critically we do everything we can to support our existing businesses as we did last year from parklets, doing what we can on inspections particularly post-flooding, to shutting down Eastman Avenue to provide a community gather-spacing and fighting the State to keep it open as long as we could.

Third, we need to continue to fight for our residents. There are many cases where large powerful interests

come in and try to muscle their way through and the Township Committee's role is to muscle back. You can look at the Cell Tower where we have been brought to Federal Court and we have hired a very experienced legal team and are making the investments necessary to fight -- to overdevelopment, where we need to make the right difficult choices so that we can fight against these developer law suits. The stakes are too high for political posturing on this issue. We need to put in the real work necessary to get it done and to keep Cranford on a good course.

Finally, number four, Community building. One of the most special parts of Cranford by far is how involved our citizens are. We have many pathways to get involved whether it is the many boards that were appointed earlier today, civic organizations, religious institutions, school and sports, etc. There's a lot to do to make people feel like they are a part of something bigger than themselves and that they have an opportunity to give back. Local government has an important role in supporting this. Just this past month, the Cranford Jaycees helped escort Santa around town delivering over 2,000 toys to Cranford children as well as giving to charities. They were escorted by the Police and the Fire Department. So, there are a lot of ways that our government can help to breathe additional life into our community. Looking ahead to this year, I think we are going to have to reschedule the River Carnival, which is a great way to bring us together to celebrate our 150<sup>th</sup> Anniversary. I know we are going to be laying the groundwork for a great next 150 years.

#### Deputy Mayor Jason Gareis

First and foremost, I would like to congratulate Mayor Miller Prunty on her second term as Chairperson of the Township Committee, I would also like to congratulate Commissioner Black on being sworn in as a member of the Township Committee. I look forward to working with all members of the Township Committee in 2022. I would like to thank the members of the Committee on electing me to serve as Vice Chair for the Committee for 2022. It is an honor to be selected to serve in this role for our residents. I am likewise honored to serve again as the Commissioner of Public Safety. It has been a pleasure to work with Chief Greco and the members of the Cranford Police Department as well as Chief Czeh and the members of the Cranford Fire Department over the last year. Both departments are comprised of dedicated professionals and volunteers who put the safety and well being of our residents above all else. We should all feel confident in the services provided by these departments.

I would like to thank County Commissioner B. J. Kowalski for her continued support. I know she was looking forward to attending today and administering the oaths to both Mayor Miller Prunty and me. She is "under the weather" and I hope she feels better soon. Id like to thank Patty Donahue and her staff in the Clerk's office. Their office always works tirelessly. Preparation of today's meeting has been nothing short of amazing, I think I got a taste for that yesterday when Patty called me and said she was in the building working all day yesterday to be prepared for today. So again, thank you for those efforts.

Finally, I would like to thank my family. The decision to run for elected office was always a family decision and I would not be able to serve without the support and encouragement of my wife Lauerin and my son, Sebastian. When Commissioner Andrews and I campaigned back in 2020, one of the last things we did was a short video. The opening line to that video is still often repeated in my house and that is "2020 has been a rough year". At the time I think we all believed that 2020 was a rough year but that life would be back to normal in 2021. Unfortunately, 2021 proved to be another tough year especially for many residents here in Cranford. In addition to continuing to battle back from the effects of the Pandemic, we were also faced with devastating effects of Storm Ida. Many residents continue to deal with those issues even up to today. Following Storm Ida, members of the Township Committee and I met with residents, engineers, elected officials from other towns that have been likewise devastated by Storm Ida as well as State officials. For many of our residents, this was not the first flood and for many, this was at least their fourth. The phrase I've heard time and time again is "it's not if, but when". We as a Township need to refocus our efforts and strategies on how to curtail flooding, and lessening the effects of flooding for all of our residents. Whether we are discussing flooding from the Rahway River or flash flooding that occurs in different parts of our town, we need to develop new plans to deal with each aspect of flooding as it confronts Cranford.

Even before the devastating effects of Storm Ida were felt here in town, Cranford was in the process of raising an additional five (5) homes through a federal grant. I am pleased to say that the homes are on track to be raised this Spring. I am even more pleased to say that working with State OEM officials following Storm Ida, Cranford was allowed the opportunity to apply for additional federal funding to raise additional homes. To date, I believe we have somewhere in the low thirties (30's) -- the number of homes that have expressed interest in this program and so I am hopeful that if the "when" does come again, we will have many homeowners that do not see levels of devastation that they did with the last few floods and especially the ones that I witnessed during Storm Ida. As Commissioner Andrews touched on, flooding is a large concern and I plan to devote a good amount of my efforts this year making sure that we

are more prepared in the future in making sure that Cranford becomes more resilient to flooding.

In closing, I would like to say "Happy New Year" to everyone. I hope 2022 finds everyone safe and healthy. Thank you, Mayor.
